SenSen delivers solid ARR growth and positive operating cash flow in Q3

Melbourne, Australia – Live Awareness AI solutions provider SenSen Networks Limited (“SenSen” or “the Company”) provides an update on its activities for the quarter ended 31 March 2026 (Q3 FY26) and a trading update for the full year.

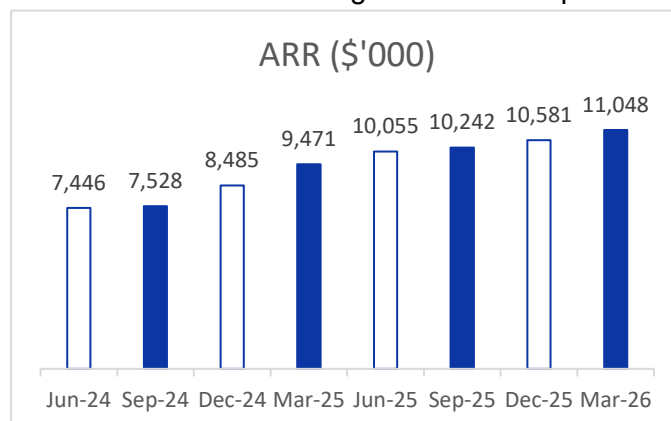
Highlights

- **Record YTD customer cash receipts of \$10.7 million**, up 7% on the prior corresponding period (PCP) of \$10.0 million
- **Solid Q3 quarterly cash receipts of \$5.2 million**, including \$2.05 million R&D tax offset refund
- **Positive Q3 operating cash flow of \$0.9 million**, up \$0.7 million or 417% on PCP
- **Closing cash balance of \$1.2 million**, with \$2.2 million in undrawn debt facilities
- **Annual Recurring Revenue (ARR) growth of 17% versus PCP to \$11.0 million**
- **World’s leading independent IT research and advisory firm, Gartner lists SenSen as one of the Vendors in its 2026 Emerging Tech: AI Vendor Race report**
- **Current economic uncertainty and supply chain delaying several projects and deferring upsell to existing customers.**

Business Operations Update

Annual Recurring Revenue Growth

SenSen achieved ARR¹ growth of 17% compared to PCP, with ARR increasing to \$11.0 million from \$9.5 million. This growth was attributable to new customers, expansion revenue from existing customers and a 41% increase in usage revenue compared to PCP.

First Smart City Deployment in India

SenSen has successfully deployed its AI Platform, SenDISA, with Pune Rural Police for the Pune Grand Challenge Tour 2026, a major international sporting event. This deployment is the first phase of a broader multi-stage public safety initiative, and a pipeline of opportunities is building in India.

Continued growth in Fuel Retail Solution

High fuel prices have led to increased instances of fuel theft. Retailers are turning to our fuel theft prevention and debt recovery solutions for help. We have locked in 32 additional sites with AMPOL and other independent fuel retailers.

R&D and Product Innovation, Gartner® Emerging Tech

SenSen continues to invest in next-generation AI capabilities to drive expansion revenue:

- *SenIQ*: A new data insights platform enabling customers to use AI to “chat with their data” and extract actionable intelligence from large historical datasets
- *SenSCAN MLPR*: A mobile licence plate recognition solution designed for regional councils and private operators, expanding our addressable market.

SenSen has also been listed as one of the Vendors in the 2026 Gartner® Emerging Tech: AI Vendor Race report (ID: G00843305). The research predicts that multimodal sensing and GenAI-powered computer vision is a major future trend with multimodal computer vision models surpassing human-level capabilities by 2030. SenSen’s SenDISA platform and AI capabilities are specifically designed for multi-camera, multi-sensor fusion and SenSen is well placed to meet the growing enterprise demand for multimodal AI-powered sensing solutions.

Economic Uncertainty Impacting FY26 Revenue

Despite positive momentum with new customer acquisition in H1 and year to date growth in ARR, the current economic uncertainty has resulted in the deferral of some opportunities in Q3. Supply chains linked to NVIDIA hardware have been disrupted for example. Most of the Company’s North American projects remain unaffected but several deployments in Singapore and Australia have experienced delays, impacting project completion and delaying revenue recognition in FY26.

The Company expects that revenue for H2 FY26 will be broadly in line with H2 FY25, and total revenue for FY26 slightly ahead of FY25, with forecast recurring revenue growth offset by a decline in upfront revenue due to project delays.

Full year EBITDA for FY26 is expected to be well up on FY25.

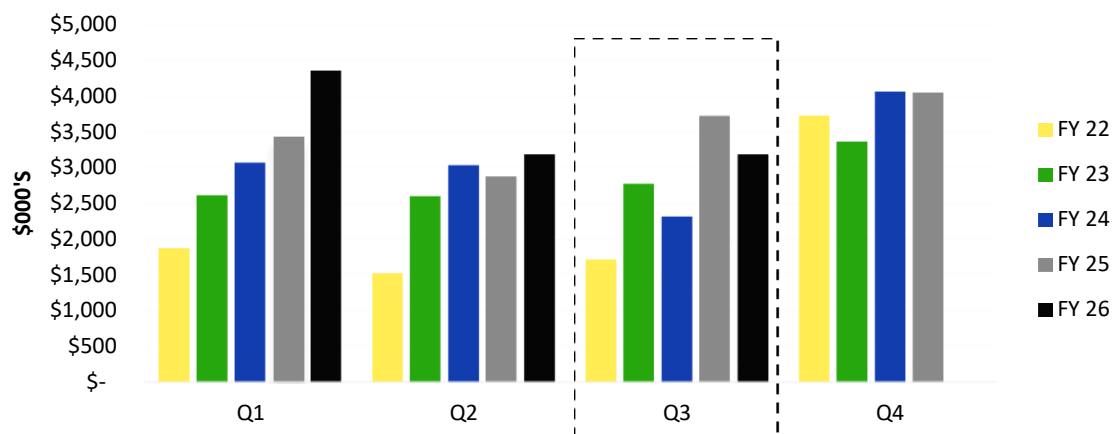

Finance Update

Quarterly Customer Cash Receipts



Customer cash receipts year to date 31 March 2026 of \$10.7 million were 7% higher than PCP. Q3 customer cash receipts were in line with Q2 but were 14% lower than PCP due to the timing of customer receipts from delayed project completion.

Cash and Debt Position

The Company's net debt position improved in Q3 following the receipt of the Company's FY25 R&D tax offset refund. The Company is continuing to utilise its Rocking Horse R&D funding and TP24 facilities for working capital funding when required.
