The Company is issuing \$1.075 million of convertible notes at a \$1.00 face value, maturing on 30 June 2027, with interest at 8.0% p.a. calculated daily and paid quarterly in arrears in cash. The notes are convertible into ordinary shares from 30 June 2026 until maturity at a 10% discount to the 15-day VWAP immediately before conversion, subject to a minimum conversion price of A\$0.072 per share. The Company may elect to redeem all or part of the outstanding amount of the convertible note at any time after 30 June 2026 and prior to maturity date.
