

## Weebit Nano Extends the Share Purchase Plan Closing Date

**28 April 2026** – Weebit Nano Ltd (**ASX: WBT, Weebit or Company**), advises that it has decided to extend the closing date of its current Share Purchase Plan (**SPP**) to 5.00pm AEST on Friday, 8 May 2026.

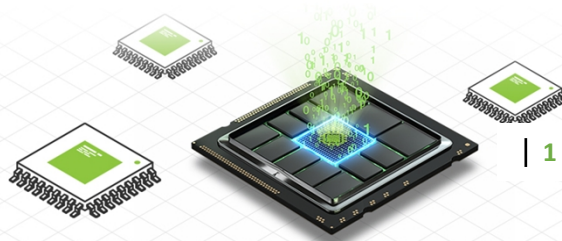
