	<p>At the Extraordinary General Meeting held on 30 September 2025, shareholders approved the refinance of the Davidson Kempner ("the Lender") Facility A into two convertible facilities (Convertible Facilities B1 and B2) ("facility") with the following terms and conditions outlined in the Notice of Meeting released to ASX on 29 August 2025 and briefly summarised below:</p> <ul style="list-style-type: none"> The Convertible facility noted above was for US\$12,562,500 and at the lenders discretion able to be converted into a maximum of 64,423,077 Shares. During the quarter the lender exercised their right to convert US\$4.25 million of the facility for 19,875,125 shares issued to a nominee of the Lender. The Company's outstanding debt to the Lender was US\$8.3 million at 31 March 2026. <p>Post the end of the March Quarter, the Lender converted an additional US\$4.1 million of debt to equity, resulting in the outstanding debt balance to the Lender being US\$4.2 million as at the date of this release.</p> <p>For more information on the conversions refer to the 12 February 2026 ASX announcement "Partial Conversion of Convertible Loan Facility" and to the 7 April 2026 ASX announcement "Partial Conversion of Convertible Loan Facility".</p>

8.8.1 Does the entity expect that it will continue to have the current level of net operating cash flows for the time being and, if not, why not?

Answer:

No. While the calculation presented in section 8.7 indicates that the Company currently holds cash reserves sufficient for 1.5 additional quarters, it anticipates the commencement of sales of uranium produced from Lance in the coming months. These sales are expected to progressively shift net operating cash outflows to net operating cash inflows in subsequent quarters, however, the Company notes that the Lance Project and newly commissioned wellfields continue to be in the ramp-up phase. Accordingly, the quantity and timing of Lance project uranium sales from production may vary from that currently anticipated by the Company. With a low level of corporate debt (currently US\$4.2 million), and low gearing ratio, the Company has the ability to take on additional debt to assist with working capital and wellfield development during the ramp-up phase. The Company is currently in discussions with potential providers of debt funding facilities.
