HighCom Limited – A\$9.81m Counter Small Uncrewed Aerial System (C-UAS) Order from Defence

Key highlights:

- A\$9.81 million incl GST (A\$8.99 ex GST), C-UAS contract awarded by the Australian Department of Defence for C-UAS products and support services.
- Product delivery is expected by the end of June 2026.
- HighCom's first major order in the C-UAS domain
- Reinforces HighCom Technology's position as a trusted value-added technology integrator to the Australian Defence Force (ADF)

HighCom Limited (ASX: HCL) (HighCom or the Company) is pleased to advise that its wholly owned subsidiary, **HighCom Technology**, has received a new A\$9.81 million incl GST (A\$8.99 million ex GST), Counter Small Uncrewed Aerial System (C-UAS) contract from the **Australian Department of Defence (Defence)**.

The contract represents HighCom Technology's first major order in the C-UAS domain. Under the agreement, HighCom Technology, in partnership with MyDefence AS will supply C-UAS products along with associated delivery and support services.

The contracted product delivery and receipt of the associated payment are expected to occur by June 2026.

The award further strengthens HighCom Technology's role in the C-UAS market, providing new capabilities, advanced defence technologies and lifecycle support to Defence customers.

Mr Bede Galvin, HighCom Technology's Acting President, commented:

"This significant partnership and the signing of a contract with Defence underscores our market position as a supplier of new capabilities, advanced technologies, systems integrations and support services to the Defence sector.

"HighCom Technology is focused on the integration of uncrewed aerial systems (UAS), counter-UAS (C-UAS) solutions and associated command and control systems, working in close collaboration with its sister division, HighCom Armor Systems. HighCom Armor Systems designs and manufactures specialist lightweight ballistic protection solutions, including its proprietary XTclave technology, supporting the Company's mission to 'protect first and front-line responders'.

"We are proud to support Defence with proven, operationally relevant solutions and look forward to delivering this program in FY27."

"This contract represents a strategic step in our long-term commitment to Australia and the Indo-Pacific region. MyDefence brings extensive operational experience in counter-UAS, with solutions developed and validated in real-world environments. The partnership with HighCom Technology enables the delivery of these capabilities in an Australian context, combining global expertise with strong local support.
