MARCH 2026 QUARTERLY ACTIVITIES REPORT

TZ Limited (ASX: TZL) (“TZ” or “the Company”) releases its Appendix 4C – Quarterly Cash Flow Report for the quarter ended 30 March 2026. In addition, provides the following operational and strategic update for FY26.

Key Highlights

Financial Summary

Key aspects of the Company’s cash flow performance for the March 2026 quarter are as follows:

- Net cash used in operating activities was \$830,000.
- Cash receipts from customers totalled \$2.679 million for the quarter.
- Operating cash outflows included:
 - product manufacturing and operating costs of \$1.282 million;
 - staff costs of \$1.403 million; and
 - administration and corporate costs of \$0.481 million.
- In accordance with item 6.1 of Appendix 4C, payments to related parties totalled \$88,000, comprising non-executive director fees.

The Company continues to actively manage its cost base in line with current operating conditions.

Business Update

FY2026

Revenue performance for FY26 has been below budget primarily reflecting timing impacts associated with customer deliveries and softer performance in the US. Importantly, this does not reflect underlying demand across the Company’s core data centre security segment, where customer engagement and order activity remain strong.

The Company expects the June quarter to be the strongest for the financial year, supported by the completion of previously delayed shipments and continued conversion of existing orders.

Data Centre Security

The Company continues to see strong momentum across the data centre sector, driven by both new builds and, more materially, the refurbishment and modernisation of existing facilities to meet evolving security, compliance and audit requirements.

Recent purchase orders, including those associated with deployments for Microsoft via channel partner Wesco Anixter, are indicative of this ongoing modernisation trend. During the period, the Company also secured an additional order supporting enhanced security requirements within an Australian government agency's data centre environment.

The Company is also experiencing increasing engagement from data centre rack manufacturers seeking to incorporate TZ's locking and software solutions as part of fully integrated cabinet offerings at the point of manufacture. This approach is intended to improve deployment efficiency and address labour constraints associated with large-scale data centre construction and refurbishment. Discussions with multiple parties are ongoing.

The forward-looking pipeline across the data centre segment remains strong, with continued enquiry levels and commercial engagement supporting confidence in future revenue conversion.

Keyvision

Keyvision continues to perform in line with expectations. Following the completion of platform enhancements in the prior period, the system is now operating with improved stability and functionality. The Company is seeing renewed sales momentum, with a growing pipeline supported by enterprise customers seeking enhanced tenant and property management capabilities.

The business is also being positioned for offshore expansion, with continued focus on building recurring revenue.

Smart Lockers / Smart Access

The Smart Lockers and Smart Access segment remains the primary contributor to recurring revenue. The Company continues to secure customer wins across both education and corporate sectors, with ongoing engagement from enterprise clients supporting a positive and expanding pipeline.

Revenue Outlook

The Company previously provided revenue guidance of approximately \$17 million for FY26. While the Company expects a strong finish to the year, a number of projects initially anticipated for delivery in Q4 FY26 have shifted into the early part of FY27.

This includes a key government-related project valued at approximately \$2.5 million, which is now expected to be confirmed and delivered in Q1 FY27. In addition, several smaller projects have been deferred into FY27 due to manufacturing lead times and delivery scheduling.

As a result of these timing impacts, the Board has revised its FY26 revenue guidance to a range of \$13 million to \$14 million. The underlying pipeline remains active, with these projects expected to contribute to revenue in the early part of FY27.

Board Update

TZ was very privileged to gain the services of Tim Richardson. Tim started with KPMG as an adviser, IT focus. Next was Head of Technology with NAB (300+ IT professionals); then ANZ, ING and Computershare. The roles have been CIO, CTO, CEO and CISO. There is no doubt that Tim's specialist expertise is totally aligned with TZ's business. Tim even lectures in Cyber Security at Swinburne University. The board of TZ is thrilled to be able to bring Tim's experience into the company.

Debt and Capital Management

TZ has a current debt level of \$5m.

The A\$1.5m Debenture with First Samuel Limited. First Samuel has confirmed the maturity date on this debenture, currently 30 June 2026, will be rolled to 30 June 2027.

The Company is also working constructively with its lender, Causeway Finance, with near-term repayment obligations extended to 31 May 2026 to allow for continued progress on funding and strategic initiatives.

As previously announced, the Company has undertaken capital raising initiatives during and subsequent to the quarter, including additional funding secured in April 2026. These initiatives have supported debt reduction, working capital requirements and continued investment in growth opportunities across the business.

The Company continues to progress a range of funding and strategic initiatives to support operations and position the business for future growth.

The interest rate of the facility is 12% p.a.</p> <p>\$3.75 million fully drawn loan from Causeway Finance, also at 12% pa interest. The Causeway debt at the start of the quarter was \$4.75m with a \$1m debt repayment made during the quarter. A subsequent debt repayment (per the debt schedule) of \$250,000 was made just after the quarter end. Firstly, the company's cashflow is very lumpy, however significant funds came in post the quarter end. Salter Bros. have been appointed to advise on the debt. Salter Bros. own Causeway Finance, the debt provider. Henslow Pty Ltd have been appointed to assist on any future, strategic capital raise. The company has a history of gaining support from both lenders and shareholders. That is expected to continue.
