Mustera Property Group Ltd (**Mustera**, the Company or the Group) is pleased to provide an update on its operational activities during the March 2026 quarter (the **Quarter**).

### HIGHLIGHTS

- The Group awarded the building contract for Verse on McCabe to Thomas Building, with construction commencing next quarter.
- During the period, a further \$20.3 million in sales were contracted for Verse on McCabe.
- The Group reached settlement on a residential and commercial unit during the Quarter in the Forbes Residences project in Applecross.

### 1. Verse on McCabe, 15 McCabe Street, North Fremantle



During the Quarter, the Group continued to advance its 42-apartment, eight-storey residential development, Verse on McCabe, in North Fremantle, with project documentation and procurement activities progressing toward the commencement of construction.

A significant milestone was achieved during the period with the appointment of Thomas Building Pty Ltd as builder for the project, following a comprehensive contract negotiation process. Thomas Building brings extensive experience in delivering high-quality residential developments

across Western Australia and has a strong reputation for craftsmanship, attention to detail and project delivery. Construction is currently targeted to commence in the second quarter of 2026, with an anticipated build timeframe of approximately 28 months.

The marketing campaign maintained positive momentum throughout the period, generating strong enquiry levels and consistent visitation to the on-site display suite. Six contracted sales were achieved within the reporting period, totalling approximately \$20.3 million, bringing the project's cumulative contracted sales to \$44.1 million.

## 2. Forbes Residences, 10 Forbes Road, Applecross

During the Quarter, the Group maintained active marketing efforts for the remaining commercial units at the Forbes Residences development.

The last remaining residential apartment settled during the Quarter for consideration of \$2.16 million, and one commercial unit settled for consideration of \$1.2 million.

Following these settlements, one commercial lot remains available for sale in the Forbes Residences development with a new marketing campaign commencing for this remaining lot in the following quarter.

## 3. Comments on Financials

In accordance with Listing Rule 4.7C.1, during the Quarter the Company incurred operating costs of approximately \$678,000 and marketing costs of approximately \$165,000 associated with ongoing development and advertising activities across its property portfolio.

Operational overheads for the Quarter totalled approximately \$343,000, comprising staff costs of \$189,000 and administrative and corporate costs of \$154,000. In addition, the Company incurred interest and finance costs of approximately \$2.41 million during the Quarter, which was primarily applied towards the retirement of the Harvis Loan Facility.
