

## **Appendix 4C Quarterly Cash Flow and Market Update**

Australian Dairy Nutritionals Limited (**AHF** or the **Group**) today lodged its Appendix 4C and provided a review of the Group's progress for the quarter ended 31 March 2026 (**Q3 FY26**).

### **Quarterly Activity Report (QAR)**

#### Financial Update

The Group is pleased to announce consolidated revenue of \$1.4m and of nutritional powders of \$880k for Q3 FY26. Nutritional powder sales represent a 20% increase on the pcp (Q3 FY25), with the result reflecting further pipeline and replenishment orders for increased distribution of the Future brand in China and contract pack sales to key customers. Nutritional powder sales in Q3 FY26 are affected by lower than forecasted distribution build in China due to a delay in our distribution partner (Mutree) securing additional sales headcount, and a longer than anticipated re-registration process in Vietnam. It is now expected that shipments to Vietnam with revised packaging and formulation will begin at the start of Q1 FY27.

Total revenue in Q3 FY26 of \$1.4m is a 13% decrease on pcp (Q3 FY25) which was a direct result of significantly lower milk and livestock sales v pcp, which was due to the exit from the lease of the North Brucknell farm. Total revenue year to date in FY26 is 5% ahead of pcp (year to date in FY25) and growth is expected to strongly accelerate in Q4 FY26 due to the expected rapid distribution build of Future brand in China supported by additional resources from Mutree.

Net cash outflows from operations were in line with expectations at \$613k for Q3 FY26. The Group ended Q3 FY26 with cash holdings of \$457k (Q2 FY26: \$809k).

The Board has and continues to assess capital raising opportunities and remains confident that it will be able to raise capital and/or access debt funding.

Directors, being related parties of the Group, were paid remuneration in the amount of \$80k in Q3 FY26, which is consistent with Q2 FY26.

#### Sales update

The business continues to focus on building consumer engagement of the Future brand in the o2o channel in China via the M2C global shopping app. Consumer retention rates are very pleasing as repeat consumer purchases are at record levels for the latest month and it is planned that further distribution and province penetration expansion will continue in Q4 FY26, as additional sales headcount resources are brought on, and a strong incentive plan is implemented. Distribution is still expected to reach 1,000 active stores by the end of FY26.
