KPT continues to engage with the NDIA regarding the recovery of outstanding receivables; however, the NDIA has not been providing regular payments. KPT remains actively engaged with the NDIA and has continued to raise concerns regarding delays in responding to queries and the timing of payment of amounts outstanding.

The Company continues to explore all viable pathways to facilitate a relisting.

Financial and Corporate

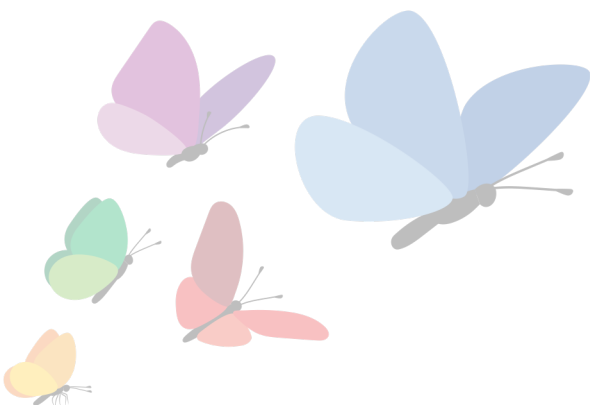
There were no payments to the Directors of the Company during the December 2025 quarter (see section 6 of the Appendix 4C).
