Metal Hawk wins \$175,000 EIS Co-Funding for Drilling at Leinster South

- Metal Hawk awarded \$175,000 in co-funding under the Western Australian Government's Exploration Incentive Scheme (EIS)
- Funding to support a three-hole diamond drilling program at the Tysons prospect within the 100%-owned Leinster South Project
- Drilling to test a key structural target along a major granite-greenstone contact

Metal Hawk Limited (ASX: MHK, "Metal Hawk" or the "Company") is pleased to announce that it has been awarded co-funding under the Western Australian Government's Exploration Incentive Scheme ("EIS") for diamond drilling at the Tysons prospect, part of the Company's 100%-owned Leinster South Project in the Agnew-Lawlers region of Western Australia.

The EIS funding will be applied to a planned three-hole diamond drilling program at the Tysons prospect area, near a major structural contact between greenstone stratigraphy and granitoid intrusives. Previous exploration by Metal Hawk has confirmed gold mineralisation along the broader Tysons structural corridor, including high-grade rock chips and gold intercepts from RC drilling.

Metal Hawk's Managing Director Will Belbin commented:

"Metal Hawk welcomes this co-funding support for diamond drilling at our Leinster South Project."

"The EIS is a valuable Western Australian Government initiative that supports technically strong exploration programs and helps advance greenfields discovery in underexplored areas."

"This diamond drilling program will provide important geological and structural information at the Tysons prospect and, if successful, could open up a significant new area for further gold exploration across the broader Leinster South project area."

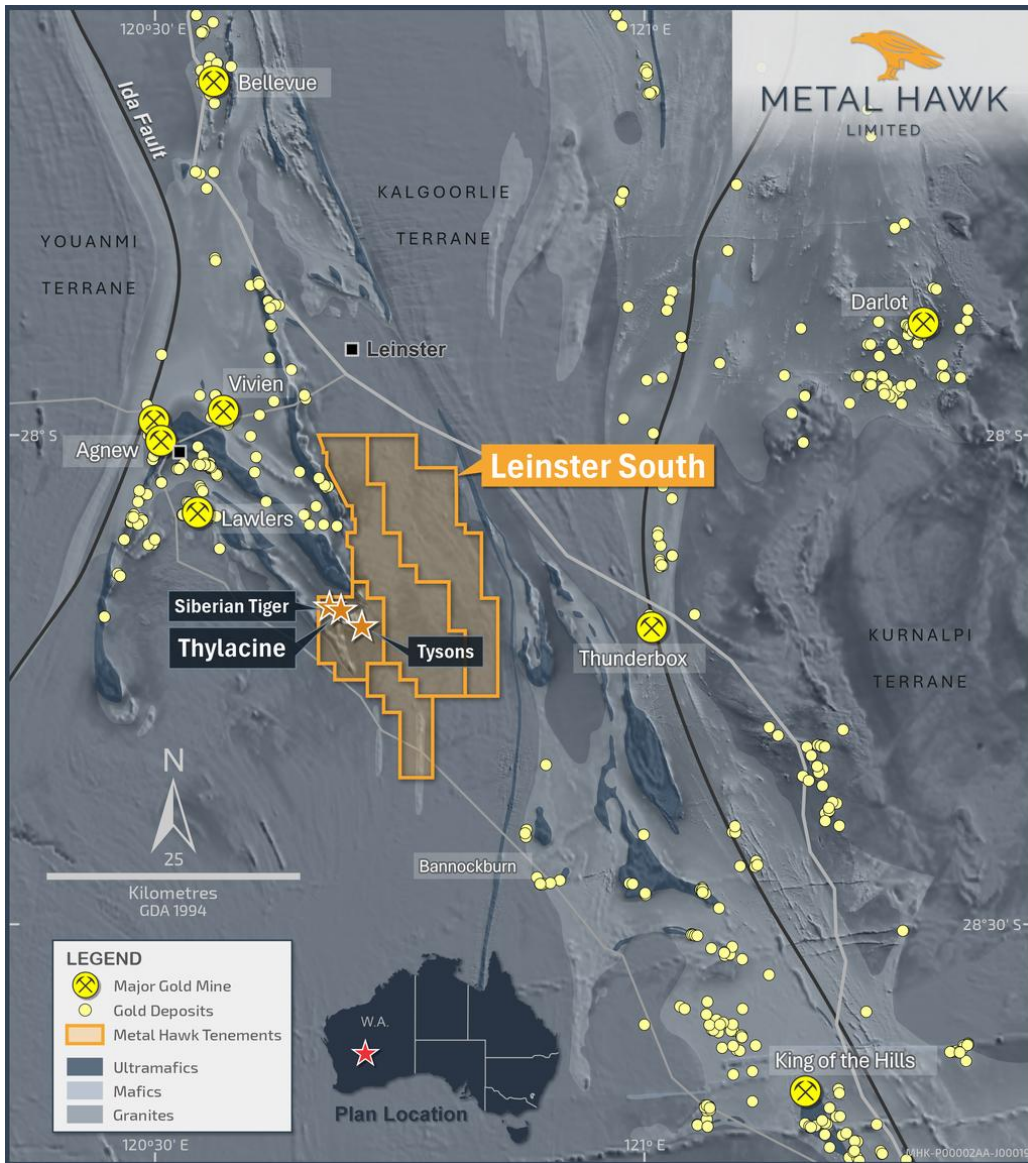


Figure 1. Leinster South Project
