Lynx will receive 6% of the total gross proceeds of the Placement and 1,000,000 options, subject to shareholder approval (exercise price \$0.30, expiry 3 years). Lynx will pay Curran and Spark Plus a selling fee of 5% on funds raised. Spark Plus is entitled to receive A\$50,000 in ordinary shares which was announced on 2 April 2026.
