## RG1 Portfolio Management Team Update, Expansion of Investment Team

- The Company announces the appointment of senior portfolio managers Kevin Bertoli and John Whelan as Portfolio Managers to RG1. Kevin and John bring extensive global equities investing experience to RG1, serving as co-Portfolio Managers to PM Capital's global equity funds, alongside Paul Moore, since 2006 and 2009 respectively.

David Jones, Chairman of RG1 said: "We are delighted to welcome Kevin and John to the RG1 portfolio management team, recognising their deep investment experience and long tenure managing global equity strategies alongside CIO Paul Moore. Under Paul's stewardship, Kevin and John have meaningfully contributed to the impressive track record of PM Capital's global long/short strategies and we look forward to their contributions to RG1 going forward.
