### Update on Sunshine Metals Share Purchase Plan

**Sunshine Metals Limited (ASX:SHN, “Sunshine”)** provides an update on its Share Purchase Plan (“SPP”) to raise up to \$3 million at A\$0.027 per share, as announced on 30 April 2026, which is open to eligible shareholders until 5.00pm (AWST) on 22 May 2026 (unless extended, withdrawn or closed early by the Company).
