Alcidion signs 7-year contract with University Hospitals Sussex for Miya Precision EPR platform

Highlights:

- Contract signed with the University Hospitals Sussex NHS Foundation Trust (**UHSussex**) to deploy Miya Precision for its new Electronic Patient Record (EPR) platform
- Total Contract Value (TCV) of approximately \$35M for an initial seven-year period with rights to extend to 10 years taking the potential TCV to \$49M
 - The partnership includes options to expand into further modules over time
- Implementation to begin immediately and extend for approximately 18 months, including a phase one go-live date target of June 2027
- Expect to recognise approximately \$8.5M of revenue in FY26 from the contract
- Alcidion's Miya Precision EPR was chosen following a competitive tender process and represents the third EPR platform contract for the business in the UK

Melbourne, Victoria | [Alcidion Group Limited](#) (ASX:ALC) ('**Alcidion**' or the '**Company**') today advises it has signed a new contract with UHSussex to supply its EPR platform.

Alcidion will deploy its flagship modular Miya Precision platform, including Miya Observations and Assessments (Patientrack), which is already live at the Trust. The Miya Precision EPR platform will provide clinicians real-time access to patient records whilst streamlining patient flow and improving clinical decision-making processes. The scope of modules includes virtual care which is the first time Alcidion will deploy the virtual care module to a UK customer. This will support the provision of care and remote patient monitoring for patients that may otherwise need to be treated in hospital.

The total contract value (TCV) is approximately \$35M over a total term of 7 years. The contract includes the right to extend the contract to 10 years resulting in a potential TCV of \$49M. The contract includes the option for additional modules over time, such as Miya Emergency and Patient Administration System (PAS), which would further add to the TCV.

In FY26, Alcidion is expected to recognise revenue of \$8.5M from the UHSussex contract, with the majority of that being generated via payment of an upfront license fee for use of the platform over the 7-year period. There will be an upfront payment, to a third party, of approximately \$2M for the medications management module. Implementation will begin immediately and is expected to take approximately 18 months given the breadth of the platform deployment, with a phase one go-live target date of June 2027.

UHSussex is located in the south of the UK and forms part of the Surrey and Sussex Integrated Care Board (ICB). They provide hospital and community health care for approximately one million people in Sussex. It is one of the largest acute trusts in the UK, with seven hospitals hosting more than 1.5 million outpatient appointments, A&E visits and surgery cases annually, employing nearly 20,000 staff.

Alcidion Group Managing Director, Kate Quirke, said: “This is an exciting step in our relationship with UHSussex and we look forward to continuing to work closely together to support their digital transformation strategy. UHSussex’s purpose for the EPR procurement is to implement a single, integrated digital platform that improves patient care, supports regional integration, drives operational efficiency, and delivers long-term social and research benefits. Building upon our existing Patienttrack module, which has been deployed at the Trust for many years, the modular nature of our Miya Precision platform will result in UHSussex being able to realise the benefits of an EPR platform deployment progressively, helping to maximise the ROI for clinicians and patients alike.

Chief Strategy Officer for University Hospitals Sussex, Roxanne Smith said: “This is an important milestone in our long-term digital strategy and a significant step towards introducing an Electronic Patient Record at UHSussex. An EPR will support our ambition to move from analogue to digital as part of our ‘Excellent Care Everywhere’ strategy, helping improve the experience of care for patients and making it easier for staff to access and share information across our hospitals and services

“Our ambition is to provide staff with modern, reliable and intuitive digital tools that bring patient information together in one place and support more consistent ways of working across the Trust. Having an EPR will form a key part of the digital foundation we are building for the future.

“This programme has already been shaped by over a thousand colleagues from across UHSussex, and that collaboration will continue as we move into the next phase of readiness and implementation work.”
