

## **Issue of Shares and Cleansing Notice – Section 708A(5)(e) Notice**

**Unith Ltd (ASX: UNT | FWB: CM3) (“Unith” or the “Company”)** advises that the Company has issued 10,000,000 fully paid ordinary shares (“Shares”) to GBA Capital Pty Ltd as Management Fee for the loan facility announced on 30<sup>th</sup> April 2026.
