#### Material Commercial Orders for Product into the UK Soft Fruits Market

Zoono Group Limited (**Company, Zoono**) (ASX: ZNO) advises that, together with the Company's partner in the food supply chain sector, OSY Group Limited (**OSY**), it has now received its first material commercial orders from Sharpak Aylesham Limited (**Sharpak**), the UK division of Groupe Guillin SA, under the exclusive UK soft fruits packaging contract entered into in May 2025.

The initial order is for product valued at approximately NZ\$600,000, with a further order of the same size scheduled for July 2026. Both orders are to be settled on accelerated payment terms.

Subsequent commercial orders are expected to follow from September 2026 as Sharpak ramps up production of coated packaging for its UK supermarket customers.

These orders follow the Company's announcements in November 2025 regarding exclusive packaging agreements with Mpact Operations (Pty) Limited in South Africa and Multisteps Pty Limited in Australia, and represent a further milestone in the commercial deployment of the Zoono–OSY antimicrobial coating technology across the Company's priority international markets.

In parallel, the Company confirms that Mpact Operations (Pty) Limited (**Mpact**) continues to order on a recurring basis under the South African agreement announced in November 2025. Following receipt of a third commercial order valued at approximately NZ\$122,000, total orders received from Mpact under the agreement now stand at approximately NZ\$366,000, consistent with the recurring commercial profile contemplated at the time of contract.

Sharpak is a leading supplier of soft fruit packaging in the United Kingdom, and the May 2025 contract granted Sharpak exclusivity in the use of the Company's products and technologies on rigid pots, tubs and trays used for soft fruits in the UK, subject to agreed minimum annual purchase volumes over the term of the agreement.

Following execution of the contract, Zoono, OSY and Sharpak undertook an extended programme of trials and validation work with leading UK supermarket customers. These trials concluded later than originally anticipated, which delayed the commencement of commercial-scale ordering under the contract.

In light of the timing of trial completion, and with the Company remaining confident in the ongoing adoption of its packaging technology by UK supermarkets, Zoono, OSY and Sharpak have agreed to defer the commencement of the minimum annual purchase commitments under the contract by twelve months. The aggregate minimum volumes contracted over the term of the agreement remain unchanged. Sharpak's UK exclusivity continues on the original terms.

As part of this arrangement, Sharpak has committed to the orders described above on accelerated payment terms, reflecting the parties' shared confidence in the commercial opportunity now opening in the UK market.

From September 2026 onwards, revenues from the UK market are anticipated to grow as Sharpak scales production of coated packaging and supply expands across its UK supermarket customer base. The Company will provide further updates as additional commercial milestones are achieved.
