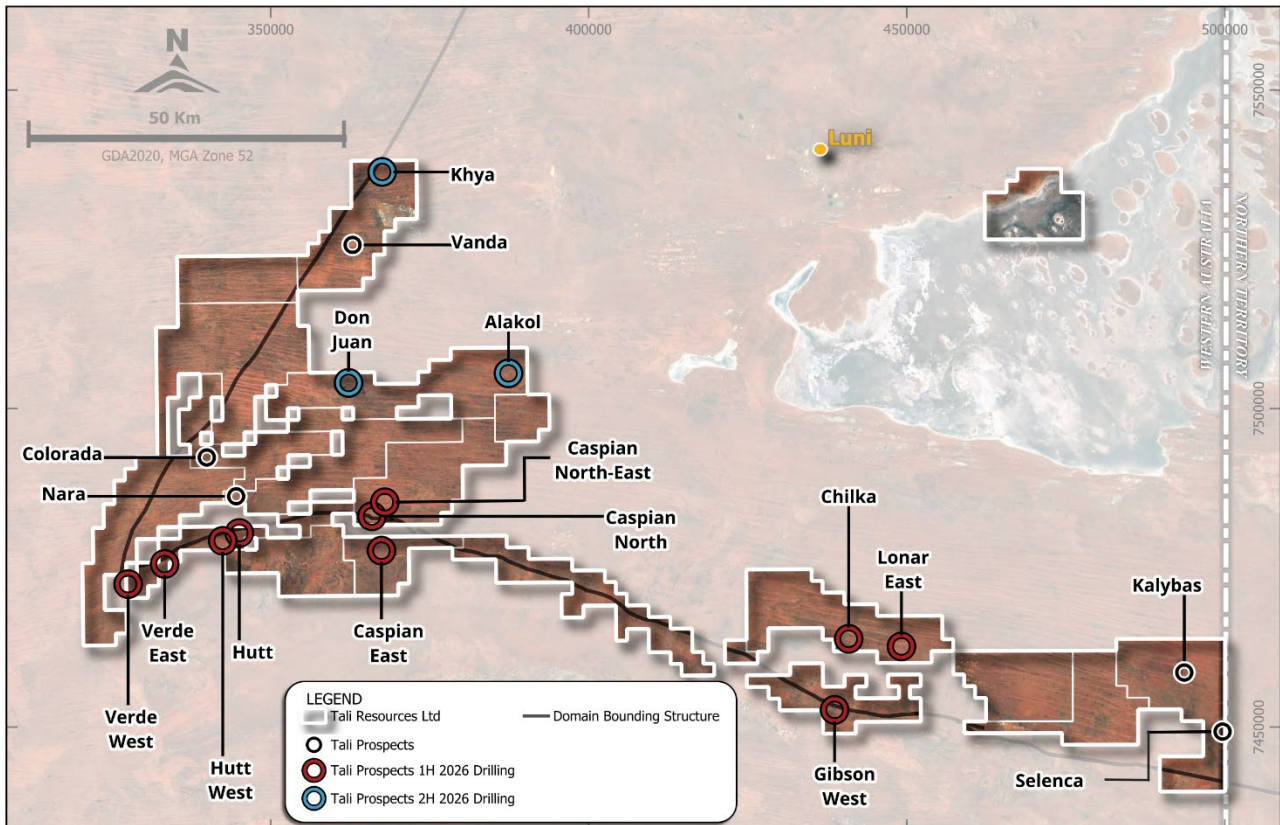

## West Arunta Drilling Program

The aircore drill program is designed to provide a first pass test of each of the following prospects: Caspian East, Caspian North, Caspian North-East, Chilka, Gibson West, Hutt, Hutt West, Lonar East, Verde East and Verde West. Drilling is expected to be completed in July with assay results to follow.
