273,929 rights were issued pursuant to deferred bonus grants, of which approximately 50% will vest on 8 March 2027 and the remaining 50% will vest on 8 March 2028, in each case subject to conditions relating to continuous employment. The rights were issued on 1 May 2026 and 28 May 2026 at a reference price of \$3.0337, being the 5-day VWAP of the Company's shares for the period commencing 2 March 2026.
