Bank account details, Tax File Number ("TFN") and/or Australian Business Number ("ABN") details can be updated through the Apex Fund Services ("Fund Registry") investor portal at <https://montaka.apexgroupportal.com/welcome>. Please ensure any updates are completed by no later than **Tuesday, 2 July 2026**.

If you invest through a broker, please note that any information you provide to your broker may not be forwarded to the Fund registry. Accordingly, any updates to your distribution reinvestment plan, distribution payment details or tax details can be provided directly to the Fund registry.

If your TFN or ABN is not provided by this date, tax may be withheld from income distributions paid to you at the top marginal tax rate. To update your tax details through the investor portal, please follow the steps below:

1. Go to <https://montaka.apexgroupportal.com/welcome>
2. Select **Investor Login**.
3. Go to **Settings**, then select **Tax Details**.
4. Enter or update your TFN details and save your changes.

The default is for distributions to be reinvested; however, investors can choose to have them paid out in cash. You can update your distribution election before this date. To add or update a bank account for your holding, please follow the steps below:

1. Go to <https://montaka.apexgroupportal.com/welcome>
2. Select **Investor Login**.
3. Go to **Settings**, then select **Distribution Method**.
4. Select **Direct Credit**.
5. Select **Add Bank Account** to enter or update your bank account details, then save your changes.

You may also elect to receive fund notices and reports electronically for faster delivery by updating your communication method in the Apex Investor Centre.

If you are not registered for the investor portal, please register at <https://montaka.apexgroupportal.com/welcome>. You will need your Securityholder Reference Number (SRN) or Holder Identification Number (HIN), available on your holding statement. SRNs begin with "I" and HINs begin with "X".
