Description

It is anticipated that the securities of Great Bear Exploration Ltd ('GBL') (previously, Hydrocarbon Dynamics Limited) will be reinstated to quotation at 09:59:00 (+15 seconds) AEST on Wednesday, 17 June 2026, following its re-compliance with Chapters 1 and 2 of the ASX Listing Rules.

GBL raised A\$6,500,000 pursuant to the offer under its prospectus dated 1 April 2026 ('Prospectus') by the issue of 325,000,000 shares at an issue price of A\$0.02 per share.
