

Cleansing Statement

On 19 June 2026, MetalsTech Limited (**ASX: MTC**) (**MetalsTech** or the **Company**) issued an “Appendix 2A” for the issue and quotation of shares which form part of the \$9.4M placement announced on 15 January 2026.

The total number of Shares issued was 9,000,000 fully paid ordinary shares. The Shares were issued at a price of 20.5 cents per share for total cash proceeds of \$1,845,000.
