Update on Secured Loan Facility

Citigold Corporation Limited ("Citigold" or "Company") (ASX: CTO) advises that it has received a notice of default in relation to the secured loan facility from DEP Nominees Pty Ltd in its capacity as trustee for the Carmen Trust (formerly The Rigby Superannuation Fund, Rebecca Agius, Rollercoaster297 Pty Ltd ATF Neller Superannuation Fund and P&C Rigby Superannuation Fund) ("Lender").

The Company is currently in discussions with the Lender regarding settlement of the facility for circa \$1.7 million and is also in discussions with funding parties to provide funds to settle the secured debt. The Company is actively working to resolve the matter as soon as practicable.

The Lender has exercised their rights to remove the current directors of the Company's wholly owned subsidiary; Charters Towers Gold Pty Ltd. Charters Towers Gold Pty Ltd does not hold any mining titles at Charters Towers.

The Company will continue to keep the market informed.
