



Cleansing Notice

Bellavista Resources Ltd (ASX: BVR) ("**Bellavista**" or the "**Company**") advises that 500,000 fully paid ordinary shares ("**Shares**") were issued today upon the exercise of 500,000 unquoted options exercisable at \$0.25 each on or before 17 January 2027. The Company received total proceeds of A\$125,000 (before costs), being the total price payable on exercise of the options.
