BMC UK Partial Sell Down

BMC Minerals Ltd. (ASX:BMC) (**BMC** or the **Company**) confirms that BMC (UK) No.1 Limited (**BMC UK**) has agreed to sell down 29,534,808 CHESS depositary interests (**CDIs**) over fully paid common shares in the Company (**Sell Down**). This Sell Down represents approximately 10.8% of the Company's issued capital.

The Sell Down was undertaken at a price of \$2.85 per CDI to a range of sophisticated, professional and institutional investors by way of an underwritten block trade.

Following the Sell Down, BMC UK will retain a 53.9% holding in the Company subject to 12, 18 and 24-month escrow periods post-ASX listing.

Commenting on the Sell Down, Managing Director and CEO, Michael McClelland said: *"BMC UK undertaking this sale of its unescrowed CDIs responds to strong investor demand and provides enhanced liquidity and free float, broadening the register and improving the likelihood of achieving major index inclusion over time."*

"We look forward to releasing the technical report refresh in the third quarter of calendar year 2026 as we continue to work through our 2026 drilling program".

Attached to this announcement are cleansing notices issued by BMC and BMC UK in relation to the Sell Down.

BMC Minerals Ltd. (ASX:BMC) (**BMC** or the **Company**) refers to its announcement today, in relation to the agreement to sell 29,534,808 CHESS depository interests (**CDIs**) over fully paid common shares in the Company held by BMC (UK) No.1 Limited (**BMC UK**).

BMC UK has advised the Company that the sale of 29,534,808 CDIs (**Sale Securities**) to certain sophisticated, professional and institutional investors will complete on 2 July 2026 by way of settlement of special crossings conducted in accordance with the ASX Settlement Operating Rules and ASX Operating Rules. Those Sale Securities represent 10.8% of the issued capital of the Company. Following completion of the sale, BMC UK retains 148,110,088 CDIs, representing 53.9% of the Company's issued capital.

The Company states that:

- (a) BMC UK, the controller of the Company for the purposes of the Corporations Act at the date of the sale of the Sale Securities, sold the Sale Securities without disclosure to investors under Part 6D.2 of the Corporations Act;
- (b) this notice is given under section 708A(5)(e) of the Corporations Act, as modified by ASIC Corporations (Sale Offers By Controllers) Instrument 2026/95 and ASIC Corporations (Offers of CHESS Depository Interests) Instrument 2025/180;
