archTIS Awarded \$3.2M Australian Department of Defence Contract

Award renews Kojensi licensing and adds significant application development and maintenance services

Key Highlights

- Award valued at A\$3.2M (incl. GST), anchored by A\$1.0M in annual recurring software licences plus A\$2.2M in application development and maintenance services.
- Australian Department of Defence (Defence) renews licensing of Kojensi Enterprise, deployed on-premises across Defence's sensitive information collaboration environment.
- Includes \$2.2M of annual application and development services alongside maintenance services.
- Cements archTIS as the incumbent provider for policy-enforced information security software inside Defence's classified ICT environment with strong potential for future licensing growth.

archTIS Limited (ASX:AR9, OTCQB:ARHLF) ("archTIS" or the "Company"), a global provider of data-centric software solutions for the secure collaboration of sensitive information, is pleased to announce it has secured a \$3.2M contract under its existing ICT Provider Arrangement (ICTPA) Deed of Standing Offer with Defence for the continued and expanded licensing of Kojensi Enterprise and the delivery of associated application development and maintenance services.

The award total is valued at \$3.2M, with \$1.0M in licenced annual recurring revenue (ARR) and \$2.2M in application, development, and maintenance services. The contract has a term of 12 months commencing 1 July 2026, and as with prior Defence awards, the contract may be terminated for convenience. Defence may extend the contract by up to two further periods of twelve months each, exercisable at its sole discretion. Daniel Lai, Managing Director and CEO, stated, "This win is a commitment from the Australian Department of Defence to invest in Kojensi and archTIS. Defence has not only renewed Kojensi Enterprise, but they are investing to expand Kojensi. This award builds on archTIS' long-standing relationship with Defence and an unbroken run of successive contract awards within the agency. The added capability enhancements demonstrate that Kojensi is evolving in lockstep with Defence's operational needs. This is exactly the kind of sticky, recurring revenue from a strategic government customer that powers our ARR growth strategy."

The Company continues to invest in Kojensi to stay ahead of the evolving information security requirements of Defence and allied government agencies, positioning the platform for further growth in user numbers and deployment sites.

The win further underscores Kojensi's differentiated value proposition: a government-certified platform purpose-built for the secure access, sharing and collaboration of sensitive and classified information in the highest-security ICT environments.
