

Notice Pursuant to Section 708A(5)(e) of the Corporations Act

Brazilian Critical Minerals Limited (**ASX: BCM**) ("**BCM**" or the "**Company**") gives notice pursuant to section 708A(5)(e) of the Corporations Act 2001 Cth ('the **Act**') that on 1 July 2026, it has issued 8,395,832 fully paid ordinary shares on the conversion of options.

In accordance with section 708A(5)(e) of the Act, the Company gives notice that:
