About Noronex Limited

Noronex is an ASX-listed copper explorer with advanced projects in the Kalahari Copper Belt, spanning Namibia and Botswana, and in Ontario, Canada. Collectively, these projects have seen over 180,000m of historical drilling. The Company has a Strategic Alliance Agreement (SAA) with South32, and two Earn-in Agreements providing South32 with the right to acquire 60% of each of Noronex's Humpback-Damara Project in Namibia and the Cgae Cgae Project in Botswana by funding a combined A\$4M in exploration per year for a maximum of five years. Noronex will be the manager of the exploration activities under the Earn-In Agreements and SAA and plans to use modern technology and exploration techniques to generate new targets at the projects and grow the current Resource base.

The Company also has exposure to a Uranium tenement in the centre of Namibia's hard rock uranium district. The Etango North (EPL 6776) is a joint venture with a local Namibian partner, where Noronex can earn up to an 80% interest on EPL 6776 with Noronex the manager and operator of the JV.

Dear Option Holder,

We are writing to you as a registered holder of NRXO listed options (**Options**) in Noronex Limited (ASX: NRX) (**Company**), to remind you that the options will expire at 5:00pm (AWST) on Friday, 7 August 2026.

There is no obligation on option holders to exercise their options. However, in accordance with Clause 5.2 of Appendix 6A of the Listing Rules, NRX provides options holders with the following information:

- The number of quoted options to which this notice applies is 72,930,180.
- On exercise, each quoted option entitles the holder to receive one fully paid ordinary share in the Company. If all of the quoted options were exercised, 72,930,180 fully paid ordinary shares in the Company would be issued.
- The exercise price for each quoted option is \$0.025 (**Exercise Price**).
- The due date for payment of the Exercise Price is 5:00pm AWST on 7 August 2026 (**Expiry Date**).
- If payment is not received prior to the Expiry Date, the quoted options will expire unexercised, and all rights will cease.
- Official quotation of the quoted options will cease on Monday, 3 August 2026, being four business days before the expiry date.
- The market price of the Company's shares on 2 July 2026, being the last trading day prior to the date of this notice, was \$0.009.
- The highest market price of the Company's quoted fully paid ordinary shares during the 3 months immediately before this notice was issued was \$0.012 on 17 June 2026. The lowest market price of the Company's quoted fully paid ordinary shares during the 3 months immediately before this notice was issued was \$0.008 on 9 June 2026 (among other dates).
- The exercise of the options is not underwritten.
- This notice is being sent to all eligible Option Holders in accordance with clause 5.2 of Appendix 6A of the Listing Rules.
