## **Brookside Commences Drilling Operations at Suttles Pad Sabres well spudded as first well in two-well Suttles pad development program**

**Tulsa, Oklahoma, USA – 7 July 2026 – Brookside Energy Limited (ASX: BRK) (OTC Pink: RDFEF) (Brookside or the Company)** advises that drilling operations have commenced on the Sabres 2-1-1S-3W SXH1 well, the first of two operated horizontal wells to be drilled from the Suttles pad in the SWISH Area of Interest (AOI) in the Anadarko Basin, Oklahoma.

Kenai Drilling Rig 18 has moved onto location, rigged up and is currently drilling ahead in the 17-1/2 inch surface-hole section of the Sabres well.

The Sabres well is targeting the Sycamore Formation at an approximate depth of 7,700-feet and is designed with an approximately 1.5-mile lateral section. Following Sabres, Kenai Drilling Rig 18 will skid a short distance across the Suttles pad to drill the Whalers 2-1-1S-3W WXH2 well, which will target the Woodford Formation from an adjacent surface location on the same pad.

Brookside holds an approximate 70% working interest in both wells.

Importantly, surface production facilities at the Suttles pad are now substantially ready to facilitate production from the Sabres and Whalers wells. This sequencing is designed to allow oil and gas production to be received, processed and turned to sales quickly once drilling and completion operations have concluded and flowback commences.

The Suttles pad is the next step in Brookside's repeatable, multi-well development model in the SWISH AOI.

**Commenting on this announcement, Brookside Managing Director & CEO David Prentice said:**

"Spudding Sabres is another step in the disciplined development of our SWISH inventory.

"The work done ahead of the drill bit matters. From land and title, to subsurface modelling, regulatory approvals, pad construction, facilities and takeaway preparations, this has been a full-cycle team effort to set the program up to move cleanly from drilling through completions, flowback and first sales.

"Our job now is to execute safely, keep cycle times tight and bring these wells online efficiently."

Brookside looks forward to providing further updates as operations progress.
