



Notice under Section 708A(5)(e) of the Corporations Act

Turaco Gold Limited (**ASX | TCG**) (**Turaco** or the **Company**) provides this notice under section 708A(5)(e) of the Corporations Act 2001 (Cth) (the **Corporations Act**).

The Company advises that it has issued 1,800,000 ordinary shares (**Shares**) following the exercise of unquoted options exercisable at \$0.12 per option (**Options**). Further details regarding the exercise of the Options are as detailed in the Appendix 2A lodged with ASX on 14 July 2026.
