- (1) Up to 1,250,000 Performance Rights effective 30 April 2027 would vest on 30 April 2028 (Tranche 1).
- (2) Up to 1,250,000 Performance Rights effective 30 April 2028 would vest on 30 April 2029 (Tranche 2).
- (3) Up to 1,250,000 Performance Rights effective 30 April 2029 would vest on 30 April 2030 (Tranche 3).

All the Performance Rights expire three years after the vesting date.
