Comments on the operations and the results of those operations are set out below:

For the quarter ended 30 June 2026, International Equities Corporation Ltd (IEQ) continued to deal with the effects of a slowing economy in Victoria. Higher operating cost, payroll, interest rates and inflation has negated cost savings measures put in place. Revenue from tourism remains weak due to a sluggish domestic economy and international events in the Middle East.

Operations at Seasons Heritage Melbourne ended In November 2025. Management of Seasons Botanic Gardens ended in June 2026, effectively ending all exposure to the hotel, tour and travel activities.

Apartments held have retained their value in the current economic climate. However, the Company will sell its stock of apartments to fund new business activities when the opportunity arises.

This quarter saw poorer revenue from the hotel division. This segment resulted in an after-tax profit from operations of \$0.289 million on revenue of \$0.064 million, mostly from write back of provisions.

On Sales and Leasing activities the company will continue to actively list new properties for sale or lease. Revenues were \$0.300 million for a profit after tax stood at \$0.164 million from commissions on long term leases. The outlook for the year ahead remains stable.

For the quarter ended 30 June 2026, the Group generated revenues of \$0.364 million from leasing of property, hotel accommodation and related activities. This resulted in an after-tax profit of \$0.219 million.

The Company will now return to property development when conditions improve.

This financial year Profit after tax per security was 0.04c (2025: Loss after Tax per security was 0.97c). Net tangible asset backing per security was 4.00c (2025: 3.96c)

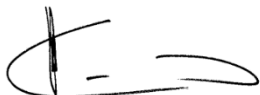
