Notice Under Section 708A(5)(e) of the Corporations Act 2001 (Cth)

American Uranium Limited (ASX:AMU) (**American Uranium, AMU** or the Company) gives notice for the purpose of section 708A(5)(e) of the Corporations Act 2001 (Cth) (**Corporations Act**) that, on 22 July 2026, it issued and allotted a total of 114,583 ordinary fully paid shares in the Company (**Securities**) without disclosure under Part 6D.2 of the Corporations Act.

The Securities are part of a class of securities quoted on ASX and may be subject to a subsequent offer for sale.
