QUARTERLY ACTIVITIES REPORT 30 JUNE 2026

HIGHLIGHTS

- Broad geochemical anomalies identified at the Tin Creek Prospect, part of the Murrindindi Gold Project, in Victoria.
- Planning in progress for re-commencement of exploration at the Amadeus Critical Minerals Project, where gallium results up to 260 ppm Ga were returned.
- Bubalus remains well funded, with \$3.03 million in cash, to pursue existing gold and critical minerals projects in Victoria and NT, and to pursue new opportunities.

Bubalus Resources Limited (ASX: BUS) (**Bubalus** or **the Company**) is pleased to report its activities for the June Quarter of 2026.

PROJECTS SUMMARY & ACTIVITIES

Murrindindi Gold Project - Victoria

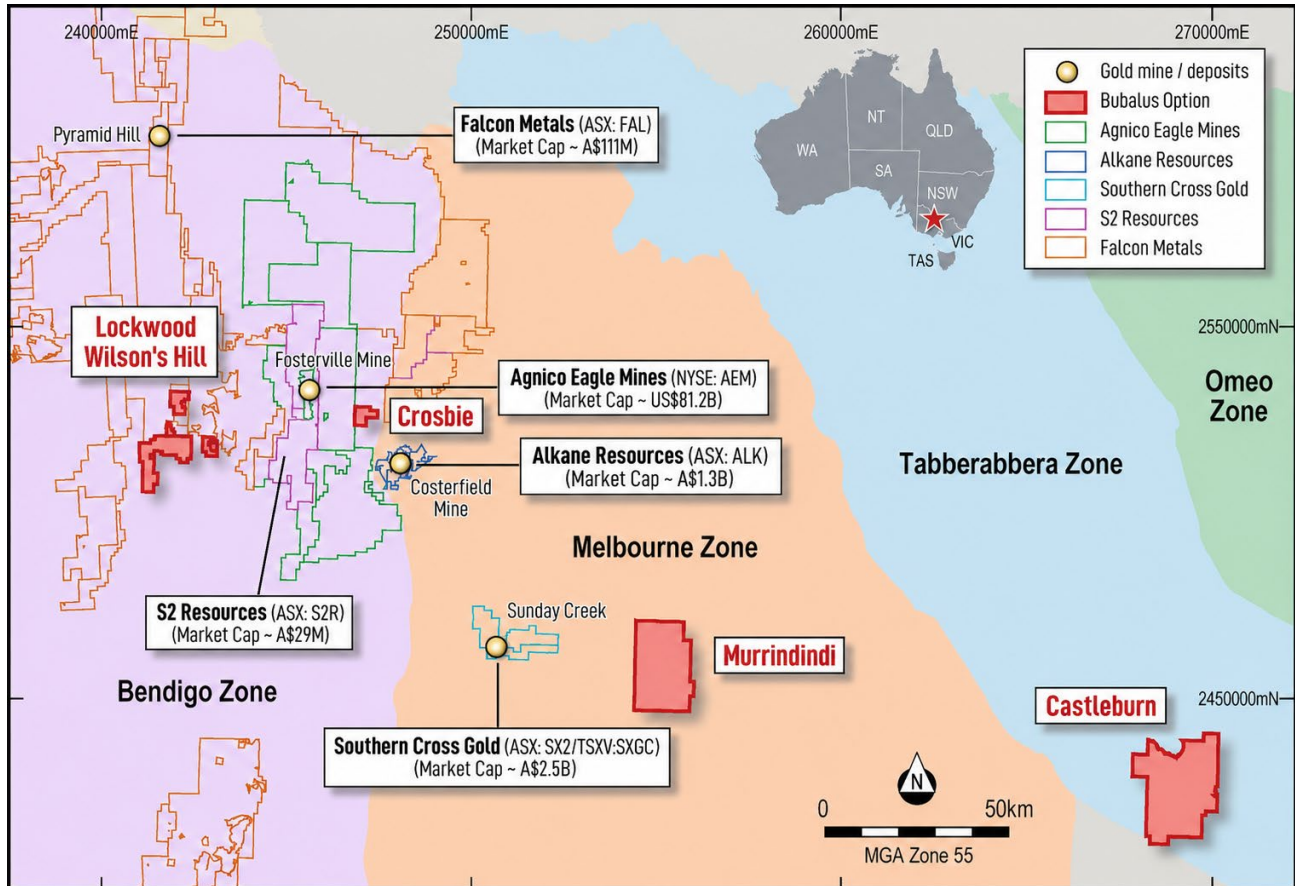


Figure 1. Location of Murrindindi showing proximity to the Sunday Creek Project

The granted Murrindindi exploration licence (EL007412) is located approximately 20 km east of the Sunday Creek Gold Project (Southern Cross Gold Consolidated) (Figure 1).

An extensive surface sampling program was completed earlier this Quarter, aimed at delineating targets for drill testing. Tin and tungsten anomalism, along with gold prospectivity, was identified during the 1980s, and culminated in the completion of a single diamond drillhole, which intersected tungsten and tin mineralisation, deemed at the time to be sub economic.

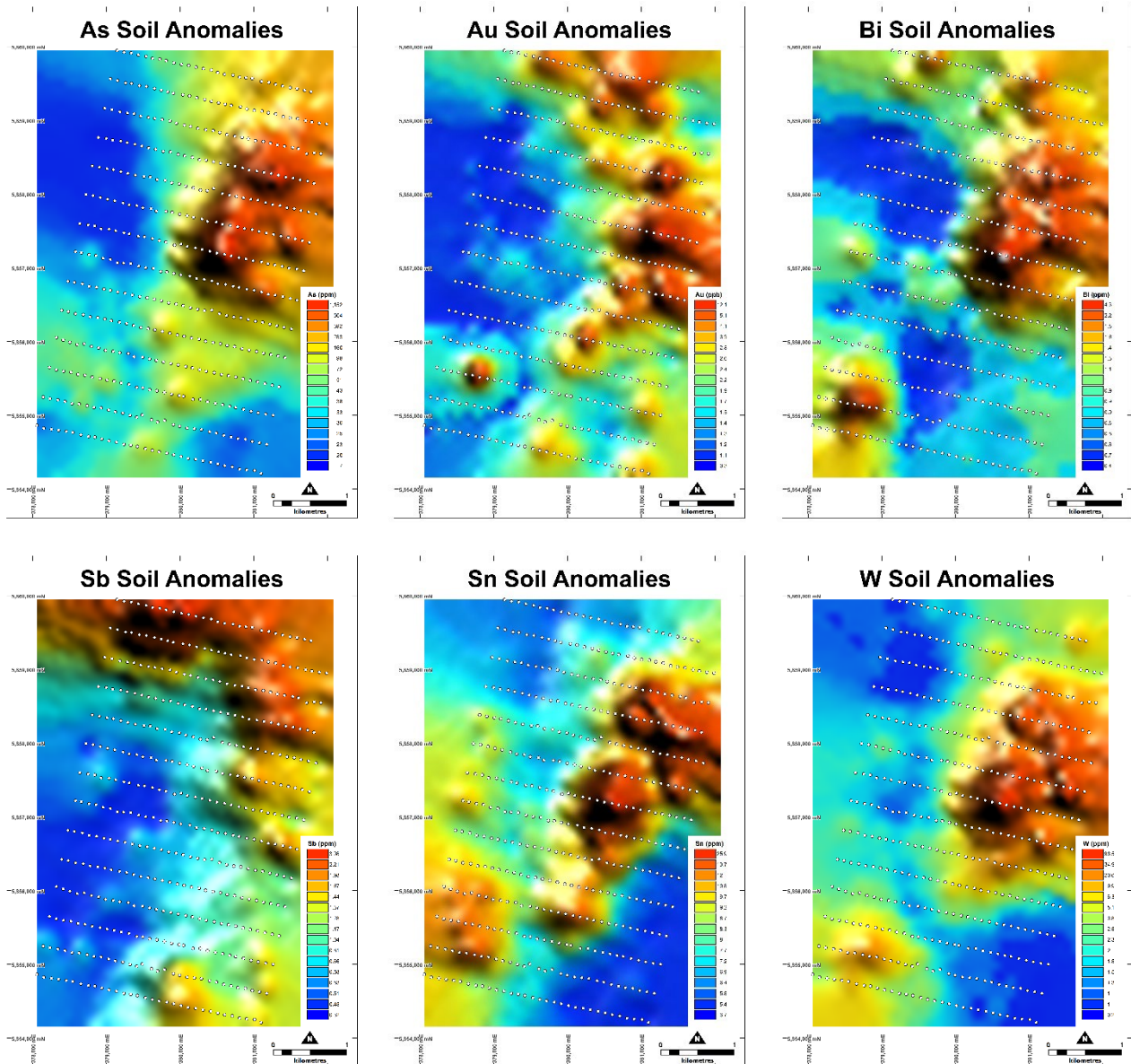


Figure 2. Key Element Anomalies

The soil sampling program comprised 441 samples, set out on a 400 m x 100 m grid. The results have delineated geochemical signatures that overlap. Firstly, a gold-hydrothermal signature with strong gold, arsenic, antimony and bismuth, and secondly, an intrusion-related signature, with elevated tin, tungsten and bismuth. Peak values of 32 ppb gold, 2,609 ppm arsenic, 255 ppm tungsten and 40 ppm tin were returned, as reported on the 15th of June, 2026. The anomalous geochemical footprint extends over several kilometres and comprises multiple coherent gold-pathfinder and tungsten-tin trends. (Figure 2)

Next Steps - Murrindindi

The Company is currently considering additional activities on the Murrindindi Project aimed at refining targets for drilling:

- Planning an airborne geophysical survey (MobileMT)
- Geological/structural mapping and interpretation.
- Infill and extension of the current sampling grid at Tin Creek, to refine and/or extend the known target areas.
- Soil and rock chip sampling over the Higginbotham Prospect, where high grade rock chips up to 131 g/t gold were previously reported.

Castleburn Gold-Copper Project – Victoria

A field visit was undertaken to the Castleburn Project during the Quarter, aimed at confirming the accessibility of the various mineral occurrences throughout the project, ahead of planned geochemical sampling programs in those areas.

Amadeus Critical Minerals Project – Northern Territory

As previously announced, the Company has rationalised tenure at the Amadeus Project, with the focus now being solely on EL32796, where previous work identified gallium anomalism up to 260 ppm, representing a key focus for further evaluation. (refer ASX announcement dated 25 November 2025) Preparation for the next phase of work at Amadeus was undertaken during the Quarter, which will focus on field programs to understand the significance of the identified gallium, base metals, and manganese mineralisation identified in earlier sampling.

Nolan's East Rare Earth Project – Northern Territory

Nolans East is located 15km southeast of the Nolans Bore deposit owned by Arafura Resources Limited. The Company has defined and had approved a drilling program targeting surface geochemical anomalies. The Company continues to pursue the final approval required before drilling can commence, which is an updated Land Access Agreement with the pastoral leaseholder, which is required due to a change of ownership.

Business Development and Cash Position

A significant focus during the Quarter has been on evaluating potential new opportunities, predominantly in the gold, copper and critical mineral commodities. The Company remains well funded, with \$3.03 million in cash to support ongoing exploration on its current projects, and near-term evaluation of priority acquisition targets.

FORECAST ACTIVITIES FOR QUARTER 3, 2026

Victorian Gold Projects

- Planning of follow up activities at the Tin Creek and Higginbotham Prospects at **Murrindindi**.
- Potential submission of a Low Impact Exploration Plan for **Wilson's Hill Gold Project**, pending positive land access discussions.
- Planning for follow up programs at other Victorian Gold Projects, including the Crosbie South and Crosbie North Gold Prospects, and the Castleburn Gold-Copper Project.

Amadeus Critical Minerals

- Systematic surface sampling to define the distribution and continuity of the identified gallium anomalism.
- Detailed geological and structural mapping
- Review and integration of geophysical datasets to refine drill targets.
- Prioritisation of prospects for potential drilling based on combined gallium, manganese and polymetallic indicators.

Nolan's East REE

- Finalisation of Land Access Agreement (LAA).
- Engagement of drilling contractor.
- Preparation for maiden drilling program (subject to completion of LAA and rig availability).

Project Generation

- Continue review of new opportunities.

CORPORATE

Cash Position

Bubalus held cash reserves at the end of Quarter of approximately \$3.03 million.

Shareholder Information

As at 30 June 2026, the Company had 573 shareholders and 69,888,008 ordinary fully paid shares on issue with the top 20 shareholders holding 37.76% of the total issued capital.

ABOUT BUBALUS RESOURCES

Bubalus has five projects, the Victorian Gold Projects, the Yinnietharra Lithium Project (prospective for lithium), Amadeus Project (prospective for Manganese), the Coomarie Project (prospective for Heavy Rare Earths), the Nolans East Project (prospective for Light Rare Earths) which are located in the Northern Territory and Western Australia:

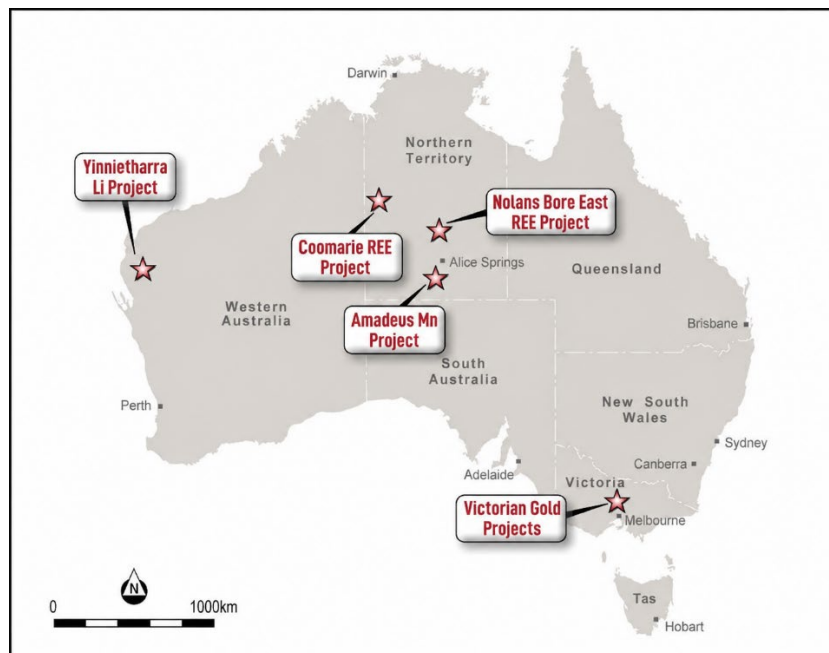
Victorian Gold Projects (Au/Sb) – A portfolio of 5 granted licences in the heart of the Victorian Goldfields. Headlined by the Crosbie Project, which has drill ready targets supported by high grade surface gold and antimony, geophysical anomalies, and geological characteristics.

Nolans East Project (Light REEs) - The project covers 380 km² of the Arunta Province, analogous to Nolan's Bore light rare earth deposit and is prospective for light rare earths, located only 15 kms east of Arafura's (ASX:ARU) 56Mt NPV \$1.011Bn light rare earth deposit.

Yinnietharra Project (Li) - Yinnietharra Project with the boundary of E09/2724 lying only 2 km east of the Malinda Prospect owned by Delta Lithium Limited (ASX:DLI) (**Delta**). Drilling at Malinda by Delta has identified spodumene-hosted lithium mineralisation over 1.6 km and to a depth of 350 m¹.

Amadeus Project (Mn) - Significant land package with outcropping high-grade manganese, located 125 km south of Alice Springs, where historical exploration has identified 11 manganese occurrences, along with cobalt, gallium and Ni-Zn-Cu anomalism.

Coomarie Project (Heavy REEs) - The project covers 1,315 km² and presents as a geological analogue to Browns Dome, host to Northern Mineral's (ASX:NTU) Browns Range heavy rare earths deposit where mineralisation is hosted on margins of granite dome intrusive where the unconformity between Gardiner Sandstone and Browns Range Metamorphics exist and located in the Tanami Region.
