Quarterly Activities Report

For the quarter ended 30 June 2026

Desert Minerals Limited (ASX: DSM) ("Desert Minerals", "DSM" or "the Company") is pleased to provide its Quarterly Activity Report for the period ended 30 June 2026 ("Quarter" or "Reporting Period").

Quarter Highlights

- Desert Minerals received strong gold anomalism from the 379-sample UltraFine⁺ soils program at the Mt Monger Gold Project, defining coherent trends (including the Titan anomaly) coincident with structural complexity and historical drilling ⁽¹⁾.
- Drilling was successfully completed at the Scotty Lithium Project on time and on budget. Consistent clay-hosted stratigraphy was intersected across all holes, with high core recoveries achieved. Assay results are pending ⁽²⁾.
- The Company raised \$1.0 million via a placement at a premium to the prevailing market price ⁽³⁾.
- Desert Minerals continues to selectively assess potential project and corporate opportunities consistent with its strategy of building a portfolio of high-quality mineral assets.

Project Summary

Mt Monger Gold Project (Western Australia)

During the Quarter, Desert Minerals received assay results from the 379-sample UltraFine⁺ soils program at the Mt Monger Gold Project. The program returned strong gold anomalism, with gold values of up to 112 ppb, defining a coherent north-northwesterly trend (Titan anomaly) through the central portion of the survey area, in places coincident with observed quartz veining at surface. The Titan soil anomaly forms the most continuous area of approximately 500 m x 300 m and coincides with a historical aircore intercept of 2 m @ 3.8 g/t Au from 49 m in hole NMR550.

An additional anomaly (Orion) was also identified in the northern portion of the Project. Planning advanced for a maiden drilling program at the Providence Prospect, with all approvals secured and a drilling contractor appointed subsequent to quarter end. Drilling is scheduled to commence in August 2026.

Scotty Lithium Project (Nevada, USA)

Drilling was successfully completed at the Scotty Lithium Project during the Quarter on time and on budget. The program targeted high-priority lithium zones through a combination of infill and step-out drilling, informed by previous drilling, soil geochemistry and magnetotelluric datasets.

Consistent clay stratigraphy interpreted as potentially lithium-bearing was intersected across all drill holes, comprising lean green to olive-grey clay (primary lithium-bearing unit), blue-green transitional

clay (OX/REDOX boundary), and brown lithic-rich clay (basement or immediately overlying basement). Sonic drilling delivered high core recoveries, providing high-quality samples for detailed geological logging and analysis. Basement or near-basement material was positively identified in multiple holes.

Assay results from the program are pending. Once received and interpreted, the Company will commence work toward a maiden Mineral Resource Estimate for the Scotty Lithium Project, subject to results.

The Scotty Lithium Project features a JORC (2012) Exploration Target of 460–837 million tonnes at 1,145–1,175 ppm lithium.

The Exploration Target is conceptual in nature. There has been insufficient exploration to estimate a Mineral Resource, and it is uncertain whether further exploration will result in the estimation of a Mineral Resource ⁽⁴⁾.

Corporate

During the Quarter the Company completed a \$1.0 million placement at a premium to the prevailing share price, strengthening the balance sheet to advance both the Mt Monger and Scotty projects.

The Company continues to selectively assess potential project and corporate opportunities consistent with its strategy of building a portfolio of high-quality mineral assets.

Finance Update

The Quarterly Cashflow Report (Appendix 5B) for the period ending 30 June 2026 provides an overview of the Company's financial activities.

The Company is in a strong financial position with ~A\$4.05 million in cash for the period ending 30 June 2026.

Desert Minerals' Executive Chairman, Mr. Peretz Shapiro, commented:

The second quarter delivered solid progress across both of our projects. At Mt Monger we received encouraging UltraFine⁺ soil results that have further refined our understanding of the system, and we are now ready to commence drilling at Providence. At Scotty, the team executed a clean and efficient drill program that has strengthened our geological confidence in the asset. With a stronger balance sheet following the recent placement, we are well positioned to advance both projects and look forward to reporting further results in the coming months.

Desert Minerals Limited (ASX: DSM) is a well-structured resource exploration company focused on projects in Tier 1 mining jurisdictions across Australia and North America. Through systematic, technology-driven exploration, the Company is committed to advancing its gold and lithium assets—including the Mt Monger Gold Project in Western Australia and the Scotty Lithium Project in Nevada, USA—with the aim of growing and delineating JORC-compliant resources and delivering value for shareholders.
