At Quarter-end, Beetaloo Energy Australia Limited (BTL) had the following credit facilities in place with Macquarie Bank Limited which are secured by the Company's Northern Territory assets: • R&D Facility (\$30 million) which carries an interest rate of BBSW+5.5% and commitment fee of 40% of the margin on undrawn amounts – drawn to \$12.4 million as at Quarter-end; • Midstream Infrastructure Facility (\$45 million), which was upsized during the Quarter and matures on 30 September 2035, had an outstanding balance of \$2.5 million as at Quarter-end following first drawdown on 26 June 2026. The facility is available to support construction and development activities for the Carpentaria Pilot Project; and • Performance Bond Facility (\$5 million) which carries an interest rate of 10.0% had an outstanding balance of \$3.5 million as at Quarter-end.
