

Notice Pursuant to Section 708A(5)(e) of the Corporations Act

Brazilian Critical Minerals Limited (**ASX: BCM**) ("**BCM**" or the "**Company**") gives notice pursuant to section 708A(5)(e) of the Corporations Act 2001 Cth ('the **Act**') that on 28 July 2026, it has issued 3,541,667 fully paid ordinary shares on the conversion of options.
