APPENDIX 4C AND REPORT ON QUARTERLY ACTIVITIES

Sydney, Australia, 31st July 2026: Victor Group Holdings (ASX: VIG) (“VIG” or “the Company”), releases its cash flow report for the June 2026 quarter (Appendix 4C) and provides an update on the key areas of activity during the quarter ended 30 June 2026.

Principal Activities

VIG and its controlled entities (the “Group”) provide:

- IaaS, SaaS & PaaS services to customers;
- Education cloud platforms which bring together best-in-class resources and applications from strategic partners such as education service and e-learning content providers; and

Key areas of activity during the quarter:

- IaaS, SaaS & PRC – VIG operates its cloud services and software development in PRC through its subsidiary, Shenghan. During the quarter, Shenghan collected around \$401K in trade receivables from IaaS, SaaS and PaaS services. The software we delivered includes Data management and customised AI agents for different clients in different sectors. The Company continued to deliver a positive operating cash flow this quarter, underpinned by sustained cash collections from the segment. The management team remains confident that the operating cash flow will stay healthy in the next quarter.

The cash and cash equivalents position of the consolidated entities at the end of this quarter was \$508K. The group, including its subsidiaries, continues to carry no external debts, and the management believes no external fundraising is necessary for the current business in PRC. A financial support confirmation has been provided by the major shareholder to safeguard the Company against any potential default on debts or payables.

- E-learning and cloud education – the Company collected \$1.69 million in trade receivables in this segment during the quarter. The Company signed approximately \$1.12 million of new Cloud education contracts during the period. The Company incurred approximately \$1.47 million in normal quarterly procurement expenditure for Cloud education content and platform services. The Company collaborated with many qualified and stable E-learning providers who focus on vocational training in IT, Intelligent IoT and AI agent areas, which helped promote its e-learning content in the

market. The management believes there will be further development in this area, supported by increasing market enthusiasm for IT and AI-related vocational courses.

Comment on Appendix 4C

The Company maintained a positive net operating cash flow this quarter, supported by steady collections from the IaaS business. The Company made \$1.07 million in capital expenditure on AI agent related development tools and platform in the quarter and collected \$531K in proceeds from the disposal of intangible assets and PPE. The management believes the Group's cash flow will remain healthy going forward, underpinned by ongoing cash generation from the core operations.
