Introduction

Tarrina Resources Limited (**Company**) has established a corporate governance framework, the key features of which are set out in this statement. 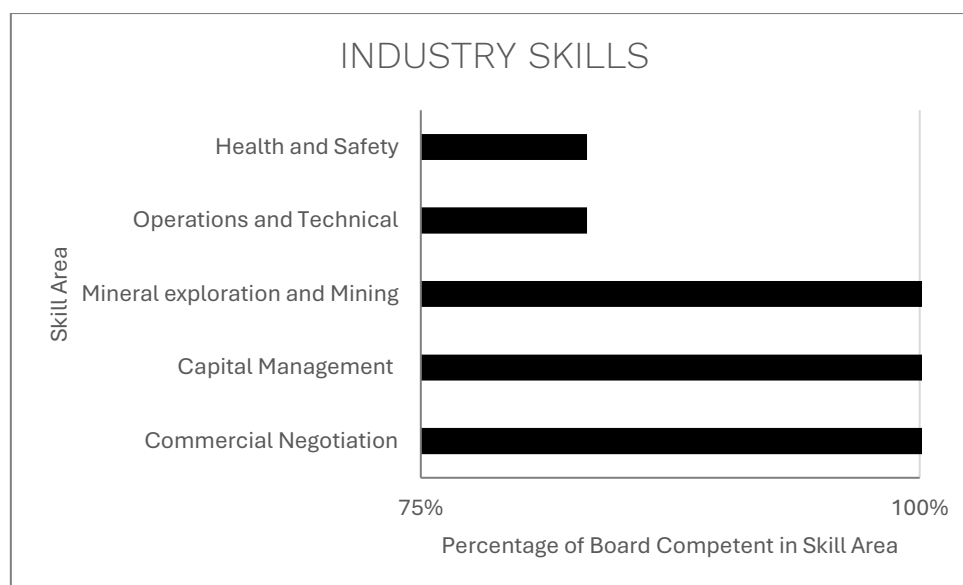
