The company will issue a total of 33,095,696 new shares in Tranche 1 to raise \$12.2m utilising the Company's existing placement capacity under listing rule 7.1.

A further 15,552,953 new shares will be issued in Tranche 2 under listing rule 7.1 to raise \$5.8m following a General Meeting of Shareholders anticipated October 2026. This includes a commitment of \$2,000,000 from major shareholder Tembo Capital Holdings UK Ltd and a commitment from Chairman Paul Cronin of \$500,000 in the placement both of which are conditional subject to shareholder approval at a General meeting.
