## **Whalers Well Advances into Woodford Lateral** **Intermediate casing successfully run and cemented; curve landed as planned in the Woodford Shale**

**Tulsa, Oklahoma, USA – 19 August 2026 – Brookside Energy Limited (ASX: BRK) (OTC Pink: RDEF) (Brookside or the Company)** is pleased to provide an update on drilling operations at the Whalers 2-1-1S-3W WXH2 well at the Suttles pad in the SWISH Area of Interest in Oklahoma's Anadarko Basin.

Drilling operations at Whalers have progressed through the intermediate section, with intermediate casing successfully run and cemented at the planned depth.

The team then drilled the curve and successfully landed the wellbore within the targeted bench of the Woodford Shale, in line with the well plan. Whalers is now drilling ahead in the lateral section.

Whalers is the second well in the two-well Suttles pad development program. Sabres has already been drilled and cased and, once Whalers reaches its planned total measured depth and production casing is installed, both wells will move into simultaneous fracture-stimulation operations.

Brookside holds an approximate 70% working interest in Sabres and Whalers.

“Whalers continues to progress as planned. Intermediate casing is in place, the curve has been successfully landed in the targeted Woodford bench and we are now drilling ahead in the lateral.

“The team has carried the same safe, disciplined execution from Sabres straight into Whalers. With several key well-construction and directional-drilling risks now behind us, the focus is on drilling the lateral efficiently, getting production casing to bottom and preparing both wells for simultaneous fracture stimulation.”

Brookside looks forward to providing further updates as operations progress.
