Directors' Report



The Directors present their Annual Report to the members, together with the audited Consolidated Financial Statements of Lycopodium Limited (the 'Company' or 'parent entity') and its subsidiaries (the 'consolidated entity'), for the financial year ended 30 June 2026 and the Statement of Financial Position of the consolidated entity as at 30 June 2026.

Principal Activities

The principal activities of the consolidated entity during the financial year consisted of the provision of engineering and project delivery services in the resources, industrial processes and rail infrastructure industries. There were no significant changes in the nature of the consolidated entity's principal activities during the financial year.

In addition to the above dividends, since the end of the financial year the Directors have recommended the payment of a final fully franked dividend of \$14,703,884 (37.0 cents per fully paid share) to be paid on 2 October 2026 out of retained earnings at 30 June 2026 (2025: \$9,935,057). This brings the total dividend declared for the year ended 30 June 2026 to 59.0 cents (2025: 35.0 cents).

Review of Operations

FY26 has been another exciting year for the Company, with an expanded geographic reach and the continued delivery of high-quality studies and projects for our clients globally, across the Resources, Industrial Processes and Rail Infrastructure industries.

Full Year Results

For the financial year ended 30 June 2026, Lycopodium generated revenue of \$377.5 million and net profit after tax of \$40.2 million. The Company's sustained positive financial performance continues to deliver long-term value and confidence in returns for our shareholders. The Directors have resolved to pay a final dividend of 37 cents per share. The total dividend for the year is 59 cents fully franked.

Activities for the Past Year

The past 12 months has seen a refinement of approach to management across our three operational hubs, being APAC, the Americas and Africa. This regional management approach supports our "One Lycopodium" philosophy, enabling us to engage more effectively with clients and access new market opportunities. Importantly, it leverages local expertise and supports structured growth across key markets where significant opportunities are identified, for example, the Americas.

In this regard, we have seen an increase in activity over the past 12 months within our Americas hub, with a number of major projects currently in delivery out of Toronto. Furthermore, the addition of SAXUM, the Argentinian-based business we acquired a majority shareholding in in 2025, has facilitated our ingress into Latin America. Having a physical presence in this region is presenting new opportunities that would not have otherwise been accessible. Our African hub, based in Cape Town, is providing a critical role in supporting

projects in delivery across the continent, enabling us to leverage the local expertise and capability that exists in key locations, including Namibia, amongst others. From an APAC perspective, we are continuing to service clients operating across Africa, and pleasingly, have secured significant work closer to home, providing services for a number of projects being delivered in Western Australia.

In the longer term, we expect to see a more regionally balanced portfolio of studies and projects across our global operations. Focus therefore remains firmly on continuing to grow our capacity and capabilities across our regional centres to support current and forecast work-in-hand.

We set in place a strategy several years ago focused on developing the necessary systems infrastructure required to enable us to operate effectively as a truly global business. This included the introduction of a global HR Information System (HRIS) and the roll out of a broader enterprise resource planning (ERP) tool. During FY26 we have continued to embed these critical systems across the business to maximise the significant operational benefits they deliver, in providing a standardised platform across all operating entities and supporting workplace efficiencies. This has been particularly important in facilitating workshare across our operations to optimise global resource utilisation and provide access to specialist capability that does not exist within a single office, leveraging global knowledge, relationships, and expertise to deliver better project outcomes.

With the fundamental premise that our people are our business, we continue to provide the learning and development support required to enable our staff to grow their career with us. This includes a suite of tailored programs and L&D tools focused on developing both technical and soft skills. The 'Develop' module available within our Culture Amp platform, which was launched in FY25, has been further embedded throughout the past year and provides our people with visible career pathways, mapped with competencies, to enable them to visualise and plan their future with us.

Outlook

The global economic outlook for FY27 suggests steady but subdued growth, with geopolitical unrest, energy market volatility and trade fragmentation impacting confidence and disrupting global supply chains. Across the resources industry, commodity prices are expected to stabilise after recent declines, with modest increases projected for 2027 as global demand improves.

Demand for critical minerals continues to be driven by the global energy transition, coupled with digital infrastructure development. The requirement for key minerals including copper, lithium, nickel, cobalt and rare earth elements is expected to continue rising as investment in renewable energy technologies, including systems and storage and electric vehicles, accelerates. Sector growth is also being driven by increasing electrification across industries and the expansion of data centres. Projects to meet this rising demand are increasingly being driven out of Latin America, with significant investment in greenfield and brownfield projects across key jurisdictions, including Argentina, Peru, Chile and Brazil.

Demand for gold remains buoyant, underpinned by persistent geopolitical uncertainty and sustained central bank buying. While greenfield project developments are advancing, they are subject to disciplined capital allocation, with macroeconomic conditions, including interest rates and inflationary pressure, influencing development timelines. The current environment is driving investment in existing operations and brownfield expansions to extend mine life. Activity is predominately being driven out of key producing regions where resources are abundant and existing infrastructure and investment conditions support development, including Africa, Canada, South America and Australia.

Global demand for uranium and investment in projects to increase supply following years of underinvestment is being driven by a renewed focus on nuclear energy as a reliable, low-carbon energy source. This environment is supporting brownfield expansions and restarts of previously suspended

mines, many of these in Namibia, in addition to greenfield developments in high-quality jurisdictions, including Canada, which is considered a major growth hub for uranium project development.

Demand for iron ore remains moderate, primarily due to reduced demand from China resulting from its weakened property sector and subdued investment in infrastructure development. However, while China remains central to the market, demand is becoming more diversified geographically, with infrastructure development and industrialisation across emerging markets, including Southeast Asia, India, the Middle East and Africa. In Australia, investment is focused on sustaining existing operations, with incremental expansions and efficiency upgrades, while major brownfield expansion projects are being pursued in Brazil.

Within the Industrial Processes industry, forward opportunities are underpinned by government incentives that support domestic manufacturing and value-added processing, including those associated with the *Future Made in Australia – National Interest Framework*. Investment is expected to be directed towards advanced processing facilities for critical minerals, battery materials, pharmaceuticals and green chemicals, as Australia seeks to move further downstream within global industrial supply chains.

The outlook for rail infrastructure projects in Australia remains strong, supported by sustained government investment and a significant pipeline of major passenger and freight developments. Investment is being driven by population growth, urban transport demand, and the need to improve freight efficiency and supply chain resilience, together with the critical role of rail in supporting the mining sector. Improvements to the Australian Rail Track Corporation's (ARTC) national rail network are ongoing, with the ARTC undertaking a significant program of work under its Network Investment Program, including new capital investments and accelerated asset replacement. Furthermore, climate change is driving investment in rail infrastructure, both to climate-proof infrastructure from extreme weather events, including heat and flooding, and accelerate the shift to low-emissions transport.

Operational Highlights

FY26 was another busy year for the business in project delivery, with a significant portfolio of projects being executed around the world.

HSE

Over the period, we recorded 9 million controlled service hours, compared to 15.7 million in FY25. Our sustained positive safety record is reflective of the commitment of our people across the business to fostering a safe working environment, and the Lost Time Injury Frequency Rate (LTIFR) of zero achieved over the 12-month period is a credit to them all.

The underlying philosophy that all incidents are preventable if the risk is understood and managed is fundamental to our culture and safety in delivery is considered a cornerstone of project success.

Resources

The studies and projects we deliver for our clients span the world, including Africa, Australia, Southeast Asia and North and Central America, and most major commodities, including gold, lithium, diamonds and gems, copper, nickel, battery minerals, mineral sands, uranium, graphite and other rare earths.

During FY26 we saw the successful completion of several major projects, including the Ahafo North Project in Ghana (Newmont), the Chemical Grade Processing Plant #3 Project in Western Australia (Talison Lithium), the Boto Gold Project in Senegal (Managem Group) and the Bomboré Hard Rock (Stage 1) Project in Burkina Faso (Orezone).

Other significant projects ongoing throughout the year include the Yanqul Copper-Gold Project in Oman (Mazoon Mining), the Baomahun Gold Project in Sierra Leone (FG Gold), the Koné Gold Project in Côte d'Ivoire (Montage Gold), the Twin Hills Gold Project in Namibia (Osino Resources), the Blackwater Expansion Project (Phase 1A, EP2 and Phase 3) in Canada (Artemis Gold), the Bomboré Hard Rock (Stage 2) Project in Burkina Faso (Orezone), the Winu Copper-Gold Project in Western Australia (Rio Tinto), and the Nyanzaga Gold Project in Tanzania (Perseus).

Several new projects have been secured over the past few months, including the Tulu Kapi Gold Project in Ethiopia (KEFI Gold and Copper), the Doropo Gold Project in Côte d'Ivoire (Resolute Mining), the Katanning Gold Project Early Works in Western Australia (Ausgold), the Pilgangoora P2000 Expansion Project in Western Australia (PLS Group), and the San Cristóbal Silver Oxide Project in Bolivia (Minera San Cristóbal S.A.), with these projects set to ramp up as we move into FY27.

LPN Dry Mining Services, Lycopodium's joint venture with Piacentini & Son, a specialised earthmoving and mining equipment company based in Western Australia, is providing services to Namdeb Diamond Corporation (Namdeb) in Namibia, with the establishment and operation of a pilot

project involving a modular dry mining facility for the stripping of overburden, under a two-year contract. This strategic work is another example of Lycopodium broadening its service offering into adjacent fields.

Our study pipeline remains strong and continues to lay a solid foundation for future project execution work. The number of quality projects in study phase presents a positive sign for Lycopodium's future project pipeline.

Lycopodium's wholly owned subsidiary, Orway Mineral Consultants (OMC), continues to be a critical technical partner to our Resources business. Considered a global leader in comminution circuit design and optimisation, OMC provides specialist services in flowsheet development, optimisation and process design, as well as supporting our clients to maximise operational performance post project completion. Experts in plant data analysis, OMC is also an integral element of our digital engineering strategy.

Rail Infrastructure

In Rail Infrastructure, we are known for our expertise in the provision of design, engineering, technical advisory and Rail Infrastructure Management (RIM) services for greenfield and brownfield rail projects across Australia, servicing both government and private sector clients.

During FY26, our team worked with the ARTC to undertake feasibility and concept design services for two crossing loop upgrades on the Broken Hill line in New South Wales under the Network Investment Program. In Western Australia, we supported Arc Infrastructure in the delivery of its Agricultural Supply Chain Improvements Project, providing track design services for upgrades between Carnamah and Mingenew.

Innovation

Lycopodium is founded on a strong commitment to innovation and continuous improvement. By continually seeking better and more efficient ways of working, we are providing new ideas and improved outcomes for our clients and enhancing our internal processes.

Innovation at Lycopodium comes in many forms, and our bi-annual Innovation Award offers the opportunity to showcase the outstanding ideas being generated and turned into reality by our people. Our two winning award submissions for FY26 included the development of a Sleeper Condition Assessment Workflow by members of our Rail Infrastructure team and the development of an internal system to manage Engineering & Drafting (E&D) progress across projects, aptly named 'PodControl'.

The Sleeper Condition Assessment Workflow is a pioneering, image-based infrastructure inspection system that leverages artificial intelligence to automate the detection and quantification of defects in railway sleepers. Developed as a modular pipeline, it transforms raw site imagery into actionable condition data through a series of intelligent processing steps, enabling real-time condition mapping and maintenance planning. This innovation represents a significant leap forward in digital asset management, offering a foundation for smarter infrastructure monitoring across transport, utilities, and public works sectors.

PodControl is a web-based system that provides an accurate, efficient, and standardised approach to managing Engineering & Drafting performance across projects.

It interfaces directly with our enterprise business software platform to incorporate real-time data. PodControl brings significant organisational and operational benefits to Lycopodium, providing a more accurate and timely representation of performance across E&D activities, reducing manual effort, minimising the potential for error, and increasing confidence in forecasting and schedule control. Importantly, given the global nature of our business, PodControl supports workshare execution by enabling budgets and responsibilities to be divided across multiple offices, supporting efficient multi-office execution and strengthening collaboration and our ability to workshare across the Company.

Other notable award submissions put forward by our people over the past 12 months include the further development of our digital capability, creating digital twins to monitor mine performance, improve efficiency and reduce downtime, and the improved design of mineral processing components and functions, including an online metal removal system, a prefabricated, modular steel reclaim vault, a stockpile reclaim feeder chute, a stockpile feed conveyor design, a standard truss design for 45m spans, and a CIL launder installation process to improve efficiency and safety.

Beyond the solutions for our clients and internal improvements our innovative thinking is delivering, the ingenuity of our people is also enabling us to participate in world-leading Research & Development projects that are determining the path forward across a spectrum of new industries and technologies.

Community

We are committed to contributing meaningfully to the communities in which we live and work, with our philanthropic activities administered through the Lycopodium Foundation. In particular, we prioritise endeavours that advance social development and education and have supported a range of fantastic initiatives over the past 12 months.

We continue to build on our long-term partnerships with the Clontarf Foundation and Murlpirrmarra Connection in Australia. Both organisations support the education, self-esteem, life skills and employment prospects of young Aboriginal and Torres Strait Islander people, and we are very pleased to have the opportunity to support the fantastic work they do with thousands of children around the country. In addition to the financial support we provide, these partnerships also enable our people to engage with the students directly, participating in activities and events undertaken throughout the year. Similarly, our support of the Ubuntu Football Academy in South Africa, an organisation committed to integrating graduates back into their individual communities to foster long-term change, also provides the opportunity for hands-on interaction with students and the opportunity to bring new perspectives. Ultimately, in engaging with these organisations, we hope to encourage students to complete their schooling and introduce them to the concept of a career in engineering.

Based in Accra, Ghana, BASICS International is committed to protecting the basic human rights of children to education, shelter, food and safety and we have shared a long history with the organisation dating back to 2010 when we supported them to build a school in Accra.

Our focus in recent years has been on providing support in the development of a camp for children in the countryside outside of Accra, offering STEM education and vocational and outdoor activities. Construction commenced in late 2024, with Phase 1 of the project, including the construction of the caretaker's house, technical buildings for student lessons, a cluster of palava huts for communal gatherings and assemblies, and a toilet and change room block, now complete, enabling day visits to commence. Phase 2, anticipated to commence in FY27, will include the construction of student and staff accommodation for longer stays.

Our support of Rafiki Australia Tanzania's Rafiki wa Binti (which means 'a friend for a girl' in Swahili) program remains ongoing. To mitigate the widespread issue of girls in Tanzania leaving school at puberty because they don't have the understanding or means to manage their menstrual cycle, the Rafiki wa Binti program is providing menstrual packs, including reusable period underwear and education kits, to schools in rural Tanzania, delivered via an education officer. The concept has been developed in consultation with local communities and so far, the initiative has provided 4,000 Binti Packs (24,000 pairs of underwear) to 4,000 girls across the country. An ambitious target has been set to reach a further 6,000 girls by the end of 2026.

Our team in Manila is continuing to build its relationship with the Eugenia Ravasco Foundation, whose mission is to fight against social exclusion in the Philippines, offering protection, medical care, nutrition and education to support vulnerable families to integrate in their communities.

Over the year, we donated grocery hampers to families at Christmas and funded the School Wellness and Infrastructure Project for the Eugenia Ravasco Day Care Centre. The project included the renovation of classroom and toilet facilities and revitalisation of the playground, in addition to providing complete sets of uniforms, shoes, bags, school supplies, and hygiene kits to more than 60 young students.

The Twin Hills Trust in Namibia serves as the socio-economic and environmental development vehicle for companies associated with the Twin Hills Gold Project, for which we are currently providing EPCM services for construction of the plant. The Trust was established to champion development projects that contribute to community support, including health initiatives; education, including early childhood development; and Training & Enterprise development. With this remit in mind, which is closely aligned with that of the Lycopodium Foundation, we have been very pleased to support the work of the Trust during FY26.

The Lycopodium Women in Mechanical Engineering Scholarship was established in 2024 to provide support to female students undertaking a degree in Mechanical Engineering at Curtin University in Western Australia. The scholarship provides financial support to students as they complete the final two years of their degree, contributing towards payment of their course fees, or for other education-related expenses such as textbooks or general living expenses. Since its inception, we have welcomed four young female engineers into the business, with our inaugural recipients now working for us on a full-time basis and the other two recipients participating in our Summer Vacation Program whilst completing their studies.

Alongside Company-initiated partnerships, I am proud of the strong sense of purpose demonstrated by our people in supporting initiatives close to their own hearts. Notably, our long-standing partnership with Jeans for Genes, dating back

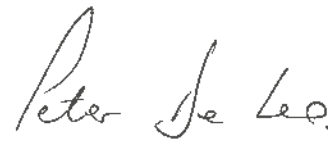
to the 1990s, which has raised an exceptional \$550,000 for the Children's Medical Research Institute. Our employees also continue to contribute to the valuable work of organisations including the St Vincent de Paul Society and Breast Cancer Care WA, amongst others.

Our membership of the Australia-Africa Minerals & Energy Group (AAMEG), the peak body representing Australian companies engaged in the development of Africa's resource industry, continues to be a valuable resource in supporting our work across the region.

Risk Management Overview

Lycopodium has a robust approach to risk management in order to provide sustainable longterm value to its shareholders. Strong risk management practices enable the Board and management to make strategic decisions that align with the risk appetite of the business.

Our risk management framework provides a whole-of-business approach and sets out the process for identifying, evaluating, monitoring, reviewing and reporting of risk. The Board has established a Risk Committee which monitors, reviews and reports on our risk management throughout the business. We undertake risk assessments and workshops to evaluate and prioritise risks. These include emerging risks which may present the business with medium to long-term risk exposure.

We use qualitative and quantitative methods to define risk consequences. We view consequences across a range of possible financial and non-financial impacts, such as health and safety, environmental, reputational, commercial and legal and community. To prioritise risk we use our Company risk matrix and consider the risk's consequences as well as its likelihood.

This assists in identifying risks that have the potential to be the most significant.



In FY2026 we identified seven strategic risks that could influence the sustainability of our business. These risks, with an outline of our mitigation controls, are set out in no particular order and are not an exhaustive list of risks that may impact Lycopodium, however are considered to be the most significant.

Principles Used to Determine the Nature and Amount of Remuneration

The objective of the consolidated entity's executive reward framework is to ensure reward for performance is competitive and appropriate for the results delivered. The LTI performance measures are assessed on the achievement of personal and Company objectives.

During the financial year ended 30 June 2026, the consolidated entity did not engage any remuneration consultants for assisting the Remuneration Committee.

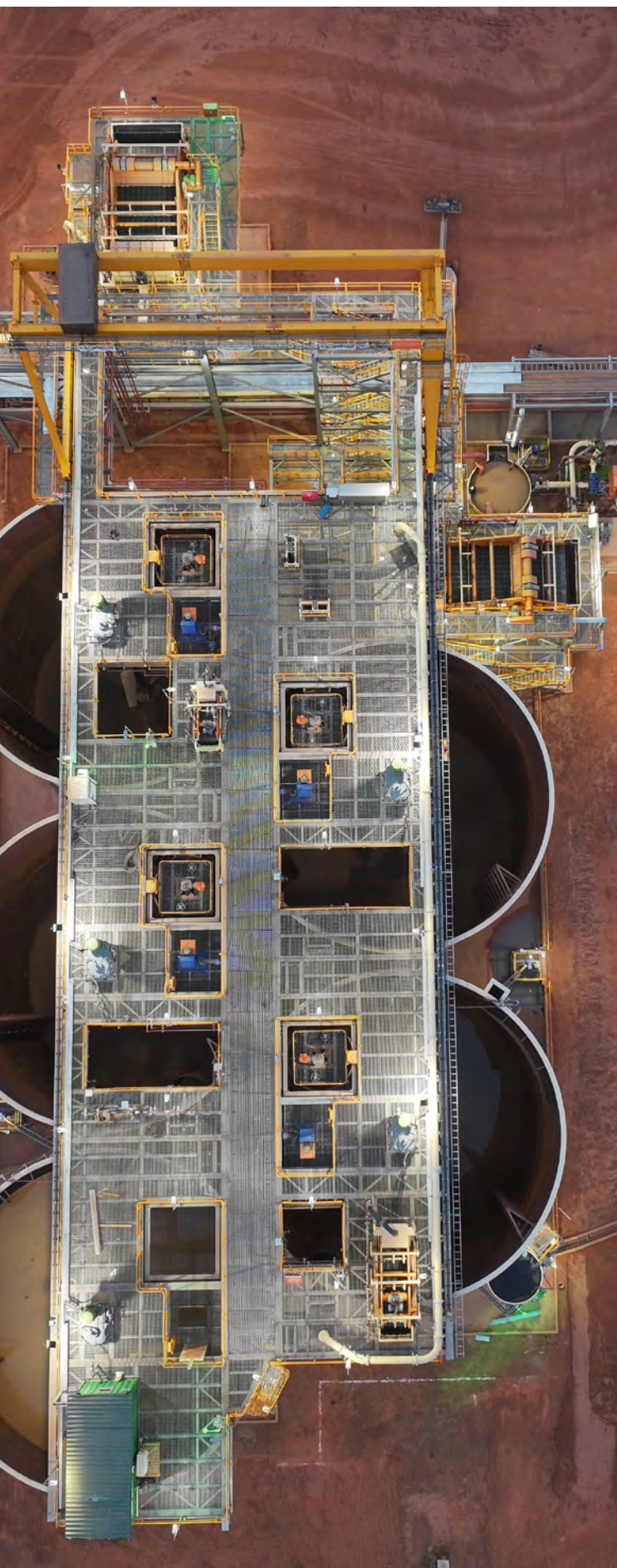
The Board of Directors of Lycopodium Limited is responsible for the overall corporate governance of the Company and its subsidiary companies (consolidated entity).

1. Summary of Material Accounting Policies

The principal accounting policies adopted in the preparation of this consolidated financial report are set out below.

These policies have been consistently applied to all the years presented, unless otherwise stated. The financial report comprises the financial report for the Company consisting of Lycopodium Limited and its subsidiaries.

(a) Basis of Preparation

This general purpose financial report has been prepared in accordance with Australian Accounting Standards and Interpretations issued by the Australian Accounting Standards Board and the Corporations Act 2001. Lycopodium Limited is a for-profit entity for the purpose of preparing the financial report. The consolidated financial report of Lycopodium Limited and its subsidiaries complies with International Financial Reporting Standards (IFRS) as issued by the International Accounting Standards Board (IASB).

All amounts have been presented in Australian dollars, rounded to the nearest thousand dollars (\$'000) unless otherwise stated.

(i) New or Amended Accounting Standards and Interpretations Adopted

The consolidated entity has adopted all of the new or amended Accounting Standards and Interpretations issued by the Australian Accounting Standards Board ('AASB') that are mandatory for the current reporting period.

Any new or amended Accounting Standards or Interpretations that are not yet mandatory have not been early adopted.

(ii) Historical Cost Convention

These financial statements have been prepared under the historical cost convention, as modified by the measurement of financial assets/liabilities at fair value through profit and loss.

(iii) Critical Accounting Estimates

The preparation of the financial report requires the use of certain critical accounting estimates. It also requires management to exercise its judgement in the process of applying the consolidated entity's accounting policies. The areas involving a higher degree of judgement or complexity, or areas where assumptions and estimates are significant to the financial report, are disclosed in note 3.

(b) Principles of Consolidation

(i) Subsidiaries

Subsidiaries are all entities (including structured entities) over which the consolidated entity has control. The consolidated entity controls an entity when the consolidated entity is exposed to, or has rights to, variable returns from its involvement with the entity and has the ability to affect those returns through its power to direct the activities of the entity. Subsidiaries are fully consolidated from the date on which control is transferred to the consolidated entity. They are deconsolidated from the date that control ceases.

The acquisition method of accounting is used to account for business combinations by the consolidated entity (refer to note 1(h)).

Intercompany transactions, balances and unrealised gains on transactions between entities in the consolidated entity are eliminated. Unrealised losses are also eliminated unless the transaction provides evidence of the impairment of the asset transferred. Accounting policies of subsidiaries have been changed where necessary to ensure consistency with the policies adopted by the consolidated entity.

Non-controlling interests in the results and equity of subsidiaries are shown separately in the Consolidated Statement of Comprehensive Income, Consolidated Statement of Changes in Equity and Consolidated Statement of Financial Position, respectively.

(ii) Employee Share Trust

The consolidated entity has formed a trust to administer the consolidated entity's employee share scheme. This trust is consolidated, as the substance of the relationship is that the trust is controlled by the consolidated entity.

(iii) Joint Arrangements

Under AASB 11 Joint Arrangements investments in joint arrangements are classified as either joint operations or joint ventures. The classification depends on the contractual rights and obligations of each investor, rather than the legal structure of the joint arrangement. Lycopodium Limited has joint venture arrangements.

(iv) Joint Ventures

Interests in joint ventures are accounted for using the equity method (see (vi) below), after initially being recognised at cost in the Consolidated Statement of Financial Position.

(v) Associates

Associates are all entities over which the consolidated entity has significant influence but not control or joint control. This is generally the case where the consolidated entity holds between 20% and 50% of the voting rights. Investments in associates are accounted for using the equity method of accounting (see (vi) below), after initially being recognised at cost.

(vi) Equity Method

Under the equity method of accounting, the investments are initially recognised at cost and adjusted thereafter to recognise the consolidated entity's share of the post-acquisition profits or losses of the investee, and the consolidated entity's share of movements in other comprehensive income of the investee. Dividends received or receivable from associates and joint ventures are recognised as a reduction in the carrying amount of the investment.

When the consolidated entity's share of losses in an equity-accounted investment equals or exceeds its interest in the entity, including any other unsecured long-term receivables, the consolidated entity does not recognise further losses, unless it has incurred obligations or made payments on behalf of the other entity.

Unrealised gains on transactions between the consolidated entity and its associates and joint ventures are eliminated to the extent of the consolidated entity's interest in these entities. Unrealised losses are also eliminated unless the transaction provides evidence of an impairment of the asset transferred. Accounting policies of equity-accounted investees have been changed where necessary to ensure consistency with the policies adopted by the consolidated entity.

(vii) Changes in Ownership Interests

The consolidated entity treats transactions with non-controlling interests that do not result in a loss of control as transactions with equity owners of the consolidated entity. A change in ownership interest results in an adjustment between the carrying amounts of the controlling and non-controlling interests to reflect their relative interests in the subsidiary. Any difference between the amount of the adjustment to non-controlling interests and any consideration paid or received is recognised in a separate reserve within equity attributed to owners of Lycopodium Limited.

When the consolidated entity ceases to have control, joint control or significant influence, any retained interest in the entity is remeasured to its fair value with the change in carrying amount recognised in profit or loss. The fair value becomes the initial carrying amount for the purposes of subsequently accounting for the retained interest as an associate, joint venture or financial asset. In addition, any amounts previously recognised in other comprehensive income in respect of that entity are accounted for as if the consolidated entity had directly disposed of the related assets or liabilities. This may mean that amounts previously recognised in other comprehensive income are reclassified to profit or loss.

If the ownership interest in a joint venture or an associate is reduced but joint control or significant influence is retained, only a proportionate share of the amounts previously recognised in other comprehensive income are reclassified to profit or loss where appropriate.

(c) Segment Reporting

Operating segments are reported in a manner consistent with the internal reporting provided to the chief operating decision maker. The chief operating decision maker, who is responsible for allocating resources and assessing performance of the operating segments, has been identified as the Board of Directors.

(d) Revenue and Other Income Recognition

Revenue from Contracts with Customers

The consolidated entity recognises revenue on an 'over time' basis. This applies to the two services of which the consolidated entity provides:

- Engineering and related services
- Construction contracts

To determine whether to recognise revenue, the consolidated entity follows a five-step process:

- (1) Identifying the contract with a customer
- (2) Identifying the performance obligations
- (3) Determining the transaction price
- (4) Allocating the transaction price to the performance obligations
- (5) Recognising revenue when/as performance obligation(s) are satisfied

For work being performed in the completion of contracts with fixed prices, the customer controls the assets as it is created or enhanced. Progress towards completion of the contract is measured according to the proportion of contract costs incurred for work performed to date relative to the estimate total contract costs.

When it is probable that total contract costs will exceed total contract revenue, the expected loss is recognised as an expense immediately.

Where recognised revenues exceed progress billings, the surplus is shown in Contract Assets. For contracts where progress billings exceed recognised revenues, the surplus is shown as Contract Liabilities.

Certain customer contracts are man-hours and expense based. In these circumstances, revenue is recognised over time as the consolidated entity has a right to consideration from the customer in an amount that corresponds directly with the value to the customer of the entity's performance completed at the time of billing. The consolidated entity therefore recognises revenue in the amount to which the consolidated entity has the right to invoice.

Variable consideration within the transaction price, if any, reflects concessions provided to the customer such as discounts, rebates and refunds, any potential bonuses receivable from the customer and any other contingent events. Such estimates are determined using either the 'expected value' or 'most likely amount' method. The measurement of variable consideration is subject to a constraining principle whereby revenue will only be recognised to the extent that it is highly probable that a significant reversal in the amount of cumulative revenue recognised will not occur. The measurement constraint continues until the uncertainty associated with the variable consideration is subsequently resolved. Amounts received that are subject to the constraining principle are recognised as a refund liability.

Interest

Interest revenue is recognised on an accrual basis.

Dividend

Dividend income is recognised when the dividend is declared.

Rental Income

Rental income is recognised on a straight line basis over the term of the operating lease.

(e) Foreign Currency Translation

(i) Functional and Presentation Currency

Items included in the financial report of each of the consolidated entity's entities are measured using the currency of the primary economic environment in which the entity operates ('the functional currency'). The Consolidated financial report is presented in Australian dollars, which is Lycopodium Limited's functional and presentation currency.

(ii) Transactions and Balances

Foreign currency transactions are translated into the functional currency using the exchange rates prevailing at the dates of the transactions. Foreign exchange gains and losses resulting from the settlement of such transactions and from the translation at year end exchange rates of monetary assets and liabilities denominated in foreign currencies are recognised in profit and loss.

Translation differences on financial assets and liabilities carried at fair value are reported as part of the fair value gain or loss. Translation differences on non-monetary assets and liabilities such as equities held at fair value through profit or loss are recognised in profit or loss as part of the fair value gain or loss. Translation differences on non-monetary assets such as equities classified as available-for-sale financial assets are recognised in other comprehensive income.

(iii) Consolidated Entities

The results and financial position of foreign operations that have a functional currency different from the consolidated entity's presentation currency are translated into the presentation currency as follows:

- Assets and liabilities for each Statement of Financial Position presented are translated at the closing exchange rate at the reporting date.
- Income and expenses for each Statement of Comprehensive Income are translated at average exchange rates for the period unless this is not a reasonable approximation of the cumulative effect of rates prevailing at the transaction dates, in which case income and expenses are translated at the rates at the dates of the transactions.
- All resulting exchange differences are recognised in other comprehensive income.

For foreign operations whose functional currency is the currency of a hyperinflationary economy, the financial statements are first restated in accordance with AASB 129 Financial Reporting in Hyperinflationary Economies before being translated into the Group's presentation currency. Where the Group has determined that the functional currency of a hyperinflationary foreign operation is any non-hyperinflationary currency, transactions, balances and results are measured in that functional currency before translation into the consolidated entity's presentation currency in accordance with the consolidated entity's foreign currency translation policies.

On consolidation, exchange differences arising from the translation of any net investment in foreign operations, and of borrowings and other financial instruments designated as hedges of such investments, are recognised in other comprehensive income. When a foreign operation is sold, or borrowings forming part of the net investment are repaid, the associated exchange differences are recognised in profit or loss as part of the gain or loss on disposal, where applicable.

(f) Income Tax

The income tax expense or credit for the year is the tax payable on the current year's taxable income based on the applicable income tax rate for each jurisdiction adjusted by changes in deferred tax assets and liabilities attributable to temporary differences and to unused tax losses.

The current income tax charge is calculated on the basis of the tax laws enacted or substantively enacted at the end of the reporting year in the countries where the Company and its subsidiaries and associates operate and generate taxable income. Management periodically evaluates positions taken in tax returns with respect to situations in which applicable tax regulation is subject to interpretation. It establishes provisions where appropriate on the basis of amounts expected to be paid to the tax authorities.

Deferred income tax is provided in full, using the liability method, on temporary differences arising between the tax bases of assets and liabilities and their carrying amounts in the consolidated financial report. However, deferred tax liabilities are not recognised if they arise from the initial recognition of goodwill. Deferred income tax is also not accounted for if it arises from initial recognition of an asset or liability in a transaction other than a business combination that at the time of the transaction affects neither accounting nor taxable profit or loss. Deferred income tax is determined using tax rates (and laws) that have been enacted or substantively enacted by the end of the reporting year and are expected to apply when the related deferred income tax asset is realised or the deferred income tax liability is settled.

Deferred tax assets are recognised only if it is probable that future taxable amounts will be available to utilise those temporary differences and losses.

Deferred tax liabilities and assets are not recognised for temporary differences between the carrying amount and tax bases of investments in foreign operations where the consolidated entity is able to control the timing of the reversal of the temporary differences and it is probable that the differences will not reverse in the foreseeable future.

Deferred tax assets and liabilities are offset when there is a legally enforceable right to offset current tax assets and liabilities and when the deferred tax balances relate to the same taxation authority. Current tax assets and tax liabilities are offset where the entity has a legally enforceable right to offset and intends either to settle on a net basis, or to realise the asset and settle the liability simultaneously.

Lycopodium Limited and its wholly-owned Australian controlled entities have implemented the tax consolidation legislation effective 1 July 2013. As a consequence, these entities are taxed as a single entity and the deferred tax assets and liabilities of these entities are set off in the consolidated financial report.

Current and deferred tax is recognised in profit or loss, except to the extent that it relates to items recognised in other comprehensive income or directly in equity. In this case, the tax is also recognised in other comprehensive income or directly in equity, respectively.

(g) Right-of-Use Assets

A right-of-use asset is recognised at the commencement date of a lease. The right-of-use asset is measured at cost, which comprises the initial amount of the lease liability, adjusted for, as applicable, any lease payments made at or before the commencement date net of any lease incentives received, any initial direct costs incurred, and, except where included in the cost of inventories, an estimate of costs expected to be incurred for dismantling and removing the underlying asset, and restoring the site or asset.

Right-of-use assets are depreciated on a straight-line basis over the unexpired period of the lease or the estimated useful life of the asset, whichever is the shorter. Where the consolidated entity expects to obtain ownership of the leased asset at the end of the lease term, the depreciation is over its estimated useful life. Right-of-use assets are subject to impairment or adjusted for any remeasurement of lease liabilities.

The consolidated entity has elected not to recognise a right-of-use asset and corresponding lease liability for short-term leases with terms of 12 months or less and leases of low-value assets. Lease payments on these assets are expensed to profit or loss as incurred.

(h) Business Combinations

The acquisition method of accounting is used to account for all business combinations, regardless of whether equity instruments or other assets are acquired. The consideration transferred for the acquisition of a subsidiary comprises the fair values of the assets transferred, the liabilities incurred, and the equity interests issued by the consolidated entity. The consideration transferred also includes the fair value of any asset or liability resulting from a contingent consideration arrangement and the fair value of any pre-existing equity interest in the subsidiary. Acquisition-related costs are expensed as incurred. Identifiable assets acquired and liabilities and contingent liabilities assumed in a business combination are, with limited exceptions, measured initially at their fair values at the acquisition-date. On an acquisition- by-acquisition basis, the consolidated entity recognises any non-controlling interest in the acquiree either at fair value or at the non-controlling interest's proportionate share of the acquiree's net identifiable assets.

The excess of the consideration transferred and the amount of any non-controlling interest in the acquiree over the fair value of the net identifiable assets acquired is recorded as goodwill. If those amounts are less than the fair value of the net identifiable assets of the subsidiary acquired and the measurement of all amounts has been reviewed, the difference is recognised directly in profit or loss as a bargain purchase.

Where settlement of any part of cash consideration is deferred, the amounts payable in the future are discounted to their present value as at the date of exchange. The discount rate used is the entity's incremental borrowing rate, being the rate at which a similar borrowing could be obtained from an independent financier under comparable terms and conditions.

Contingent consideration is classified either as equity or a financial liability. Amounts classified as a financial liability are subsequently remeasured to fair value with changes in fair value recognised in profit or loss.

(i) Impairment of Assets

Goodwill and intangible assets that have an indefinite useful life are not subject to amortisation and are tested annually for impairment, or more frequently if events or changes in circumstances indicate that they might be impaired. Other assets are tested for impairment whenever events or changes in circumstances indicate that the carrying amount may not be recoverable. An impairment loss is recognised for the amount by which the asset's carrying amount exceeds its recoverable amount. The recoverable amount is the higher of an asset's fair value less costs of disposal and value in use. For the purposes of assessing impairment, assets are grouped at the lowest levels for which there are separately identifiable cash inflows which are largely independent of the cash inflows from other assets or group of assets (cash-generating units). Non-financial assets other than goodwill that suffered an impairment are reviewed for possible reversal of the impairment at the end of each reporting year.

(j) Current and Non-Current Classification

Assets and liabilities are presented in the statement of financial position based on current and non-current classification.

An asset is classified as current when: it is either expected to be realised or intended to be sold or consumed in the consolidated entity's normal operating cycle; it is held primarily for the purpose of trading; it is expected to be realised within 12 months after the reporting period; or the asset is cash or cash equivalent unless restricted from being exchanged or used to settle a liability for at least 12 months after the reporting period. All other assets are classified as non-current.

A liability is classified as current when: it is either expected to be settled in the consolidated entity's normal operating cycle; it is held primarily for the purpose of trading; it is due to be settled within 12 months after the reporting period; or there is no unconditional right to defer the settlement of the liability for at least 12 months after the reporting period. All other liabilities are classified as non-current.

Deferred tax assets and liabilities are always classified as non-current.

(k) Cash and Cash Equivalents

For Statement of Cash Flow presentation purposes, cash and cash equivalents includes cash on hand, deposits held at call with financial institutions, other short-term, highly liquid investments with original maturities of three months or less that are readily convertible to known amounts of cash and which are subject to an insignificant risk of changes in value, and bank overdrafts.

(l) Trade Receivables and Other Receivables

Trade receivables are recognised initially at fair value and subsequently measured at amortised cost using the effective interest method, less expected credit loss. Trade receivables are generally due for settlement within 30 days.

Collectability of trade receivables is reviewed on an ongoing basis. Debts which are known to be uncollectible are written off by reducing the carrying amount directly. An allowance account (expected credit loss on trade receivables) is used when there is objective evidence that the consolidated entity will not be able to collect all amounts due according to the original terms of the receivables. Significant financial difficulties of the debtor, probability that the debtor will enter bankruptcy or financial reorganisation, and default or delinquency in payments (more than 30 days overdue) are considered indicators that the trade receivable is impaired. The amount of the impairment allowance is the difference between the asset's carrying amount and the present value of estimated future cash flows, discounted at the original effective interest rate. Cash flows relating to short-term receivables are not discounted if the effect of discounting is immaterial.

The amount of the impairment loss is recognised in the Consolidated Statement of Profit and Loss and Other Comprehensive Income within 'other expenses'. When a trade receivable for which an impairment allowance had been recognised becomes uncollectible in a subsequent period, it is written off against the allowance account. Subsequent recoveries of amounts previously written off are credited against 'other expenses' in the Consolidated Statement of Profit and Loss and Other Comprehensive Income.

Other receivables are recognised at amortised cost, less any allowance for expected credit losses.

(m) Contract Assets

Contract assets are recognised when the consolidated entity has transferred goods or services to the customer but where the consolidated entity is yet to establish an unconditional right to consideration. Contract assets are treated as financial assets for impairment purposes.

(n) Customer Acquisition Costs

Customer acquisition costs are capitalised as an asset where such costs are incremental to obtaining a contract with a customer and are expected to be recovered. Customer acquisition costs are amortised on a straight-line basis over the term of the contract.

Costs to obtain a contract that would have been incurred regardless of whether the contract was obtained or which are not otherwise recoverable from a customer are expensed as incurred to profit or loss. Incremental costs of obtaining a contract where the contract term is less than one year is immediately expensed to profit or loss.

(o) Customer Fulfilment Costs

Customer fulfilment costs are capitalised as an asset when all the following are met: (i) the costs relate directly to the contract or specifically identifiable proposed contract; (ii) the costs generate or enhance resources of the consolidated entity that will be used to satisfy future performance obligations; and (iii) the costs are expected to be recovered. Customer fulfilment costs are amortised on a straight-line basis over the term of the contract.

(p) Inventories

Raw materials, work in progress and finished goods are stated at the lower of cost and net realisable value on a 'first in first out' basis. Cost comprises of direct materials and delivery costs, direct labour, import duties and other taxes, an appropriate proportion of variable and fixed overhead expenditure based on normal operating capacity and where applicable, transfers from cash flow hedging reserves in equity. Costs of purchased inventory are determined after deducting rebates and discounts received or receivable.

Stock in transit is stated at the lower of cost and net realisable value. Cost comprises purchase and delivery costs, net of rebates and discounts received or receivable.

Net realisable value is the estimated selling price in the ordinary course of business less the estimated costs of completion and the estimated costs necessary to make the sale.

(q) Non-Derivative Financial Assets

(i) Classification

The consolidated entity classifies its financial assets in the following measurement categories:

- Those to be measured subsequently at fair value (either through other comprehensive income, or through profit or loss).
- Those to be measured at amortised cost.

The classification depends on the consolidated entity's business model for managing financial assets and the contractual terms of the cashflows.

For assets measured at fair value, gains and losses will either be recorded in profit or loss or other comprehensive income. For Investments in equity instruments that are not held for trading, this will depend on whether the consolidated entity has made an irrevocable election at the time of initial recognition to account for the equity investment at fair value through other comprehensive income. For investments in debt instruments, this will depend on the business model in which the investment is held. The consolidated entity reclassifies debt investments when its business model for managing those assets changes.

(ii) Measurement

At initial recognition, the consolidated entity measures a financial asset at its fair value plus, in the case of a financial asset not at fair value through profit or loss, transaction costs that are directly attributable to the acquisition of the financial asset. Transaction costs of financial assets carried at fair value through profit or loss are expensed in profit or loss. Measurement of cash and cash equivalents and trade and other receivables remains at amortised cost consistent with the comparative period.

Debt Instruments

Subsequent measurement of debt instruments depends on the consolidated entity's business model for managing the asset and the cash flow characteristics of the asset. There are three measurement categories which the consolidated entity classifies its debt instruments:

- **Amortised cost:** Assets that are held for collection of contractual cash flows, where those cash flows represent solely payments of principal and interest are measured at amortised cost. A gain or loss on a debt investment that is subsequently measured at amortised cost and is not part of a hedging relationship is recognised in profit or loss when the asset is derecognised or impaired. Interest income from these financial assets is included in finance income using the effective interest rate method.
- **Fair value through other comprehensive income (FVOCI):** Assets that are held for collecting contractual cash flows and through sale on specified dates. A gain or loss on a debt investment that is subsequently measured at FVOCI is recognised in other comprehensive income. None are currently held by the consolidated entity.
- **Fair value through profit or loss (FVPL):** Assets that do not meet the criteria for amortised cost or FVOCI are measured at fair value through profit or loss. A gain or loss on a debt investment that is subsequently measured at fair value through profit or loss and is not part of a hedging relationship is recognised in profit or loss and presented net in the statement of profit or loss within other gains/(losses) in the period in which it arises. None are currently held by the consolidated entity.

Equity Instruments

The consolidated entity subsequently measures all equity investments at fair value. Where the consolidated entity's management has elected to present fair value gains and losses on equity investments in other comprehensive income, there is no subsequent reclassification of fair value gains and losses to profit or loss following the derecognition of the investment. Dividends from such investments continue to be recognised in profit or loss as other income when the consolidated entity's right to receive payments is established. Impairment losses (and reversal of impairment losses) on equity investments measured at FVOCI are not reported separately from other changes in fair value. Changes in the fair value of financial assets at fair value through profit or loss are recognised either in other income or in other expenses in the statement of profit or loss.

(iii) Impairment

The consolidated entity assesses on a forward-looking basis the expected credit losses associated with its debt instruments carried at amortised cost and FVOCI. The impairment methodology applied depends on whether there has been a significant increase in credit risk.

For trade receivables and other receivables, the consolidated entity applies the simplified approach permitted by AASB 9, which requires expected lifetime losses to be recognised from initial recognition of the receivables.

(r) Non-Derivative Financial Liabilities

Interest Bearing Liabilities

All loans and borrowings are initially recognised at fair value, being the amount received less attributable transaction costs. After initial recognition, interest bearing liabilities are stated at amortised cost with any difference between cost and redemption value being recognised in the statement of profit or loss over the period of the borrowings on an effective interest basis.

Trade and Other Payables

Liabilities are recognised for amounts to be paid for goods or services received. Trade payables are settled on terms aligned with the normal commercial terms in the consolidated entity's countries of operation.

These amounts represent liabilities for goods and services provided to the consolidated entity prior to the end of the financial year which are unpaid. Due to their short-term nature, they are measured at amortised cost and are not discounted. The amounts are unsecured and are usually paid within 30 days of recognition.

(s) Contract Liabilities

Contract liabilities represent the consolidated entity's obligation to transfer goods or services to a customer and are recognised when a customer pays consideration, or when the consolidated entity recognises a receivable to reflect its unconditional right to consideration (whichever is earlier) before the consolidated entity has transferred the goods or services to the customer.

(t) Borrowings

Loans and borrowings are initially recognised at the fair value of the consideration received, net of transaction costs. They are subsequently measured at amortised cost using the effective interest method.

(u) Lease Liabilities

A lease liability is recognised at the commencement date of a lease. The lease liability is initially recognised at the present value of the lease payments to be made over the term of the lease, discounted using the interest rate implicit in the lease or, if that rate cannot be readily determined, the consolidated entity's incremental borrowing rate. Lease payments comprise of fixed payments less any lease incentives receivable, variable lease payments that depend on an index or a rate, amounts expected to be paid under residual value guarantees, exercise price of a purchase option when the exercise of the option is reasonably certain to occur, and any anticipated termination penalties. The variable lease payments that do not depend on an index or a rate are expensed in the period in which they are incurred.

Lease liabilities are measured at amortised cost using the effective interest method. The carrying amounts are remeasured if there is a change in the following: future lease payments arising from a change in an index or a rate used; residual guarantee; lease term; certainty of a purchase option and termination penalties. When a lease liability is remeasured, an adjustment is made to the corresponding right-of-use asset, or to profit or loss if the carrying amount of the right-of-use asset is fully written down.

(v) Finance Costs

Finance costs attributable to qualifying assets are capitalised as part of the asset. All other finance costs are expensed in the period in which they are incurred.

(w) Derivative Financial Instruments

Derivative financial instruments are stated at fair value, with changes in fair value recognised in the statement of profit or loss. Where derivative financial instruments qualify for hedge accounting, recognition of changes in fair value depends on the nature of the item being hedged. Hedge accounting is discontinued when the hedging relationship is revoked, the hedging instrument expires, is sold, terminated, exercised, or no longer qualifies for hedge accounting.

The consolidated entity documents at the inception of the hedging transaction the economic relationship between hedging instruments and hedged items including whether the instrument is expected to offset changes in cash flows of hedged items. The consolidated entity documents its risk management objective and strategy for undertaking various hedge transactions at the inception of each hedge relationship.

Cash Flow Hedge

The effective portion of changes in the fair value of derivatives that are designated and qualify as cash flow hedges is recognised in the cash flow hedge reserve within equity, limited to the cumulative change in fair value of the hedged item on a present value basis from the inception of the hedge. The gain or loss relating to the ineffective portion is recognised immediately in profit or loss, within other expenses.

When option contracts are used to hedge forecast transactions, the consolidated entity designates only the intrinsic value of the option contract as the hedging instrument. Gains or losses relating to the effective portion of the change in intrinsic value of the option contracts are recognised in the cash flow hedge reserve in equity. The changes in the time value of the option contracts that relate to the hedged item ('aligned time value') are recognised within other comprehensive income in the costs of hedging reserve within equity.

When forward contracts are used to hedge forecast transactions, the consolidated entity generally designates only the change in fair value of the forward contract related to the spot component as the hedging instrument. Gains or losses relating to the effective portion of the change in the spot component of the forward contracts are recognised in the cash flow hedge reserve in equity. The change in the forward element of the contract that relates to the hedged item is recognised within other comprehensive income in the costs of hedging reserve within equity. In some cases, the entity may designate the full change in fair value of the forward contract (including forward points) as the hedging instrument. In such cases, the gains or losses relating to the effective portion of the change in fair value of the entire forward contract are recognised in the cash flow hedge reserve within equity.

Amounts accumulated in equity are reclassified in the periods when the hedged item affects profit or loss, as follows:

- The gain or loss relating to the effective portion of forward and option contracts are ultimately recognised in profit or loss as the hedged item affects profit or loss within expenses.
- The gain or loss relating to the effective portion of the interest rate swaps hedging variable rate borrowings is recognised in profit or loss within 'finance cost'.

When a hedging instrument expires, or is sold or terminated, or when a hedge no longer meets the criteria for hedge accounting, any cumulative deferred gain or loss and deferred costs of hedging in equity at that time remains in equity until the forecast transaction occurs, resulting in the recognition of a non-financial asset such as inventory. When the forecast transaction is no longer expected to occur, the cumulative gain or loss and deferred costs of hedging that were reported in equity are immediately reclassified to profit or loss. Hedge ineffectiveness is recognised in profit or loss within other expenses.

(x) Property, Plant and Equipment

Property, plant and equipment is stated at historical cost less depreciation. Historical cost includes expenditure that is directly attributable to the acquisition of the items.

Subsequent costs are included in the asset's carrying amount or recognised as a separate asset, as appropriate, only when it is probable that future economic benefits associated with the item will flow to the consolidated entity and the cost of the item can be measured reliably. The carrying amount of any component accounted for as a separate asset is derecognised when replaced. All other repairs and maintenance are charged to profit or loss during the reporting year in which they are incurred.

Depreciation on plant and equipment is calculated using the straight line or diminishing value method to allocate their cost, net of their residual values, over their estimated useful lives, as follows:

The assets' residual values and useful lives are reviewed, and adjusted if appropriate, at the end of each reporting year.

An asset's carrying amount is written down immediately to its recoverable amount if the asset's carrying amount is greater than its estimated recoverable amount (note 1(i)).

Gains and losses on disposals are determined by comparing proceeds with carrying amount. These are included in the profit and loss.

(y) Intangible Assets

(i) Goodwill

Goodwill is measured as described in note 1(h). Goodwill on acquisitions of subsidiaries is included in intangible assets. Goodwill is not amortised but it is tested for impairment annually, or more frequently if events or changes in circumstances indicate that it might be impaired, and is carried at cost less accumulated impairment losses. Gains and losses on the disposal of an entity include the carrying amount of goodwill relating to the entity sold.

Goodwill is allocated to cash-generating units for the purpose of impairment testing. The allocation is made to those cash-generating units or groups of cash-generating units that are expected to benefit from the business combination in which the goodwill arose, identified according to operating segments (note 4).

(ii) Software

Intangible assets also comprise capitalised computer software. Computer software has a finite useful life and is carried at cost less accumulated amortisation. Amortisation is calculated using the straight-line method to allocate the cost of the computer software over their estimated useful lives, being three years.

(z) Borrowing Costs

General and specific borrowing costs that are directly attributable to the acquisition, construction or production of a qualifying asset are capitalised during the year of time that is required to complete and prepare the asset for its intended use or sale. Qualifying assets are assets that necessarily take a substantial year of time to get ready for their intended use or sale.

Other borrowing costs are expensed in the year in which they are incurred.

(aa) Provisions

Provisions for legal claims, service warranties and make good obligations are recognised when the consolidated entity has a present legal or constructive obligation as a result of past events, it is probable that an outflow of resources will be required to settle the obligation and the amount can be reliably estimated. Provisions are not recognised for future operating losses.

Where there are a number of similar obligations, the likelihood that an outflow will be required in settlement is determined by considering the class of obligations as a whole. A provision is recognised even if the likelihood of an outflow with respect to any one item included in the same class of obligations may be small.

Provisions are measured at the present value of management's best estimate of the expenditure required to settle the present obligation at the end of the reporting year. The discount rate used to determine the present value is a pre-tax rate that reflects current market assessments of the time value of money and the risks specific to the liability. The increase in the provision due to the passage of time is recognised as interest expense.

(ab) Employee Benefits

The obligations are presented as current liabilities in the Consolidated Statement of Financial Position if the entity does not have an unconditional right to defer settlement for at least twelve months after the reporting date, regardless of when the actual settlement is expected to occur.

(i) Short-Term Obligations

Liabilities for wages and salaries, including non-monetary benefits expected to be settled wholly within 12 months after the end of the period in which the employees render the related services are recognised in respect of employees' services up to the end of the reporting period and are measured at the amounts expected to be paid when the liabilities are settled. All other short-term employee benefit obligations are presented as payables.

The liability for long service leave and annual leave which is not expected to be settled wholly within 12 months after the end of the period in which the employees render the related service is therefore recognised in the provision for employee benefits and measured as the present value of expected future payments to be made in respect of services provided by employees

up to the end of the reporting period using the projected unit credit method. Consideration is given to expected future wage and salary levels, experience of employee departures and periods of service. Expected future payments are discounted using market yields at the end of the reporting period of high-quality corporate bonds with terms and currency that match, as closely as possible, the estimated future cash outflows. Re-measurement as a result of experience adjustments and changes in actuarial assumptions are recognised in profit or loss.

(ii) Retirement Benefit Obligations

Contributions to defined contribution funds are recognised as an expense as they become payable. Prepaid contributions are recognised as an asset to the extent that a cash refund or a reduction in the future payments is available.

(iii) Share-Based Payments

Share-based compensation benefits are provided to certain Executive Directors and other designated employees via the Performance Rights Plans. Information relating to this scheme is set out in note 36.

The fair value of rights granted under the Performance Rights Plans are recognised as an employee benefit expense with a corresponding increase in equity. The fair value is measured at grant date and recognised over the period during which the employees become unconditionally entitled to the rights.

The fair value at grant date is independently determined using a Binomial Tree option pricing model that takes into account the exercise price, the term of the rights, the vesting and performance criteria, the impact of dilution, the non-tradeable nature of the rights, the share price at grant date and expected price volatility of the underlying share, the expected dividend yield and the risk-free interest rate for the term of the rights.

(iv) Loan Funded Share Plan

A limited recourse loans was provided to eligible employees of the Company or such other persons as the Board determines. A broad outline of the plan is summarised below:

- The Company will loan funds to participating employees to purchase Lycopodium Limited shares.
- The loan will be a limited recourse loan provided the employee stays with the Company for greater than three years.
- During the term of the loan, dividends will be offset against the outstanding loan balance.

The Company has the following as the result of this transaction:

Share Based Payment

The difference between the value of the shares purchased and the value of the shares allocated to participating employees represents the cost to the Company for providing the loan to the employees. This amount is expensed in the profit and loss upon vesting.

Loan Funded Shares

The loan funded shares purchased by the eligible employee are classified as a reduction in equity as at the reporting date.

(v) Defined Contribution Superannuation Expense

Contributions to defined contribution superannuation plans are expensed in the period in which they are incurred.

(ac) Issued Capital

Ordinary shares are classified as equity. Incremental costs directly attributable to the issue of new shares are shown in equity as a deduction, net of tax, from the proceeds.

(ad) Dividends

Provision is made for the amount of any dividend declared, being appropriately authorised and no longer at the discretion of the entity, on or before the end of the reporting year but not distributed at the end of the reporting year.

(ae) Earnings Per Share

(i) Basic Earnings Per Share

Basic earnings per share is calculated by dividing:

- the profit attributable to owners of the Company, excluding any costs of servicing equity other than ordinary shares
- by the weighted average number of ordinary shares outstanding during the financial year, adjusted for bonus elements in ordinary shares issued during the year.

(ii) Diluted Earnings Per Share

Diluted earnings per share adjusts the figures used in the determination of basic earnings per share to take into account:

- the after income tax effect of interest and other financing costs associated with dilutive potential ordinary shares, and
- the weighted average number of additional ordinary shares that would have been outstanding assuming the conversion of all dilutive potential ordinary shares.

(af) Goods and Services Tax (GST)

Revenues, expenses and assets are recognised net of the amount of associated GST, unless the GST incurred is not recoverable from the taxation authority. In this case it is recognised as part of the cost of acquisition of the asset or as part of the expense.

Receivables and payables are stated inclusive of the amount of GST receivable or payable. The net amount of GST recoverable from, or payable to, the taxation authority is included with other receivables or payables in the Consolidated Statement of Financial Position.

Cash flows are presented on a gross basis. The GST components of cash flows arising from investing or financing activities which are recoverable from, or payable to the taxation authority, are presented as operating cash flows.

Commitments and contingencies are disclosed net of the amount of GST recoverable from, or payable to, the tax authority.

(ag) Fair Value Measurement

When an asset or liability, financial or non-financial, is measured at fair value for recognition or disclosure purposes, the fair value is based on the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date; and assumes that the transaction will take place either: in the principal market; or in the absence of a principal market, in the most advantageous market.

Fair value is measured using the assumptions that market participants would use when pricing the asset or liability, assuming they act in their economic best interests. For non-financial assets, the fair value measurement is based on its highest and best use. Valuation techniques that are appropriate in the circumstances and for which sufficient data are available to measure fair value, are used, maximising the use of relevant observable inputs and minimising the use of unobservable inputs.

Assets and liabilities measured at fair value are classified into three levels, using a fair value hierarchy that reflects the significance of the inputs used in making the measurements. Classifications are reviewed at each reporting date and transfers between levels are determined based on a reassessment of the lowest level of input that is significant to the fair value measurement.

For recurring and non-recurring fair value measurements, external valuers may be used when internal expertise is either not available or when the valuation is deemed to be significant. External valuers are selected based on market knowledge and reputation. Where there is a significant change in fair value of an asset or liability from one period to another, an analysis is undertaken, which includes a verification of the major inputs applied in the latest valuation and a comparison, where applicable, with external sources of data.

(ah) Employee Share Trust

The consolidated entity has in place a trust to administer the consolidated entity's employee share and share rights schemes. This trust is consolidated, as the substance of the relationship is that the trust is controlled by the consolidated entity. Shares held by the Lycopodium Employee Share Trust are disclosed as Treasury shares and deducted from contributed equity.

The movement in treasury shares represent acquisition of the Company's shares on market and allocation of shares to the Company's employees from the vesting of awards and exercise of rights under the employee share-based payment trust.

(ai) Parent Entity Financial Information

The financial information for the parent entity, Lycopodium Limited, disclosed in note 38 has been prepared on the same basis as the consolidated financial report, except as set out below.

(i) Investments in Subsidiaries, Associates and Joint Venture Entities

Investments in subsidiaries, associates and joint venture entities are accounted for at cost in the financial report of Lycopodium Limited. Dividends received from associates are recognised in the parent entity's profit or loss, rather than being deducted from the carrying amount of these investments.

(ii) Share Based Payments

The grant by the Company of rights over its equity instruments to the employees of subsidiary undertakings in the Company is treated as a capital contribution to that subsidiary undertaking. The fair value of employee services received, measured by reference to the grant date fair value, is recognised over the vesting period as an increase to investment in subsidiary undertakings, with a corresponding credit to equity.

2. Financial Risk Management

The consolidated entity manages its exposure to key financial risks, including interest rate and currency risk in accordance with the consolidated entity's financial risk management policy. The objective of the policy is to support the delivery of the consolidated entity's financial targets whilst protecting future financial security.

The main risks arising from the consolidated entity's financial instruments are interest rate risk, foreign currency risk, credit risk and liquidity risk. The consolidated entity uses different methods to measure and manage different types of risks to which it is exposed. These include monitoring levels of exposure to interest rate and foreign exchange risk and assessments of market forecasts for interest rates and foreign exchange. Ageing analyses and monitoring of specific credit allowances are undertaken to manage credit risk, and liquidity risk is monitored through the development of future rolling cash flow forecasts.

The primary responsibility for identification and control of financial risks rests with the Board. The Board reviews and agrees on policies for managing each of the risks identified above.

(a) Market Risk

(i) Foreign Exchange Risk

The consolidated entity operates internationally and is exposed to foreign exchange risk arising from various currency exposures, primarily with respect to the US dollar (USD) and Canadian dollars (CAD). Exchange rate exposures are managed with approved policy parameters utilising forward exchange contracts.

Foreign exchange risk arises when future commercial transactions and recognised financial assets and financial liabilities are denominated in a currency that is not the entity's functional currency.

Equity securities price risk arises from investments in equity securities. The equity investments are publicly traded on the Australian Securities Exchange ("ASX"). The price risk for the listed securities is immaterial in terms of a possible impact on profit and loss or total equity and as such a sensitivity analysis has not been completed. The consolidated entity does not have a risk management policy surrounding price risk in place as the Board considers the risk minimal.

(iii) Interest Rate Risk

The consolidated entity is exposed to interest rate risk arising mainly from borrowings and cash balances held. The risk is considered minimal as the consolidated entity's borrowings are immaterial. The consolidated entity does not enter into any specific swaps or hedges to cover any interest rate volatility and does not have a risk management policy surrounding cash flow and interest rate risk as the Board considers these risks to be minimal.

Sensitivity

At 30 June 2026, if interest rates had changed by +/-50 basis points from the year end rates with all other variables held constant, post-tax profit and equity for the year would have been \$524,000 lower/higher (2025: \$348,000 lower/higher), as a result of lower/higher interest income from cash and cash equivalents.

(b) Credit Risk

Credit risk arises from the financial assets of the consolidated entity, which comprise cash and cash equivalents, trade and other receivables and other current assets. The consolidated entity's exposure to credit risk arises from potential default of the counterparty, with a maximum exposure equal to the carrying amount of these instruments.

Cash and Cash Equivalents

The credit risk on cash and cash equivalents is limited because the consolidated entity's primary bank is rated AA- by an international credit-rating agency.

Trade and Other Receivables

The consolidated entity's exposure to credit risk is influenced mainly by the individual characteristics of each customer. However, management also considers the demographics of the consolidated entity's customer base, including the default risk of the industry and country in which customers operate, as these factors may have an influence on credit risk.

The consolidated entity trades only with recognised, creditworthy third parties, and as such collateral is not requested nor is it the consolidated entity's policy to securitise its trade and other receivables. All receivables at balance date that are neither past due nor impaired comply with the consolidated entity's policy on credit quality.

It is the consolidated entity's policy that all customers who wish to trade on credit terms are subject to credit verification procedures including an assessment of their financial position, past experience and industry reputation.

In addition, receivable balances are monitored on an ongoing basis with the result that the consolidated entity's exposure to bad debts is minimised.

There are no significant concentrations of credit risk within the consolidated entity. The consolidated entity minimises concentrations of credit risk in relation to trade receivables by undertaking transactions with a number of customers that operate predominantly in the mining and extractive industry sector including major operators in the industry and junior/emerging operators. There are multiple contracts with our significant customers, across a number of their subsidiaries and divisions within those subsidiaries and locations.

Deposits Held With Banks

The credit risk on deposits held with banks are limited as they comprise deposits held with banks with high credit ratings assigned by international credit-rating agencies.

(c) Liquidity Risk

3. Critical Accounting Estimates and Assumptions

The consolidated entity makes estimates and assumptions concerning the future. The resulting accounting estimates will, by definition, seldom equal the related actual results. The estimates and assumptions that have a significant risk of causing a material adjustment to the carrying amounts of assets and liabilities within the next financial year are discussed below.

(i) Impairment Testing of Goodwill

The consolidated entity tests annually whether goodwill has suffered any impairment, in accordance with the accounting policy stated in note 1(i). The recoverable amounts of cash-generating units have been determined based on value-in-use calculations. These calculations require the use of assumptions. Refer to note 14 for details of these assumptions and the potential impact of changes to the assumptions.

(ii) Service and Equipment Warranties

In accordance with the accounting policy stated in note 1(aa), the consolidated entity has recognised warranty provisions at the end of the financial year in respect of potential claims for rectification work on some of its EPC contracts. Refer to note 21 in relation to the service warranty provisions provided at period end. The amounts provided takes into account the percentage completion of the project, forecast to complete costs plus any close-out obligations and potential contractual liabilities during the warranty period.

(iii) Fixed-Price Contracts

The consolidated entity uses cost inputs to estimate its revenue from fixed-sum contracts. The stage of completion is measured by reference to the contract costs incurred to date compared to the estimated total costs for the contract.

Significant assumptions are required to estimate the total contract costs and the recoverable variations work that will affect the stage of completion and the contract revenue respectively. In making these estimates, the consolidated entity has relied on experience and the best available information.

(iv) Income tax

The consolidated entity is subject to income taxes in the jurisdictions in which it operates. Significant judgement is required in determining the provision for income tax. There are many transactions and calculations undertaken during the ordinary course of business for which the ultimate tax determination is uncertain. The consolidated entity recognises liabilities for anticipated tax audit issues based on the consolidated entity's current understanding of the tax law. Where the final tax outcome of these matters is different from the carrying amounts, such differences will impact the current and deferred tax provisions in the period in which such determination is made.

(v) Business Combinations – Fair Value of Assets and Liabilities Acquired

Business combinations are initially accounted for on a provisional basis. The fair value of assets acquired, liabilities and contingent liabilities assumed are initially estimated by the consolidated entity taking into consideration all available information at the reporting date. Fair value adjustments on the finalisation of the business combination accounting is retrospective, where applicable, to the period the combination occurred and may have an impact on the assets and liabilities, depreciation and amortisation reported.

4. Segment Information

Management has determined the operating segments based on the reports reviewed by the Board that are used to make strategic decisions.

(a) Description of Segments

Management has determined the operating segments based on the internal reports reviewed by the Board (who are identified as the Chief Operating Decision Maker ("CODM")) that are used to assess performance and allocate resources.

During the period, the Consolidated entity refined its internal reporting structure such that performance is now monitored on a geographic basis. As part of this change, the Group has updated its operating segments and has restated comparative information in accordance with AASB 8 Operating Segments.

The Board assesses the business on a geographic basis and has identified four operating segments; APAC, Africa, Americas and Other, which are reportable operating segments in accordance with the requirements of AASB 8.

Management has determined the operating segments based on the reports reviewed by the Board of Directors that are used to make strategic decisions.

(c) Tax Consolidation

The Company and its 100% owned Australian entities formed a tax consolidated group on 1 July 2013. Members of the tax consolidated group have entered into a tax sharing agreement in order to allocate income tax expense to the wholly owned Australian entities on a pro-rata basis. The agreement provides for the allocation of income tax liabilities between the entities should the head entity default on its tax payment obligations. At balance date, the possibility of default is remote. The head entity of the tax consolidated group is Lycopodium Limited.

Tax Effect Accounting by Members of the Tax Consolidated Group

Members of the tax consolidated group have entered into a tax funding agreement effective from 1 July 2013. The tax funding agreement provides for the allocation of current taxes to members of the tax consolidated group. Deferred taxes are allocated to members of the tax consolidated group in accordance with the group allocation approach, which is consistent with the principles of AASB 112 Income Taxes.

The allocation of taxes under the tax funding agreement is recognised as an increase/(decrease) in the member entities' intercompany accounts with the tax consolidated group head company, Lycopodium Limited. In this regard, the Company has assumed the benefit of tax losses from the member entities as of the balance date. The nature of the tax funding agreement is such that no tax consolidated contributions by or distributions to participant's equity are required.

(b) Key Assumptions Used for Value-in-Use Calculations

The recoverable amount of each CGU within the business segment is determined on the basis of value-in-use (VIU). In the Minerals CGU, our experience and strength in the gold sector and opportunities in sustaining capital works projects underpins the forecast growth both internationally and domestically.

During the year, as a consequence of the SAXUM acquisition, the consolidated entity has a new SAXUM CGU.

The following describes the assumptions on which management has based its cash flow projections when determining value in use:

Growth Rate

The growth rate represents a steady indexation rate which does not exceed management's expectations of the long-term average growth rate for the business in which each CGU operates. The rate applied in the cash flow projection is for Australia 2% (2025: 2%) , Africa 2% (2025: 2%) and for SAXUM 8-10% (2025: n/a).

Discount Rate

For the Australian CGUs, the pre-tax discount rate applied to cash flow projections is 7.67% (2025: 6.54%) and for the Minerals CGUs in Africa CGU, the pre-tax discount rate is 13.39% (2025: 13.96%). Lastly, the pre-tax discount for SAXUM CGU was 13.00% (2025: n/a).

The discount rates mentioned above reflect management's estimate of the time value of money and the consolidated entity's weighted average cost of capital and the risk-free rate.

Cash Flows

Value-in-use calculations use cash flow projections from approved budgets based on past performance and expectations for the future covering a five-year period.

Revenue

The value-in-use model is based on the budget approved by the Board. The forecast budget process was developed based on revenue expectations for the year built around existing customer contracts along with the potential to develop new markets and sustain growth.

Sensitivities

The Board has performed sensitivities around all key assumptions disclosed above. There are no fluctuations to any of the assumptions that could reasonably occur that would cause the recoverable amount of any CGUs to be equivalent to that of the carrying amount of the CGUs' assets.

The recoverable amount of the SAXUM CGU exceeded its carrying amount at 30 June 2026. Sensitivity analysis was performed over the key assumptions used in the value-in-use model. The analysis indicated that the discount rate would need to increase by approximately 8.3%, or forecast revenue growth assumptions would need to be approximately negative 15–20%, for the recoverable amount to equal the carrying value of the CGU. Management therefore considers the SAXUM CGU to have adequate headroom and does not believe that a reasonably possible change in a key assumption would result in an impairment.

(c) Cash Flow Assumptions

Apart from the considerations described in determining the value-in-use of the cash-generating units described above, the Board is not currently aware of any other probable changes that would necessitate changes in its key estimates.

33. SAXUM Acquisition

On 3 July 2025, Lycopodium Limited completed the acquisition of a 60% controlling interest in SAXUM Ingenieria S.A., SAXUM Consultoria e Engenharia Ltda, SAXUM Engineering Pty Ltd and SAXUM Engineering LLC (collectively, SAXUM), for total cash consideration of \$10,783,000. SAXUM is a multi-disciplinary engineering and project management services company, providing services to the mineral processing, cement & lime, manufacturing & infrastructure and oil & gas sectors. The acquisition of the four SAXUM entities has been accounted for as a single business combination, as all entities were negotiated and acquired under one integrated contractual arrangement. The acquisition forms part of the Consolidated entity's strategy to expand its footprint in the Americas.

Key Audit Matters

The Group has recognised total revenue of \$374,019,000 from contracts with customers. As disclosed in note 1(d), these revenues are recognised over time as performance obligations are fulfilled. The Group's construction, engineering and related services contracts comprise both lump sum and cost plus arrangements. For lump sum arrangements, the Group recognises construction contracts, engineering and related services revenue after assessing all factors relevant to each contract, including specifically the following as applicable: • Determination of the stage of completion and measurement of progress towards performance obligations; • Estimation of total contract revenue and costs, including the estimation of cost contingencies; • Determination of contractual entitlement and assessment of the probability of customer approval of variations and acceptance of claims; and • Estimation of project completion date. For cost plus contracts, the Group recognises construction contracts, engineering and related services revenue after assessing the cost of work provided, together with the appropriate profit margin. This area is a key audit matter due to the number and type of estimation events throughout the contract life, the unique nature of individual contract conditions, leading to complex and judgmental revenue recognition from contracts.	Our audit procedures included: • Assessing the appropriateness of the revenue recognition policies applied by the Group against the criteria in the accounting standards; • Assessing contractual terms with customers and testing project revenues and costs incurred against underlying supporting documents; • For lump sum arrangements: ◦ Assessing management's assumptions in determining the stage of completion, total transaction price and total budgeted cost estimate for construction contracts; ◦ Testing the mathematical accuracy of revenue and profit recognised during the year based on the stage of completion for construction contracts; ◦ Reading customers' and subcontractors' correspondence and discussing the progress of projects with project managers for any potential disputes, variation order claims, known technical issues or significant events that would impact the estimated contract costs; ◦ Agreeing progress billings to invoices issued and receipts; ◦ Assessing completion certificates for completed projects; and ◦ Discussing with project personnel and management the rationale for revisions made to budgeted costs and checking supporting documentation; • For cost plus arrangements: ◦ Agreeing invoices issued to timesheets other relevant documentation and bank receipts; ◦ Reading customers' correspondence for any dispute on invoices issued; and ◦ Assessing the completeness of revenue recognised by comparison to project listings; and • Assessing disclosures in the financial report against the results of our testing and the requirements of the accounting standards.

Impairment of goodwill Refer to Note 14 in the financial statements	
The carrying amount of goodwill at 30 June 2026 is \$12,897,000. Management performs an annual impairment test on the recoverability of goodwill as required by Australian Accounting Standards. We determined this area to be a key audit matter as management's assessment of the recoverable amount, determined on a value in use basis, of the cash generating units (CGUs) to which goodwill is allocated involves judgement about the future cash flow projections, expected revenue growth rates and the discount rate.	Our audit procedures included: - Assessing the Group's accounting policy for compliance with the Australian Accounting Standards; - Assessing management's determination that the goodwill should be allocated to the respective CGUs; - Assessing the valuation methodology used to determine the recoverable amount of the assets in the CGUs; - Challenging the reasonableness of key assumptions used in the value-in-use model (VIU), including the future cash flow projections, expected revenue growth rate and discount rate; - Assessing management's sensitivity analysis over the key assumptions used in the VIU; - Checking the mathematical accuracy of the VIU and reconciling input data to supporting documentation; and - Assessing the adequacy of disclosures in the financial statements.

On 3 July 2025, Lycopodium Limited completed the acquisition of a 60% controlling interest in SAXUM Ingenieria S.A., SAXUM Consultoria e Engenharia Ltda, SAXUM Engineering Pty Ltd and SAXUM Engineering LLC (collectively, SAXUM), for total cash consideration of \$10,783,000. The transaction was treated as a business combination in accordance with AASB 3 Business Combinations. The purchase price allocation has resulted in the recognition of intangible assets of \$9,212,000, consisting of customer relationships and goodwill. The acquisition was considered a key audit matter because the accounting for the transaction is complex and involves significant judgments. These include the recognition and valuation of the consideration paid and the determination of the fair value of the assets acquired and liabilities assumed.	Our audit procedures included: - Assessing the Group's accounting policy for compliance with the Australian Accounting Standards; - Reading acquisition agreements to obtain an understanding of the transaction and the related accounting considerations; - Assessing management's application of acquisition accounting, including the determination of control and identification of the acquisition date in accordance with AASB 3 Business Combinations; - Assessing the methods, assumptions and data utilised in determining the fair value of assets and liabilities acquired, including evaluating the work performed by management's experts and the competency and objectivity of the expert; - Testing the determination of consideration paid; - Recalculating the goodwill arising on the acquisition; and - Assessing the adequacy of disclosures in the financial statements.
