The Board of BCI Minerals Limited (ASX:BCI) (“BCI” or “the Company”) has responsibility for corporate governance for the Company and its subsidiaries and has implemented policies, procedures and systems of control with the intent of providing a strong framework and practical means for ensuring good governance outcomes which meet the expectations of all stakeholders.

This Corporate Governance Statement is current as at 18 August 2026 and was approved by the Board of the Company on that date.

This Corporate Governance Statement discloses the extent to which the Company has, during the financial year ended 30 June 2026, followed the recommendations set by the ASX Corporate Governance Council in its publication Corporate Governance Principles and Recommendations Fourth Edition (**Recommendations**). The Company will continue to review its corporate governance framework to ensure it reflects any changes within the Company, or accepted principles and good practice. The Recommendations are not mandatory; however the Company has identified where a recommendation has not been followed during the reporting period, the reasons for doing so and what (if any) alternative governance practices were adopted in lieu of the recommendation.

The Company has adopted a series of corporate governance policies and procedures which provide the written terms of reference for the Company’s corporate governance duties. Bell is the nominee director of AustralianSuper Pty Ltd as trustee for AustralianSuper, which is a substantial shareholder of the Company. Mr. B. O'Donnell (Chair) is not considered to be independent as he is a director of Australian Capital Equity which is associated with the Company's largest shareholder, Wroxby Pty Ltd. During FY26, Mr R. Court provided advisory services to Australian Capital Equity which is associated with the Company's largest shareholder, Wroxby Pty Ltd. The Board does not consider the nature of these services to affect his independence. In line with prior practice, a number of the Company's non-executive Directors have received performance rights from the Company in previous financial years. All performance rights have lapsed or been exercised other than those held by Ms. G. Bell, as shown on page 100 of the Annual Report.
