McGrathNicol Restructuring appointed as Voluntary Administrators to Australian Pacific Coal Limited (ASX:AQC) (Receivers Appointed) (Administrators Appointed) ACN 089 206 986 and the entities listed at Annexure A (collectively the Companies)

Appointment of Voluntary Administrators

McGrathNicol Restructuring announces that Shaun Fraser and Jonathan Henry were appointed voluntary administrators (**Administrators**) of AQC and certain of its subsidiaries listed in Annexure A (**the Companies**) on 24 August 2026 by resolution of the Companies' directors.

The Administrators have assumed control of the Companies' affairs and will undertake an urgent assessment of their financial position and explore available options for their future.

The appointment of the Administrators to the Companies does not impact the Dartbrook Mine sale process which is being managed by the Receivers and Managers. Any enquiries regarding the Dartbrook Mine sale process should be directed to FTI Consulting.

Whilst in Administration, the shares of Australian Pacific Coal Limited will continue to be suspended from trading. The Administrators intend to provide shareholders with updates in due course on the ASX platform.

First statutory meeting of creditors

A first statutory meeting of creditors must be held within eight business days after the administration begins and is expected to take place on Thursday, 3 September 2026. Meeting notices setting out the time and location for the first meeting of creditors will be distributed to the Companies' creditors over the coming days.
