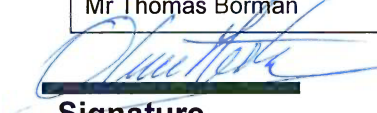

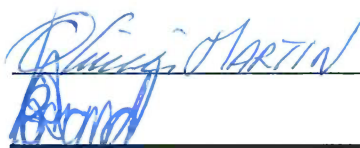

DIRECTIONS
