

Results of Webjet Group 2026 Annual General Meeting

27 August 2026

Webjet Group Limited (ASX: WJL) (Webjet or the Company) advises that its 2026 Annual General Meeting was held today at 2:00pm (Melbourne time) at Level 2, 509 St Kilda Road, Melbourne, Victoria 3004 and virtually via the Automic investor portal.

Resolutions put to the Meeting

Each resolution put to the Meeting was decided on a poll. The resolutions put to the Meeting were as follows:

Item	Resolution
1	Adoption of the Remuneration Report set out in the Annual Report of the Company for the financial year ended 31 March 2026
2	Confirmation of Dr Gary Weiss AM as a Director pursuant to clause 10.11 of the Company's Constitution
3	Approval for the grant of Rights to the Group CEO and Managing Director, Ms Nicole Sheffield, under the Long-Term Incentive Plan
4	Approval of the issue of Shares to Dr Gary Weiss AM under the Non-Executive Director Share Plan

In accordance with ASX Listing Rule 3.13.2 and section 251AA(2) of the *Corporations Act 2001* (Cth), details of the voting results for these resolutions are attached at Appendix 1.

It is noted that more than 25% of the votes cast on resolution 1 (Adoption of the Remuneration Report) were against the resolution. Accordingly, the Company received a "first strike" on its Remuneration Report.

Resolutions not put to the Meeting

Resolutions 5 and 6 set out in the Notice of Meeting were not put to the Meeting. Those resolutions were:

5	Election of Ms. Cinzia Burnes as a Director of the Company — Shareholder Nomination
6	Election of Mr. Andrew Burnes AO as a Director of the Company — Shareholder Nomination

As announced by the Company on 24 August 2026, after market close on Friday, 21 August 2026 the Company was notified by Retail Travel Investments Pty Ltd ACN 094 188 100, a wholly owned subsidiary of Helloworld Travel Limited (ASX: HLO), of its decision to withdraw the nominations of Ms. Cinzia Burnes and Mr. Andrew Burnes AO for election as directors of the Company.

Those nominations were the subject of Resolutions 5 and 6 in the Notice of Meeting. As the nominations had been withdrawn, there was no candidate for election under either resolution and, accordingly, Resolutions 5 and 6 were not put to the Meeting.
