

On-market Share Buyback

28 August 2026. CleanSpace Holdings Limited (ASX: CSX, “CleanSpace” or the “Company”), an Australian company that designs, manufactures, and sells premium respiratory protection solutions for industrial markets, today announces its intention to conduct an on-market buy-back of up to 10% of its issued ordinary shares (**Buy-Back**), in accordance with the terms set out below.

Rationale

The Board considers the Buy-Back to be an efficient use of the Company's capital, while maintaining the Company's ability to fund its operations and growth strategy. The buyback reflects the Board's confidence in the Company's underlying value and prospects.

- The Buy-Back will be conducted in compliance with the Corporations Act 2001 (Cth), ASX Listing Rules (including Appendix 3C) and the Company's Share Trading Policy.
- The Company is not obliged to buy back any shares and may vary, suspend or terminate the Buy-Back at any time without prior notice.
- Shares acquired under the Buy-Back will be cancelled.

- The Buy-Back will not materially affect the Company's ability to pay creditors.
