Forrestania Resources Limited (FRS:ASX) (“Forrestania” or “the Company”) refers to its off-market takeover offer made for 100% of the shares in Zenith Minerals Limited (“**Zenith**”) announced to ASX on 9 June 2026 (“**Offer**”). Pursuant to Section 671B of the *Corporations Act 2001* (Cth) a Form 604 is attached.

Interim Orders

On 30 August 2026 the Takeovers Panel, for the purpose of enabling the matters pertaining to the matters referred to as *Zenith Minerals Limited 01 & 02* to be considered in an orderly manner, amended interim orders made on 2 August 2026 that without the consent of the Takeovers Panel, the Company must not process any further acceptances received in relation to the Offer and must not declare the Offer free from any defeating condition. These interim orders have effect until further orders are provided by the Takeovers Panel, the determination of the proceedings or two months from the orders. Forrestania has now clarified with the Panel that its Interim Orders do not prevent Forrestania from reporting its relevant interest under the Corporations Act.

Zenith Shareholders who wish to accept the Offer can still lodge their acceptance during this time, however Forrestania will not process those acceptances in accordance with those interim orders.
