

CLEANSING NOTICE

Benz Mining Corp. (TSXV: BZ, ASX: BNZ) (**Benz** or the **Company**) gives notice that it has issued 40,431,267 CHESS Depository Interests (**CDIs**), as detailed in the Appendix 2A released today, in relation to the Placement announced on 24 August 2026.

The Company gives notice under section 708A(5)(e) of the *Corporations Act 2001* (Cth) (**Corporations Act**) (as modified by ASIC Instrument 2025/180), that:

1. the Company issued the CDIs without disclosure to investors under Part 6D.2 of the Corporations Act;

For completeness, the Company has an active drill program running at its Glenburgh Gold Project from which it continues to receive assay results in the ordinary course¹. The Company will release details of the results in accordance with its usual procedures and disclosure obligations.
