

NOTICE UNDER SECTION 708A(5)(e) OF THE CORPORATIONS ACT 2001 (CTH)

Vysarn Limited ACN 124 212 175 (ASX:VYS) (**Vysarn** or the **Company**) advises that it has issued 12,142,857 fully paid ordinary shares (**New Shares**) as part of the upfront consideration for the acquisition of 100% of the shares in Technologies International Group Pty Ltd ACN 071 424 783 (**WellTech**). Refer to the Company's previous announcements dated 28 July 2026 for further details in respect of the acquisition of WellTech.

The Company provides notification under section 708A(5)(e) of the *Corporations Act 2001* (Cth) (**Corporations Act**) of the issue of the New Shares. The Corporations Act restricts the on-sale of securities issued without disclosure unless the sale is exempt under section 708 or section 708A of the Corporations Act. By the Company giving this notice (**Notice**), a sale of the New Shares will fall within the exemption in section 708A(5) of the Corporations Act and they will immediately be freely tradeable.

For the purposes of section 708A(6) of the Corporations Act, the Company gives notice that:

- a) the New Shares were issued without disclosure under Part 6D.2 of the Corporations Act;
- b) this Notice is being given under section 708(5)(e) of the Corporations Act;
- c) as at the date of this Notice, the Company has complied with:
 - a. the provisions of Chapter 2M of the Corporations Act as they apply to the Company; and
 - b. sections 674 and 674A of the Corporations Act; and
- d) as at the date of this Notice, there is no information which is excluded information (as defined in sections 708A(7) and 708A(8) of the Corporations Act).
