Principal activities

The principal activity of the Group during the year was mineral exploration with a focus of exploration in Alaska.

There were no significant changes in the nature of the Group's principal activities during the year ended 30 June 2026, other than as detailed in the Exploration Report below, whereby the Group executed a binding Heads of Agreement for an option to acquire a 100% interest in the Boulder Creek Gold-Silver Project in Idaho, USA and completed the staking of additional twenty (20) BLM claims adjacent and adjoining to the Boulder Creek Gold-Silver Project.

Dividends

There were no dividends paid, recommended or declared during the current or previous financial year.

Review of operations

The net loss of the Group after providing for income tax amounted to \$459,211 (30 June 2025: \$313,994), which includes a write-off of \$105,824, being the carrying value of the Chulitna Project, and expenditure of \$78,657 in respect of the Boulder Creek Gold-Silver Project, being the option fee and issue of shares in the Company pursuant to a binding Heads of Agreement.

Corporate

In February 2026, the Company successfully completed a private placement of 22,125,000 shares at \$0.016 per share, raising \$354,000 (before costs), together with 4,425,000 free attaching options exercisable at \$0.05 each on or before 9 February 2029.

In August 2026, the Company announced that it has secured firm commitments from sophisticated and professional investors to raise \$900,000 (before costs) through the issue of 100 million fully paid ordinary shares ("Placement") at an issue price of \$0.009 per share.

The Placement will be conducted in two tranches, and shares issued will rank equally with existing fully paid ordinary shares.

- ▶ Tranche 1 shares to be issued pursuant to the Company's existing placement capacity under ASX Listing Rule 7.1 (6,585,000 shares); and
- ▶ Tranche 2 shares of ~93,415,000 shares will be issued subject to shareholder approval pursuant at the Company's Annual General Meeting ("AGM"), to be held sometime in October 2026.

Settlement and allotment of shares in respect of Tranche 1 occurred on 31 August 2026. Tranche 2 settlement and allotment will be following shareholder approval at the AGM.

Exploration

The following is a review of the operations of the Group during the financial year to the date of this report.

Boulder Creek Gold-Silver Project (Idaho, USA) (100% interest in 20 BLM claims and an option to acquire 100% interest)

During the year, the Company executed a binding Heads of Agreement ("HoA") for an option to acquire a 100% interest in Idaho State Lease E600117 ("ISL"), comprising ~640 acres located ~90km southwest of Boise in Idaho, USA.

The Company received laboratory analysis results of five rock samples collected from the project area where historical drilling conducted by Nerco. Inc. between 1985 - 1987 identified anomalous zones during their exploration works. The samples returned high-grade silver and gold assay results, including 767g/t (~24.6oz/t) Ag (sample 1809629), as shown in Table 1.

The high-grade results, and with the recent site visit proving positive, demonstrate the prospectivity for gold and silver mineralisation at the targeted Nerco. Inc. site within the project area.

The Company is progressing the exploration planning works targeting the anomalous prospect site for an initial drilling campaign. The Company's Idaho-based geological consultants are currently preparing the necessary works, including obtaining necessary approvals, sourcing a suitable drill rig and arranging access road works, to conduct the drilling program during the USA summer period.

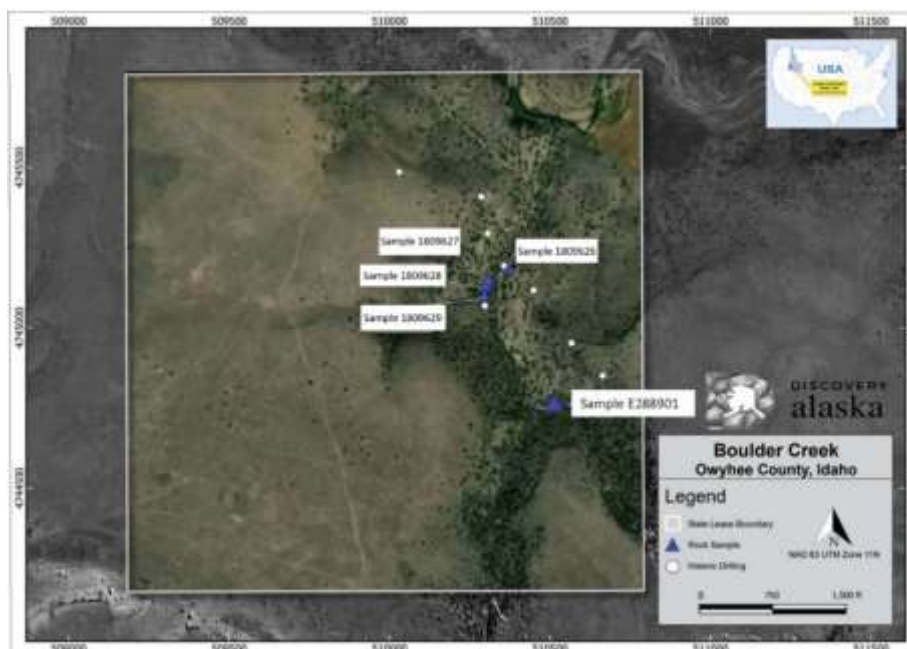


Figure 1. Boulder Creek Au-Ag Project – Sample Location Map

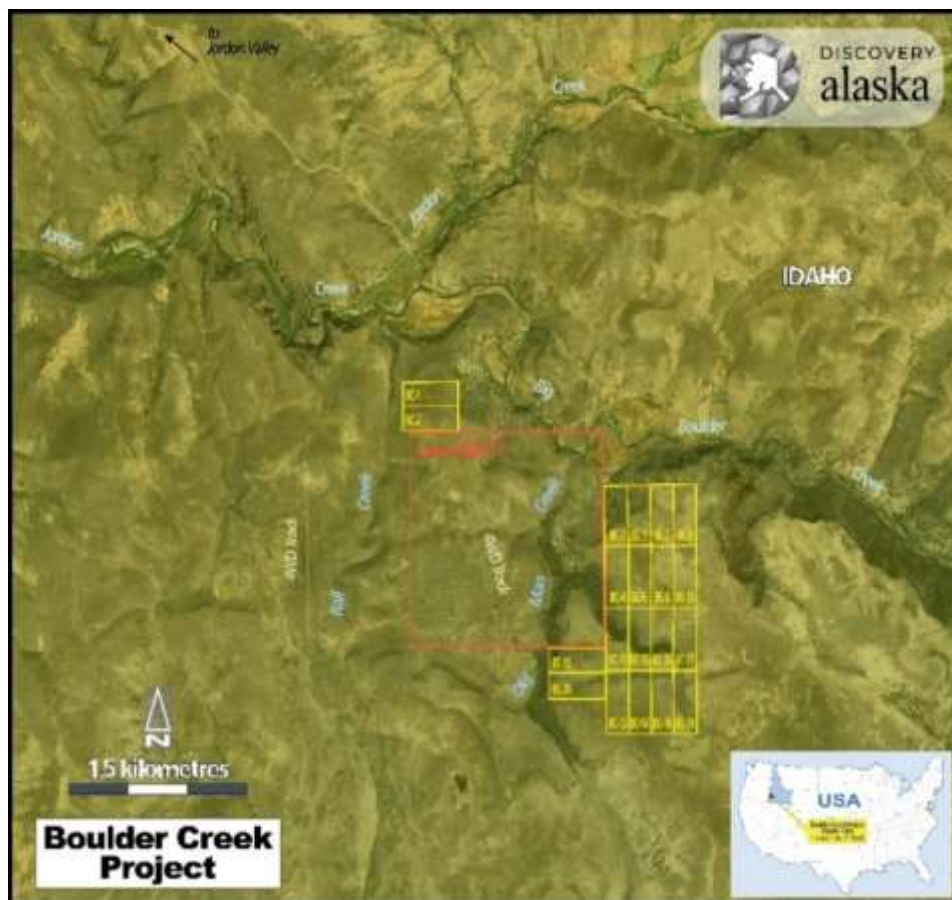


Figure 2. Boulder Creek Gold-Silver Project – BLM Claims (yellow) and ISL (red)

In April 2026, the Company successfully completed the staking of twenty (20) additional BLM claims covering an area of ~413 acres located northwest, east and southeast of the existing ISL to cover the potential strike extensions of the prospective geological structures that may extend beyond the ISL project area (refer Figure 2 below).

The project is prospective for epithermal high grade vein hosted gold-silver and disseminated gold-silver, and lies within a prospective area containing several historical sites.

The Boulder Creek Project provides direct leverage to gold and silver in a high-price environment, and is located near the historical mining town of Silver City.

Cuddingwarra Gold Project (to acquire 100% interest)

On 24 August 2026, the Company announced that it had entered into a binding Share Purchase Agreement ("SPA") to acquire the strategic Cuddingwarra Gold Project, located near Cue, Western Australia.

The Cuddingwarra Gold Project comprises eight (8) Prospecting License applications (being P20/2587, P20/2588, P20/2589, P20/2590, P20/2591, P20/2592, P20/2593 and P20/2594) covering an area of 13.86km² in a significant land position neighboring the historical Cuddingwarra Gold Mine and other major gold producers and projects, including Westgold Resources and Caprice Resources, and is proximal to regional processing infrastructure.

Refer below to the matters subsequent to the end of the financial year for further details regarding the proposed transaction.

Chulitna Gold Project (Alaska, USA) (100% interest)

The Chulitna Project is located on State of Alaska public lands, and is not subject to any Native Title claims, native lands, or native claimant groups. The project lies approximately 250km north of Anchorage and close to the major Parks Highway, which runs mostly parallel to the State-owned Alaska railroad. The project area comprises 15.5km² (24 claims) centred on the Partin Creek gold prospect. The Company is progressing its reviewing of its strategy for the project.

Given that there were no exploration activities undertaken in respect of the project during the year and the uncertainty regarding the ultimate recoupment of capitalised costs, the Company resolved to write-off capitalised exploration expenditure of \$105,824 during the year ended 30 June 2026.

New Project Opportunities

The Company is reviewing additional mineral project opportunities and has conducted due diligence over projects that may complement the Company's current exploration activities.

Material business risks

The business and operations of the Group are subject to numerous risks, many of which are beyond the Group's control. The Group makes every effort to identify materials risks and to manage these effectively. This section does not attempt to provide an exhaustive list of risks faced by the Group or by investors in the Company, nor are they in order of significance. Actual events may be different to those described.

The Board aims to manage these risks by carefully planning its activities and implementing risk control measures. Some of the risks are, however, highly unpredictable and the extent to which the Board can effectively manage them is limited.

Future capital raisings

The Group has limited financial resources and limited operating revenues. To earn and/or maintain its interest in its mineral projects, the Group has contractually agreed or is required to make certain payments and expenditures for and on such projects. Any additional equity financing may be dilutive to shareholders, may be undertaken at lower prices than the current market price and debt financing, if available, may involve restrictive covenants which limit the Group's operations and business strategy. Although the Directors believe that additional capital can be obtained, no assurances can be made that appropriate capital or funding, if and when needed, will be available on terms favourable to the Group or at all. If the Group is unable to obtain additional financing as and when required, it may be required to reduce, delay or suspend its operations and this could have a material adverse effect on the Group's activities and could therefore affect the Group's ability to continue as a going concern.

Exploration risks

Mineral exploration is subject to a high degree of risk, which even a combination of experience, knowledge and careful evaluation may fail to overcome. These risks may be even greater in the Group's case given the fact that its mineral projects are still in their exploration stage. There is no assurance that the Group's exploration will result in the discovery of an economically viable mineral deposit.

Furthermore, exploration activities are expensive and may be unsuccessful, resulting in the reduction in the value of those tenements, diminution in the cash reserves of the Group and possible relinquishment of the tenements. The exploration costs of the Group are based on certain assumptions with respect to the method and timing of exploration. By their nature, these estimates and assumptions are subject to significant uncertainties and, accordingly, the actual costs may materially differ from these estimates and assumptions. Accordingly, no assurance can be given that the cost estimates and the underlying assumptions will be realised in practice, which may materially and adversely affect the Group's viability. If the level of operating expenditure required is higher than expected, the financial position of the Group may be adversely affected.

Regulatory risk

The Group's exploration activities will require certain approvals, licences and permits from the applicable governmental authorities. There is no assurance that the Group will be successful in obtaining the necessary approvals, licences and permits on a timely basis or at all to undertake its exploration activities in the future or, if granted, that the approvals, licences and permits will be on the basis applied or remain in force as granted.

The Group's business and results of operations could be adversely affected if applications lodged for licences and permits are not granted. Mining and exploration tenements are subject to periodic renewal. The renewal of the term of a granted tenement is also subject to the discretion of the relevant Minister. Renewal conditions may include increased expenditure and work commitments or compulsory relinquishment of areas of the tenements comprising the Group's projects. The imposition of new conditions or the inability to meet those conditions may adversely affect the operations, financial position and/or performance of the Group.

Material business risks (continued)

Environmental risk

The operations and activities of the Group are subject to the environmental laws and regulations of the USA. As with most exploration projects and mining operations, the Group's operations and activities are expected to have an impact on the environment, particularly if advanced exploration or mine development proceeds. The Group attempts to conduct its operations and activities to the highest standard of environmental obligation, including compliance with all environmental laws and regulations. The Group is unable to predict the effect of additional environmental laws and regulations which may be adopted in the future, including whether any such laws or regulations would materially increase the Group's cost of doing business or affect its operations in any area. However, there can be no assurances that new environmental laws, regulations or stricter enforcement policies, once implemented, will not oblige the Group to incur significant expenses and undertake significant investments which could have material adverse effect on the Group's business, financial condition or performance.

Significant changes in state of affairs

Apart from the activities detailed above in the review of operations, there were no other significant changes in the state of affairs of the Consolidated Entity during the financial year.

Matters subsequent to the end of the financial year

On 24 August 2026, the Company announced that it had entered into a binding Share Purchase Agreement ("SPA") to acquire 100% interest in the Cuddingwarra Gold Project, comprising eight (8) Prospecting License applications covering an area of 13.86km² in a significant land position neighboring the historical Cuddingwarra Gold Mine and other major gold producers and projects.

The total transaction consideration reflects:

- \$240,000 worth of DAF Shares to be issued by DAF directly to the Boora shareholders as consideration for the sale of the Sale Shares; and
- \$480,000 worth of DAF Shares to be issued by DAF directly to Jack Johns, together with \$35,000 in cash to be paid by DAF directly to Jack Johns on the date of the SPA as a non-refundable consideration, with the DAF Shares issued at Completion, in each case in satisfaction of Boora's obligations to Jack Johns under the Option Agreement for the exercise of the Cuddingwarra Option.
- This represents an aggregate transaction value of \$720,000 worth of DAF Shares and \$35,000 in cash.

The binding SPA is subject to standard conditions, including obtaining shareholder approval, grant of all the prospecting licences and completing a capital raising.

In conjunction with the announcement of the acquisition of the Cuddingwarra Gold Project, the Company announced that it has secured firm commitments from sophisticated and professional investors to raise \$900,000 (before costs) through the issue of 100 million fully paid ordinary shares ("Placement") at an issue price of \$0.009 per share.

Remuneration report (audited)

The remuneration report, which has been audited, outlines the director and executive remuneration arrangements for the Consolidated Entity and the Company, in accordance with the requirements of the *Corporations Act 2001* and its Regulations.

A Principles used to determine the nature and amount of remuneration

The objective of the Consolidated Entity's executive reward framework is to ensure reward for performance is competitive and appropriate for the results delivered. The framework aligns executive reward with the achievement of strategic objectives and the creation of value for shareholders, and conforms with the market best practice for delivery of reward. The Board of Directors ('the Board') ensures that executive reward satisfies the following key criteria for good reward governance practices:

- competitiveness and reasonableness
- acceptability to shareholders
- performance linkage / alignment of executive compensation
- transparency

A Principles used to determine the nature and amount of remuneration (continued)

The Board is responsible for determining and reviewing remuneration arrangements for its directors and executives. The performance of the Consolidated Entity depends on the quality of its directors and executives. The remuneration philosophy is to attract, motivate and retain high performance and high quality personnel.

Alignment to shareholders' interests:

- has economic profit as a core component of plan design
- focuses on sustained growth in shareholder wealth and growth in share price, and delivering constant or increasing return on assets as well as focusing the executive on key non-financial drivers of value
- attracts and retains high calibre executives

In accordance with best practice corporate governance, the structure of non-executive directors and executive remunerations are separate.

Non-executive directors' remuneration

Fees and payments to non-executive directors reflect the demands which are made on, and the responsibilities of, the directors. Non-executive directors' fees and payments are reviewed annually by the Board.

ASX listing rules requires that the aggregate non-executive directors remuneration shall be determined periodically by a general meeting. The most recent determination was at the General Meeting, held in August 2011, where the shareholders approved an aggregate remuneration of \$350,000.

Executive remuneration

The Consolidated Entity aims to reward executives with a level and mix of remuneration based on their position and responsibility, which is both fixed and variable.

The executive remuneration and reward framework has three components:

- base pay and non-monetary benefits
- share-based payments
- other remuneration such as superannuation and long service leave

The combination of these comprises the executive's total remuneration.

Fixed remuneration, consisting of base salary, superannuation and non-monetary benefits, are reviewed annually by the Nomination and Remuneration Committee, based on individual and business unit performance, the overall performance of the Consolidated Entity and comparable market remunerations.

Executives can receive their fixed remuneration in the form of cash or other fringe benefits (for example motor vehicle benefits) where it does not create any additional costs to the Consolidated Entity and adds additional value to the executive.

The long-term incentives ('LTI') includes long service leave and share-based payments. The Nomination and Remuneration Committee intends to revisit the long-term equity-linked performance incentives specifically for executives at the end of each financial year.

There are currently no executive directors appointed by the Consolidated Entity.

Consolidated Entity performance and link to remuneration

Remuneration packages do not include performance-based components. An individual member of staff's performance assessment is done by reference to their contribution to the Consolidated Entity's overall operational achievements. All Directors and Executives hold shares and options in the Company to facilitate goal congruence between Executives with that of the business and shareholders. Further information has not been disclosed as it is commercially confidential.

Voting of Remuneration Report at 2025 Annual General Meeting

The 2025 Remuneration Report was voted for, without any commentary or discussion, at the 2025 Annual General Meeting (AGM), based on poll votes with votes for of 20,329,049 (64.92%), and 10,986,134 votes against (35.08%).

Note: As more than 25% of the votes were cast against the resolution relating to the Remuneration Report, it constitutes the first strike for the purposes of the *Corporations Act 2001 (Cth)*.

NOTE 1. GENERAL INFORMATION

This financial report of Discovery Alaska Limited ('the Company') for the year ended 30 June 2026 comprises the Company and its subsidiaries (collectively referred to as 'the Consolidated Entity' or 'Group').

Discovery Alaska Limited is a for profit company limited by shares incorporated in Australia whose shares are publicly traded on the Australian Securities Exchange. The financial report was authorised for issue in accordance with a resolution of Directors dated 4 September 2026.

1a Basis of preparation

These general purpose financial statements have been prepared in accordance with Australian Accounting Standards, other authoritative pronouncements of the Australian Accounting Standards Board, Australian Accounting Interpretations and the *Corporations Act 2001*. Discovery Alaska Limited is a for-profit entity for the purposes of preparing the financial statements.

Compliance with IFRSs

The financial statements of Discovery Alaska Limited also comply with International Financial Reporting Standards (IFRSs) as issued by the International Accounting Standards Board (IASB).

Going concern

The financial report has been prepared on a going concern basis, which contemplates the continuity of normal business activity and the realisation of assets and the settlement of liabilities in the ordinary course of business.

For the year ended 30 June 2026, the Group recorded a loss of \$459,211 (2025: \$313,994) and had net cash outflows from operating and investing activities of \$299,343 (2025: \$210,212). At 30 June 2026, the Group had a working capital surplus of \$189,324 (2025: \$215,376).

In context of this operating environment, the ability of the Group to continue as a going concern is dependent on securing additional funding through debt or equity to continue to fund its operational and exploration activities.

These conditions indicate a material uncertainty that may cast a significant doubt about the Group's ability to continue as a going concern and, therefore, that it may be unable to realise its assets and discharge its liabilities in the normal course of business.

The financial statements have been prepared on the basis that the Group is a going concern, which contemplates the continuity of normal business activity, realisation of assets and settlement of liabilities in the normal course of business for the following reasons:

- As disclosed in Note 21, subsequent to balance date, the Company announced that it has secured firm commitments from sophisticated and professional investors to raise \$900,000 (before costs);
- The Company believe they can raise additional funding through debt or equity;
- The Directors have provided signed letters of support confirming that they will not call upon director fees owed by the Company until such time that the Company has the ability to pay the amounts; and
- Cash spending can be reduced or slowed below its current rate if required.

Should the Group not be able to continue as a going concern, it may be required to realise its assets and discharge its liabilities other than in the ordinary course of business, and at amounts that differ from those stated in the financial statements. The financial report does not include any adjustments relating to the recoverability and classification of recorded asset amounts or liabilities that might be necessary should the Group not continue as a going concern.

Principles of consolidation

The consolidated financial statements incorporate the assets and liabilities of the Company as at 30 June 2026 and the results of its subsidiaries for the year then ended. The Company and its subsidiaries are referred to in this financial report as 'the Consolidated Entity' or 'Group'.

Subsidiaries are all those entities over which the Consolidated Entity has the power to govern the financial and operating policies, generally accompanying a shareholding of more than one-half of the voting rights. The effects of potential exercisable voting rights are considered when assessing whether control exists. Subsidiaries are fully consolidated from the date on which control is transferred to the Consolidated Entity. They are de-consolidated from the date that control ceases.

NOTE 1. GENERAL INFORMATION (continued)

Principles of consolidation (continued)

Intercompany transactions, balances and unrealised gains on transactions between entities in the Consolidated Entity are eliminated on consolidation. Unrealised losses are also eliminated unless the transaction provides evidence of the impairment of the asset transferred. Accounting policies of subsidiaries have been changed where necessary to ensure consistency with the policies adopted by the Consolidated Entity.

The acquisition of subsidiaries is accounted for using the acquisition method of accounting. A change in ownership interest, without the loss of control, is accounted for as an equity transaction, where the difference between the consideration transferred and the book value of the share of the non-controlling interest acquired is recognised directly in equity attributable to the parent.

Where the Consolidated Entity loses control over a subsidiary, it derecognises the assets including goodwill, liabilities and non-controlling interest in the subsidiary together with any cumulative translation differences recognised in equity. The Consolidated Entity recognises the fair value of the consideration received and the fair value of any investment retained together with any gain or loss in profit or loss.

Revenue recognition

Revenue is recognised when it is probable that the economic benefit will flow to the Consolidated Entity and the revenue can be reliably measured. Revenue is measured at the fair value of the consideration received or receivable.

Interest

Interest revenue is recognised as interest accrues using the effective interest method. This is a method of calculating the amortised cost of a financial asset and allocating the interest income over the relevant period using the effective interest rate, which is the rate that exactly discounts estimated future cash receipts through the expected life of the financial asset to the net carrying amount of the financial asset.

Income tax

The income tax expense or benefit for the period is the tax payable on that period's taxable income based on the applicable income tax rate for each jurisdiction, adjusted by changes in deferred tax assets and liabilities attributable to temporary differences, unused tax losses and the adjustment recognised for prior periods, where applicable.

Deferred tax assets and liabilities are recognised for temporary differences at the tax rates expected to apply when the assets are recovered or liabilities are settled, based on those tax rates that are enacted or substantively enacted, except for:

- When the deferred income tax asset or liability arises from the initial recognition of goodwill or an asset or liability in a transaction that is not a business combination and that, at the time of the transaction, affects neither the accounting nor taxable profits; or
- When the taxable temporary difference is associated with investments in subsidiaries, associates or interests in joint ventures, and the timing of the reversal can be controlled and it is probable that the temporary difference will not reverse in the foreseeable future.

Deferred tax assets are recognised for deductible temporary differences and unused tax losses only if it is probable that future taxable amounts will be available to utilise those temporary differences and losses.

The carrying amount of recognised and unrecognised deferred tax assets are reviewed each reporting date. Deferred tax assets recognised are reduced to the extent that it is no longer probable that future taxable profits will be available for the carrying amount to be recovered. Previously unrecognised deferred tax assets are recognised to the extent that it is probable that there are future taxable profits available to recover the asset.

Deferred tax assets and liabilities are offset only where there is a legally enforceable right to offset current tax assets against current tax liabilities and deferred tax assets against deferred tax liabilities; and they relate to the same taxable authority on either the same taxable entity or different taxable entity's which intend to settle simultaneously.

NOTE 1. GENERAL INFORMATION (continued)

Financial assets

Initial Recognition

Financial assets are recognised when the Consolidated Entity becomes a party to the contractual provisions to the instrument. For financial assets, this is the date that the Consolidated Entity commits itself to either the purchase or sale of the asset (i.e. trade date accounting is adopted). Financial instruments (except for trade receivables) are initially measured at fair value plus transaction costs, except where the instrument is classified “at fair value through profit or loss”, in which case transaction costs are expensed to profit or loss immediately. Where available, quoted prices in an active market are used to determine fair value. In other circumstances, valuation techniques are adopted.

Classification and Subsequent Measurement

Financial assets can be subsequently measured at:

- amortised cost;
- fair value through other comprehensive income (debt instruments)
- fair value through other comprehensive income (equity instruments only – no recycling); or
- fair value through profit or loss,

based on the two primary criteria, being:

- the contractual cash flow characteristics of the financial asset; and
- the business model for managing the financial assets.

A financial asset is subsequently measured at amortised cost when it meets the following conditions:

- the financial asset is managed solely to collect contractual cash flows; and
- it gives rise to cash flows that are solely payments of principal and interest on the principal amount outstanding on specified dates.

The Consolidated Entity has financial assets at amortised cost being cash and cash equivalents and trade and other receivables. Furthermore, the Consolidated Entity has listed investments in the form of ordinary shares. As permitted under AASB 9, the Consolidated Entity has irrevocably elected to recognise all fair value movements after initial recognition in other comprehensive income through the financial assets reserve in equity.

Impairment of financial assets

The Consolidated Entity assesses at the end of each reporting period whether there is any objective evidence that a financial asset or group of financial assets is impaired. Objective evidence includes significant financial difficulty of the issuer or obligor; a breach of contract such as default or delinquency in payments; the lender granting to a borrower concessions due to economic or legal reasons that the lender would not otherwise do; it becomes probable that the borrower will enter bankruptcy or other financial reorganisation; the disappearance of an active market for the financial asset; or observable data indicating that there is a measurable decrease in estimated future cash flows.

The amount of the impairment allowance for loans and receivables carried at amortised cost is the difference between the asset's carrying amount and the present value of estimated future cash flows, discounted at the original effective interest rate. If there is a reversal of impairment, the reversal cannot exceed the amortised cost that would have been recognised had the impairment not been made and is reversed to profit or loss.

Financial assets are considered impaired when there has been a significant or prolonged decline in value below initial cost. Subsequent increments in value are recognised in other comprehensive income through the financial assets reserve.

NOTE 1. GENERAL INFORMATION (continued)

Exploration and evaluation assets

Exploration and evaluation expenditure in relation to separate areas of interest for which rights of tenure are current is carried forward as an asset in the statement of financial position where it is expected that the expenditure will be recovered through the successful development and exploitation of an area of interest, or by its sale; or exploration activities are continuing in an area and activities have not reached a stage which permits a reasonable estimate of the existence or otherwise of economically recoverable reserves. Where a project or an area of interest has been abandoned, the expenditure incurred thereon is written off in the year in which the decision is made.

At each reporting date the directors review each area of interest to determine the appropriateness of continuing to capitalise costs in relation to that area of interest. Where it is determined that the costs incurred on an area of interest will not be recovered through sale or future development and exploitation of the resource the directors will write off costs to the profit or loss.

Trade and other payables

These amounts represent liabilities for goods and services provided to the Consolidated Entity prior to the end of the financial year and which are unpaid. Due to their short-term nature they are measured at amortised cost and are not discounted. The amounts are unsecured and are usually paid within 30 days of recognition.

Share-based payments

Equity-settled share-based compensation benefits are provided to Directors and external consultants.

Equity-settled transactions are awards of shares, or options over shares that are provided to Directors or external consultants in exchange for the rendering of services. Cash-settled transactions are awards of cash for the exchange of services, where the amount of cash is determined by reference to the share price.

Employee benefits

The cost of equity-settled transactions are measured at fair value on grant date. Fair value is independently determined using either the Binomial or Black-Scholes option pricing model that takes into account the exercise price, the term of the option, the impact of dilution, the share price at grant date and expected price volatility of the underlying share, the expected dividend yield and the risk free interest rate for the term of the option, together with non-vesting conditions that do not determine whether the Consolidated Entity receives the services that entitle the executives to receive payment. No account is taken of any other vesting conditions.

The cost of equity-settled transactions are recognised as an expense with a corresponding increase in equity over the vesting period. The cumulative charge to profit or loss is calculated based on the grant date fair value of the award, the best estimate of the number of awards that are likely to vest and the expired portion of the vesting period. The amount recognised in profit or loss for the period is the cumulative amount calculated at each reporting date less amounts already recognised in previous periods.

If equity-settled awards are modified, as a minimum an expense is recognised as if the modification has not been made. An additional expense is recognised, over the remaining vesting period, for any modification that increases the total fair value of the share-based compensation benefit as at the date of modification.

If the non-vesting condition is within the control of the Consolidated Entity or executive, the failure to satisfy the condition is treated as a cancellation. If the condition is not within the control of the Consolidated Entity or executive and is not satisfied during the vesting period, any remaining expense for the award is recognised over the remaining vesting period, unless the award is forfeited.

If equity-settled awards are cancelled, it is treated as if it has vested on the date of cancellation, and any remaining expense is recognised immediately. If a new replacement award is substituted for the cancelled award, the cancelled and new award is treated as if they were a modification.

NOTE 1. GENERAL INFORMATION (continued)

Issued capital

Ordinary shares are classified as equity.

Incremental costs directly attributable to the issue of new shares or options are shown in equity as a deduction, net of tax, from the proceeds.

Earnings per share

Basic earnings per share

Basic earnings per share is calculated by dividing the profit attributable to the owners of Discovery Alaska Limited, excluding any costs of servicing equity other than ordinary shares, by the weighted average number of ordinary shares outstanding during the financial year, adjusted for bonus elements in ordinary shares issued during the financial year.

Diluted earnings per share

Diluted earnings per share adjusts the figures used in the determination of basic earnings per share to take into account the after income tax effect of interest and other financing costs associated with dilutive potential ordinary shares and the weighted average number of shares assumed to have been issued for no consideration in relation to dilutive potential ordinary shares.

Operating segments

Operating segments are presented using the 'management approach', where the information presented is on the same basis as the internal reports provided to the Chief Operating Decision Makers ('CODM'). The CODM is responsible for the allocation of resources to operating segments and assessing their performance.

Foreign currency translation

The financial report is presented in Australian dollars, which is Discovery Alaska Limited's functional and presentation currency.

Foreign currency transactions

Foreign currency transactions are translated into Australian dollars using the exchange rates prevailing at the dates of the transactions. Foreign exchange gains and losses resulting from the settlement of such transactions and from the translation at financial year-end exchange rates of monetary assets and liabilities denominated in foreign currencies are recognised in profit or loss.

Foreign operations

The assets and liabilities of foreign operations are translated into Australian dollars using the exchange rates at the reporting date. The revenues and expenses of foreign operations are translated into Australian dollars using the average exchange rates, which approximate the rate at the date of the transaction, for the period. All resulting foreign exchange differences are recognised in other comprehensive income through the foreign currency reserve in equity.

The foreign currency reserve is recognised in profit or loss when the foreign operation or net investment is disposed of.

CRITICAL ACCOUNTING JUDGEMENTS, ESTIMATES AND ASSUMPTIONS

The preparation of the financial statements requires management to make judgements, estimates and assumptions that affect the reported amounts in the financial statements. Management continually evaluates its judgements and estimates in relation to assets, liabilities, contingent liabilities, revenue and expenses. Management bases its judgements, estimates and assumptions on historical experience and on other various factors, including expectations of future events, management believes to be reasonable under the circumstances. The resulting accounting judgements and estimates will seldom equal the related actual results. The judgements, estimates and assumptions that have a significant risk of causing a material adjustment to the carrying amounts of assets and liabilities (refer to the respective notes) within the next financial year are discussed below.

NOTE 1. GENERAL INFORMATION (continued)

CRITICAL ACCOUNTING JUDGEMENTS, ESTIMATES AND ASSUMPTIONS (continued)

Share-based payment transactions

The Consolidated Entity measures the cost of equity-settled transactions with executives by reference to the fair value of the equity instruments at the date at which they are granted. The fair value is determined by using either the Binomial or Black-Scholes model taking into account the terms and conditions upon which the instruments were granted. The accounting estimates and assumptions relating to equity-settled share-based payments would have no impact on the carrying amounts of assets and liabilities within the next annual reporting period but may impact profit or loss and equity.

Recovery of deferred tax assets

Deferred tax assets are recognised for deductible temporary differences only if the Consolidated Entity considers it is probable that future taxable amounts will be available to utilise those temporary differences and losses.

Exploration and evaluation costs

The Consolidated Entity has capitalised exploration and evaluation costs, net of impairments recognised, in accordance with AASB 6 Exploration for and evaluation of mineral resources. The Consolidated Entity assesses impairment at each reporting date by evaluating conditions specific to the Consolidated Entity and its areas of interest that may lead to impairment of assets. When an impairment trigger exists, the recoverable amount of the assets is determined.

New accounting standards and interpretations

Standards and Interpretations applicable to 30 June 2026

For the year ended 30 June 2026, the Directors have reviewed all of the new and revised Standards and Interpretations issued by the AASB that are relevant to the Consolidated Entity and effective for the current reporting periods beginning on or after 1 July 2025.

Finance identifies, evaluates and hedges financial risks within the Consolidated Entity's operating units. Finance reports to the Board on a monthly basis.

The Consolidated Entity's cash and cash equivalents are held in current accounts and short-term deposits, and are therefore subject to interest rate risk.

An increase/decrease in interest rates on cash at bank of 100 basis points (1.00%) would have a favourable/adverse effect on profit before tax of \$2,178 per annum (2025: \$3,783). The percentage change is based on the expected volatility of interest rates using market data and analysts forecasts.

Credit risk

Credit risk refers to the risk that a counterparty will default on its contractual obligations resulting in financial loss to the Consolidated Entity. The Consolidated Entity has a strict code of credit, including obtaining agency credit information, confirming references and setting appropriate credit limits. The Consolidated Entity obtains guarantees where appropriate to mitigate credit risk. The maximum exposure to credit risk at the reporting date to recognised financial assets is the carrying amount, net of any provisions for impairment of those assets, as disclosed in the statement of financial position and notes to the financial statements. The Consolidated Entity does not hold any collateral.

Liquidity risk

Vigilant liquidity risk management requires the Consolidated Entity to maintain sufficient liquid assets (mainly cash and cash equivalents) and available borrowing facilities to be able to pay debts as and when they become due and payable.

The Consolidated Entity manages liquidity risk by maintaining adequate cash reserves by continuously monitoring actual and forecast cash flows and matching the maturity profiles of financial assets and liabilities.

Boulder Creek Gold-Silver Project

In December 2025, the Company executed a binding Heads of Agreement (“HoA”) for an option to acquire a 100% interest in the Boulder Creek Gold-Silver Project, comprising a ~640 acres Idaho State Lease (“ISL”) located ~90km southwest of Boise in Idaho, USA.

Under the terms of the binding HoA, subject to the satisfaction of all conditions precedent and completing any outstanding due diligence requirements, the Company has an option to acquire a 100% legal and beneficial interest in the Boulder Creek Gold-Silver Project from C bar B Properties Corporation.

The Company paid a non-refundable option fee of US\$30,000 cash and issued 2,000,000 fully paid ordinary shares of the Company following completion of due diligence.

During the option period, the Company agrees to pay/issue to C bar B Properties Corporation the following:

- US\$100,000 cash and 3,000,000 DAF shares on the one-year anniversary of the HoA;
- US\$200,000 cash and 1,000,000 DAF shares on the two-year anniversary of the HoA; and
- US\$300,000 cash on the three-year anniversary of the HoA.

A fee of US\$1,500,000 and a 1% Net Smelter Royalty will be payable to exercise the option to acquire the 100% interest in the Boulder Creek Project tenement at any time within four years of executing the HoA.

On 24 August 2026, the Company announced that it had entered into a binding Share Purchase Agreement (“SPA”) to acquire 100% interest in the Cuddingwarra Gold Project, comprising eight (8) Prospecting License applications covering an area of 13.86km² in a significant land position neighboring the historical Cuddingwarra Gold Mine and other major gold producers and projects.

The total transaction consideration reflects:

- \$240,000 worth of DAF Shares to be issued by DAF directly to the Boora shareholders as consideration for the sale of the Sale Shares; and
- \$480,000 worth of DAF Shares to be issued by DAF directly to Jack Johns, together with \$35,000 in cash to be paid by DAF directly to Jack Johns on the date of the SPA as a non-refundable consideration, with the DAF Shares issued at Completion, in each case in satisfaction of Boora’s obligations to Jack Johns under the Option Agreement for the exercise of the Cuddingwarra Option.
- This represents an aggregate transaction value of \$720,000 worth of DAF Shares and \$35,000 in cash.

The binding SPA is subject to standard conditions, including obtaining shareholder approval, grant of all the prospecting licences and completing a capital raising.

In conjunction with the announcement of the acquisition of the Cuddingwarra Gold Project, the Company announced that it has secured firm commitments from sophisticated and professional investors to raise \$900,000 (before costs) through the issue of 100 million fully paid ordinary shares (“Placement”) at an issue price of \$0.009 per share.

The Placement will be conducted in two tranches, and shares issued will rank equally with existing fully paid ordinary shares.

- Tranche 1 shares to be issued pursuant to the Company's existing placement capacity under ASX Listing Rule 7.1 (6,585,000 shares); and
- Tranche 2 shares of ~93,415,000 shares will be issued subject to shareholder approval pursuant at the Company’s Annual General Meeting (“AGM”), to be held sometime in October 2026.

Settlement and allotment of shares in respect of Tranche 1 occurred on 31 August 2026. Tranche 2 settlement and allotment will be following shareholder approval at the AGM.

Opinion

We have audited the financial report of Discovery Alaska Limited ("the Company") and its controlled entities ("the Consolidated Entity"), which comprises the consolidated statement of financial position as at 30 June 2026, the consolidated statement of profit or loss and other comprehensive income, the consolidated statement of changes in equity and the consolidated statement of cash flows for the year then ended, notes to the financial statements, including a summary of material accounting policies, and the directors' declaration.

In our opinion:

- a. the accompanying financial report of Discovery Alaska Limited is in accordance with the *Corporations Act 2001*, including:

Without modifying our opinion above, we draw attention to Note 1 Going Concern to the annual report, which indicates that the Consolidated Entity produced a net loss for the year of \$459,211 with net cash outflows from operating activities and investing activities of \$299,343. The net working asset position of the Consolidated Entity at 30 June 2026 was \$189,324.

These conditions, along with other matters as set forth in Note 1 Going Concern, indicate the existence of a material uncertainty that may cast significant doubt about the ability of the Consolidated Entity to continue as a going concern and whether it will realise its assets and extinguish its liabilities in the normal course of business and at the amounts stated in the financial report.

Basis for Opinion

We conducted our audit in accordance with Australian Auditing Standards. Our responsibilities under those standards are further described in the *Auditor's Responsibilities for the Audit of the Financial Report* section of our report. We are independent of the Company in accordance with the auditor independence requirements of the *Corporations Act 2001* and the ethical requirements of the Accounting Professional and Ethical Standards Board's *APES 110 Code of Ethics for Professional Accountants (including Independence Standards)* (the Code) that are relevant to our audit of the financial report in Australia.
